Post Documents on file at Department

National "Resolution 36: Mission Blue Post Assistance Program" enabled Posts to apply for a grant for up to \$1,000 for assistance during this pandemic time. One of the requirements to get this grant was that the Posts have all necessary documentation required by the Department on file at Department.

"RESOLVED, That an American Legion Post will be eligible for a Mission Blue Post Assistance Program grant after verification by the American Legion Department Adjutant that the Post meets the criteria and requirements, which are listed here:

- 1. A Post must have a consolidated post report on file.
- 2. A Post must have filed an IRS 990 within the prescribed due date.
- 3. A Post must have filed all other required forms and reports as prescribed by the Department.
- 4. A Post must have actively participated in one or more American Legion program(s) within the last 18 months.
- A Post must have a financial need.
- 6. A Post must provide a certificate of insurance naming The American Legion dba American Legion National Headquarters as an additional insured.
- 7. A Post must provide documentation indicating that the Post is properly incorporated, and be it further..."

These conditions to receive assistance from National show the need for Posts to have required documentation on file.

Yearly, the Department's Internal Affairs Committee has checked the records on file at Department and provided a list of the Posts who either have a) not submitted records, or b) do not have all the required documents on file.

As time has gone by, some Posts have gotten pretty slack about sending required documents into Department. All Posts need to ensure that the required documents are on file at Department. An example of National's requirement to have documentation at Department is shown in

The American Legion Resolution 35,
which states:

"The American Legion's national adjutant, or designee, has been given authority to independently investigate, confirm and determine that the organizations using the Tradenames are also naming The American Legion, and respected Department of The American Legion as needed, as additional insured on their respective liability insurance policies."

The documentation requirements will continue to be a priority, so every Post should ensure their documents are on file. This will prevent Posts from finding themselves in a position where they cannot get some assistance because they have not filed documents



The American Legion Legacy Scholarship is a needs-based scholarship designed to fulfill a financial gap remaining after all federal and state educational grants/scholarships available to an eligible applicant have first been applied. Priority consideration is given to children of U.S. servicemembers who died while serving on active duty on or after Sept. 11, 2001. Children of post-9/11 veterans having been assigned a combined disability rating by the Department of Veterans Affairs of 50 percent or greater may also qualify.

Public Relations Committee

Need some pointers navigating media resources to promote your Post in 2021? The American Legion Public Relations Toolkit offers the following thoughts. "The list of job titles in today's media varies from place to place and often changes to reflect the latest trends and technology. How do you know who is the right person is to contact when you have a story to tell about your Post? Talk to the receptionist who answers the phone.

Remember the old axiom from our military days: You get the best information from the people who answer the phones and do the work. It is still the same today, and it works with any company, anywhere. Just pick up the phone and call the newspaper, radio, television station, or cable system main number. Ask the person who answers to whom you should send a news release from your Post or who you should speak with to suggest a topic for a talk show or public service announcement. Get the correct contact person's name, phone, fax, and email information.

Armed with that information, you can begin the communication process. Every media operation is different. That is why you want to work with the people closest to doing the story, not necessarily upper management. Understanding where some of the division lies in a media operation can be helpful. Consider the following: Daily and Weekly Newspapers -The City Editor is probably as high in the working chain as you want to go. This is generally the individual who makes reporter assignments for local stories. He/she also is the person who edits the stories.

Contacting a Reporter is a great place to start. Besides being told what stories to write, reporters have a resp -

onsibility to suggest stories. If you can convince a reporter your story is important, you are ahead of the game. The individual who works separately from the news writing side of the business is the Editorial Page Editor. This individual helps develop editorial positions of the newspaper, etc.

When you want to place a guest editorial written by your Post Commander in a newspaper, this is where you will most likely be directed. An Op-Ed Editor selects the commentary and opinion pieces that appear on the page opposite the editorial page in most papers, thus the name "op-ed." Sometimes a column written by your commander or member of your Post can be used as an op-ed piece.

Letters to the Editor are generally handled by one individual in the editorial department. Most newspapers also have information on how to submit letters to the editor via mail, fax, and e-mail. Never overlook the potential of a short, to-the-point letter reinforcing the positive community perception of our organization. Weekly newspapers have just a few staff members to handle all the jobs, so do not be surprised if the person you need to speak with is also the person who answers the phone. In the weekly newspaper business, the editor is a Jack or Jill of all trades. Assignment Editor of a television station assigns a reporter/videographer to cover a story. The Report does the work. Once you have a relationship with the reporter, you can usually make future calls directly to that person with future stories. A Community Affairs Director coordinates all the station's activities in the community. If you were looking to establish a partnership with a News station for a special event, this is probably the person you will be told to contact. The individual who produces and often hosts station programs that tackle interest issues to

the public is the Public Affairs Director. If you have an event you want to promote, this is the person you will most likely work

with for your special event.

Radio Stations also

have staff who may assist you. Unless you live in a major city, the individual hired as the news director is generally the news director also doing the Public Service Director's job, hosting or producing a taped weekend radio talk program of community interest and more. The Promotion Director is the individual who coordinates appearances by on-air personalities at events and develops other related projects to increase listeners. The individual who schedules the time of all commercials is the Continuity Director. At smaller radio stations, this person may also schedule public service announcements. So remember, talking to the top person in charge is seldom where you want to start. Don't try to figure out whom to call; let the workers help you navigate the maze of job titles."






District 7 is in the middle of the State's pandemic explosion and continues to struggle with m e m b e r ship. There are currently



You're Dead – Now What? A Resolution for 2021

A morbid headline, to be sure but designed to get your attention and for you to take action if necessary.

In the four decades, I have worked as a veteran advocate, one of the saddest things I have dealt with concerns the sudden and unexpected death of a veteran and their family's impact.

At a time of deep sorrow and grief, it is often made worse by the fact that the deceased veteran took care of all the family matters and did not discuss them with those closest to them

As a result, the family did not know where the veteran's DD Form 214 was, did not know where to find their vehicle titles or the deed to their home. They did not know the status of the benefits paid to the veteran by the VA or about their Social Security payments. They also had no information about the veterans' retirement payments or any life insurance coverage. The list goes on and on.

And now for the most important New Year's Resolution, you will make for 2021.

As you can see, when the family is

dealing with funeral or memorial service plans, they are also trying to determine the veteran's wishes concerning their property and belongings.

The solution to these challenges is to sit down with your loved ones and set up a plan for your passing. Setting up a plan should involve visiting an attorney to draw up a Last Will and Testament along with a Power of Attorney. These documents should be kept in a place known to your beneficiary.

Someone should safeguard other essential documents such as the DD Form 214, vehicle titles, property deeds or payment records, life insurance certificates, VA and Social Security benefits status, and retirement payments. This is not an all-inclusive list, but your attorney can help you put these together when you draw up your will.

Charles "Shad-

ow Walks" Tailfeathers, a fixture at numerous Veterans Summits and Marcellus Norwest Memorial Veterans Powwows held in Grand Ronde, walked on on Saturday, Aug. 15, at St. Charles Medical Center in Bend.

Tailfeathers (Cree/Blackfeet) was a Vietnam War-era Naval Construction Battalion "Seabees" veteran who worked for the Native Wellness Institute in Gresham and served on its board of directors.

He was credited with being the "visionary" behind the Veterans Summit that started being held annually in July 2013 at uyxat Powwow Grounds in Grand Ronde.

"For more than 15 years, Charlie served the Native Wellness Institute, traveling to Tribal communities, shar-

ing his Elder wisdom and teachings, and helping others to find healing," says a statement posted

on the Wellness Institute's Facebook page. "He was an anchor and a rock to the staff and board; often helping each of us through life's challenges and celebrating our victories."

"Charlie was not only just a good guy, but an imposing figure within the Tribal community," said Grand Ronde Tribal Council member Steve Bobb Sr., who is a Vietnam War-era Marine Corps veteran. "He was committed to his people and to the care and wellbeing of veterans. He was looked up to by many and one of those Elder leaders that when he spoke, you listened. His presence at our powwows was always a joy and his passing will leave a hole for years to come."

Tailfeathers earned a bachelor's of applied science science from Lane Community College in Eugene in Traditional Values and Customs and worked for 20 years for the Confederated Tribes of Warm Springs, where he assisted in creating a family wellness court system. In addition, he served as vice president of the Warm Springs Veterans Memorial Park Committee

He also served as a Victim of Crime advocate, Elders advocate and Juvenile advocate. He provided training and technical assistance to Tribal court systems and offered Native wellness and healing training in Indian Country for more than 35 years.

"Charlie touched the lives of thousands of people," the Wellness Institute's Facebook statement says. "He always incorporated cultural values into everything he did as he knew our culture held all of the answers that we

needed."

Tailfeathers appeared in a You-Tube video called "Trail of Life" that was posted on May 21. It can be viewed at www.youtube.com/watch?v=jUBaFnS-SLE.

He was born on Feb. 1, 1945, and was buried on the Warm Springs Reservation, the homeland of his wife, Nancy, on Sunday, Aug. 16. He was an enrolled member of the Blackfeet Nation located in Browning, Mont. He is survived by children, grandchildren and great-grandchildren.

The Grand Ronde Tribal Council held a moment of silence in Tailfeathers' memory during its Tuesday, Aug. 18, Legislative Action Committee hearing.

"He loved Grand Ronde, the people, the way the Tribes care for their people and all of the gatherings," said Native Wellness Institute Executive Director Jillene Joseph.

The American Legion calls for Senate to pass, White House to sign NDAA

(WASHINGTON—December 9, 2020) – The head of the nation's largest veteran's organization called for the White House and Senate to reach an agreement on the proposed National Defense Authorization Act, which contains many provisions that The American Legion strongly supports. The House of Representatives passed the NDAA last night with a veto-proof majority.

"There are many items in the proposed legislation which would improve the quality of life not just for our military members, but for our Vietnam veterans as well," James W. "Bill" Oxford, national commander of The American Legion said. "Moreover, we hope that President Trump agrees that an issue as important as liability for social media companies is important enough to debate on its own merits and should not be part of the NDAA."

Oxford singled out the Fair Care for Vietnam Veterans Act as "a life-changing provision that is included in the NDAA which will benefit more


than 34,000 Vietnam veterans and their families." The amendment, secured by Sen. Jon Tester, D-Mont., would add bladder cancer, hypothyroidism and Parkinsonism to the list of service-connected presumptions associated with Agent Orange exposure.

"Additionally, the defense bill increases troop strength and includes a 3 percent pay raise which our military members certainly deserve," Oxford added. "The American Legion has always advocated for a strong national defense and quality care for our country's veterans. We believe that the NDAA goes a long way toward strengthening America."

From myself to the rest of the veterans out there, I commend and thank you for all that you have done and sacrificed for our country.


Try to remember the good times and make peace with the bad times.

He said no, they have it covered, and I should go ahead and board the plane. So after arriving at the airport in Norfolk, I took a cab home to Virginia Beach. Arriving at my apartment complex, I knock on my door to surprise my wife. Not realizing the incident had made national news, she opens the door with tears and shock that I stood in the doorway. It was all over the television news, and she thought it might be the CACO Officer bringing the worst news a wife could hear because they were not giving names of the men. After all, the next of kins' haven't been notified. Needless to say, I will never do that again. Below is the article by JOC Roger Busby. At the base Chapel at Little Creek is another Plaque to memorialize our fallen shipmates. Rest in Peace.

Barcelona (17 January 1977)

Catastrophe Strikes

Catastrophe struck in the early morning hours of 17 January 1977 when the LCM-6, leaving fleet landing at 2 AM on a final run back to the ships with 124 enlisted sailors and marines

dressed for the cold winter weather, collided with the 390-ton Spanish freighter "Urlea" in the inner harbor. The collision occurred about 80-feet off of the end of a high commercial pier where the vision of the coxswain was obstructed by the height of the pier as the two craft rounded the pier from opposite sides. Neither craft had time to react before the bulbous bow of the freighter lifted the bow of the LCM-6 and capsized the boat tossing the occupants into the dark harbor water. Personnel on the pier and at Fleet Landing scrambled to assist those in the boat but many who had been in the liberty boat were disoriented or trapped under the high sides of the LCM-6.

GUAM, notified by the Beach guard of the accident, mustered the Rescue and Assistance Detail and sent them by boat to assist with the rescue efforts. The first word back to the States about the accident was garbled and reported that the GUAM and TRENTON had collided and that the GUAM had overturned. While that misinformation was later corrected, the consternation created among the concerned families of the deployed ships and embarked units was understandable. Rescue efforts continued throughout the night but by first light the effort had become one of recovery of our shipmates. The ships would end up spending several more days

conducting accurate musters and accounting for the missing.

As the Assistant Command Duty Officer on GUAM, I was assigned as the Boat Officer of GUAM's Captain's Gig, and I and the 2-man crew of the LCPL were sent to the beach in anticipation of a scheduled protocol visit by the Mayor of Barcelona. Spanish Navy divers had arrived in the early morning hours to survey the accident scene and conduct the recovery. The magnitude of the loss quickly became evident, and it was not too long afterward that we were re-detailed and assigned as the prime recovery platform for this grim task. Forty-nine crewmen and marines from GUAM and TRENTON were lost in this tragic accident.

Several days later, GUAM moved pier side to the same molo adjacent to the accident site, and she remained moored for the duration of the port visit. At the conclusion of the port visit, a very touching moment occurred as the Ship was leaving the pier and heading for the sea. An older Spanish woman, dressed traditionally in black with her head covered, quietly appeared on the pier and, one by one, slowly tossed red roses into the harbor water, one for each of our lost shipmates.

In 1978, one year later, a 12-foot granite and iron memorial to these men was erected in Barcelona near the Muelle de Barcelona. "Two survivors of the incident who attended the ceremony were CPLs Alfonso Valent, Jr. and Harry L. Thomas. Their memories of that night are still vivid, and both are still reluctant to ride in liberty boats.

"After I was thrown into the water, I was sucked under about 15 feet and became disoriented," said Valent. "I




