The Senate Committee on Veterans and Emergency Preparedness voted 3 to 1 on 3/18/21 to send it to the full Senate for its vote. Sen. Linthicum voted against SB 790 – the only "Nay" vote on our six veterans highways bills over the last 12 years. Dick submitted the legion letter to the SB 790 testimony file.

A VE Day proclamation request was sent to the Governor's Office. Hopefully, we got it in under the thirty-day requirement window.

The Oratorical State contest held at the Santiam Post 51 was a success. Scholarship prize money total over \$13,000.00 to four winners and their group picture made the cover of the Legionnaire. Also, since National HQ canceled their contest, they awarded the winner an additional \$5000.00. I sincerely hope posts can see just how vital this program is and garner new candidates for next year. Remember, they can start now and practice all year long, so promote this Americanism program.

She is recovering from some surgery at the moment and still cranking it out. I received a call from a legionnaire that got a printed copy sent to the post. He was very appreciative to have and read it in his hands, so much, so he was all choked up trying to tell me how much it meant to him.

So It is essential for adjutants or whoever gets the post email to forward the link to the Oregon Legionnaire on our department website and print out a copy to those older members who don't have a computer. I heard a comment that the Oregon legionnaire is worthless! Only because the ones that need to get it are not receiving it. It still costs way too much money for every member to have a printed copy.

The Parking lot at Department has been resurfaced a very nice job by Oregon Paving. The Sprinkler system is in and the grass has filled in and looks great.

Hats off to our volunteers; they don't get enough credit. Speaking of Volunteers, Our National Vice Commander Rob Liebenow is our membership processing guru and makes calls to get people transferred into posts, reorganizes the files and supply cabinets. NATIONAL EXECUTIVE COMMITTEEMAN

We have had no live NEC meetings in 2020 or 2021, all have been by Zoom conference.

On January 13, 2021, our national commander Bill Oxford issued a call to action. He doubled down on three key challenges from last year designed to grow and strengthen our organization:

- 1. Recruit over 100,000 new members into the organization.
- 2. Attain 90% renewal rate.
- 3. Achieve 100% CPR reporting.

It is going to be tough to meet the hundred thousand new member goal. However nationwide we have over 615,000 expired members for 2019 and 2020.

The commander has a call to action for all leaders to:

- 1. Encourage our posts and districts to work their expired rosters,
- 2. Personally contact and renew those members who have not renewed,
- 3. Conduct periodic checks to those renewed members to see how they are doing.

We simply need to make working renewals our main priority.

With the #48 Indy Car Team Sponsorship, it is anticipated that we will get additional membership donations and sales from Legion emblem sales, not to mention the television advertising that we can get from the 17 IndyCar races per year. One being at the Portland International Raceway in mid-September where we can set up and take advantage of membership!

We had virtual national executive committee meetings on October 14 and 15th where we passed over 40 resolutions.

Of note resolution number 36 entitled **MISSION BLUE POST ASSISTANCE PROGRAM,** wherein posts with financial need could apply for thousand dollars grants for current and past-due mortgage payments, real estate rents, insurance premiums, and current which in past utilities as a result of covid. \$5 million was authorized from the American Legion national emergency fund for this program.

Eligibility for a Mission Blue Post Assistance Program grant requires posts to have:

- 1. A Consolidated Post Report on file.
- 2. Filed an IRS 990 within the prescribed due date.
- 3. Filed all other required forms and reports as prescribed by the department.
- 4. Actively participated in one or more American Legion programs in the last 18 months.
- 5. A financial need.
- 6. A certificate of insurance naming The American Legion doing business as American Legion National Headquarters as an additional insured.
- 7. Documentation indicating that the post is properly incorporated.

The Mission Blue Post Assistance Program grant application is available online.

American Legion posts applying for a grant will be required to first submit the completed application to their respective department for approval before it can be sent to National Headquarters. This application procedure is the same as the NEF.

American Legion posts have until Dec. 31, 2021, to apply for a Mission Blue CAP grant.

Resolution number 32. Risk management mandates for national youth programs which mandates sexual abuse awareness training and criminal history background check screening for American Legion baseball program staff, American Legion Boys Nation, American Legion national oratorical contest, Junior Shooting Sports, Boy Scouts. This resolution strongly urged and encouraged departments to establish procedures and policies for sexual abuse training and criminal history background

check screening.

Resolution number 35, insurance requirements.

Requiring that any and all insurance policies purchased by an American Legion department, department chartered intermediate body, post, or organization shall specify that the American Legion is held harmless and named as an additional insured on any and all insurance policies and it strongly urges all American legion departments to follow similar courses of protective action requiring departments on intermediate bodies and post that obtain insurance policies hold their respective American Legion departments harmless and also named as an additional insured. There will be more to come out from the national judge advocate on this resolution.

Covid restrictions will certainly put some limitations on our youth activities, but we will participate in all youth programs.

Probably, we will have a virtual Spring NEC, but the greatest news: The American Legion's 102nd National Convention will take place in Phoenix, Arizona, August 27 – September 2, 2021. I am so ready!

Saturday, February 27 I was at Department with the Permanent Finance Commission putting together the Proposed 2021-2022 Department Budget. The Proposed 2021-2022 Budget will be presented and discussed with the Department Executive Committee (DEC) at our Spring DEC Meeting which will be held at LaPine Post 45 on Sunday, April 11. After those discussions, the Proposed Budget will be published in the Oregon Legionnaire per our Constitution and By-Laws and presented to the Delegates at our Department Convention in June 2021 at Seven Feathers for discussion and adoption.

Yes, it is tax season, I know that I am repeating this, as I will continue too as we are seeing some of the negative outcomes in the filing of Post Taxes, a lot brought on by COVID 19, not being able to hold meetings face to face, not visiting our Posts, Post Visitations. And remember, please ask your Post if they have filed their Taxes. District Commanders ask your Posts, meetings, or phone if they have filed their Taxes. Every Post is a separate corporation and is required to file a 990, 990EZ, or 990-n each year, there are no exceptions.

Post elections for new officers and Post delegates to District Caucus and Department Convention is taking place "now". Department By-Laws, Article V – Convention, Section 1. Reads "The several Posts of the Department shall, at least forty-five (45) days prior to the opening of the annual Department Convention elect their delegates and alternates and certify them to the Department Adjutant. The registration fee for all authorized delegates, alternates, and delegates-at-large, as it shall be determined by the Department Executive Committee, shall be sent in accordance with the Convention Committee Code of Procedure. No delegate shall be seated at the Convention unless certification of such election is received by the Department Adjutant at least thirty (30) days prior, except as hereinafter provided."

Sixty (60) days before Department Convention the Department Adjutant will send out Convention Delegate Forms with the authorized Post Delegate strength. The delegate fee is \$15.00 for each delegate. The Post is responsible to send the Delegate Form with certification from the Post Adjutant and \$15.00 for each delegate strength. If a Post is authorized three (3) delegates and only has two (2) attending, the Post is still responsible to send in the delegate fees for three (3) delegates. Those Posts not returning their Certified Delegate Forms and delegate fees will not be in good standing and will have no delegate vote.

The following is the Judge Advocates report for the period following the Mid-Winter DEC to the Spring DEC. There are several issues that need to be resolved and action taken as listed below.

- 1. Request for copies of Department Resolutions has shown that there does not seem to be a logical or controlled method in use to control, track or store resolutions at Department Headquarters.
- 2. At the Department Commanders request, I forwarded to him a suggested draft of what I thought needed to be done to change the Department's Bylaws concerning putting on or taking a post off of probation. Commander has forwarded this suggested draft to the Resolution Assignment Committee and the Constitution and By-Laws Committee.
- 3. The Resolution Assignment Committee has been given the role of editor and approval authority for submitted resolutions. This procedure is out of the realm of "Resolution Assignment," and should be a function of the Constitution and By-laws committee for items that affect the Constitution and By-laws. The Resolution Assignment Committee was formed to ensure that resolutions submitted at the annual convention were routed to the appropriate commission/committee for action at the convention. However, this has morphed into a requirement in the Resolution Assignment Committee Code of Procedures that "ALL" resolutions will go through that committee. These issues need to be addressed, and authority and actions for the Resolution and Assignment Committee and the Constitution Committee and By-Laws need to be resolved as to what their roles are concerning resolutions.

- 4. Very few Constitution and By-Laws or "no-change" reviews have been received since the last DEC. A standard form has been developed to show review by the Department Judge Advocate on submitted Constitution/By-laws and/or "no-change." The form will be kept on file at Department Headquarters with the other required post documents.
- 5. A report was given at the last DEC concerning the use of "electronic" means of meetings and annual budget changes for the Constitution and By-laws. At this time there has not been any resolutions to change the vtDepartment Constitution or By-laws to reflect any changes. All changes to the Constitution and By-laws can only be approved at the annual convention, with other requirements concerning submittal dates etc. At the last DEC, the "assistance" team which was tasked to provide any required training, guidance and leadership support for the matter concerning Albany Post 10, gave their recommendation for the ending of probation
- 6. It is the recommendation of the Judge Advocate, that the Internal Affairs Committee be tasked in writing as to what their specific duties entail. Items such as a yearly review of required post documents on file, resolution, accountability and storage procedure, and reviewing of the Department Adjutant's responsibility for review and action on Headquarters' policies that are under their requirement to review. Examples: Policy 20-04-020 Book of Reports; Policy 20-04-021 The Legionnaire Newsletter; 16-09-001 Conference Calls (Go to Meeting); Policy 16-09-004 Document Retention; Policy 16-09-005 Equipment Inventory Checkout and Usage; Policy 16-09-007 Official Department of Oregon Vehicles(s); Policy 16-09-011 Rental of American Legion Facilities.

Even though the Regional Office is closed, we continue to work with veterans; advocating for their benefits and aiding as needed.

Some important information for Vietnam Veterans:

The VA has opened the *Program of Comprehensive Assistance for Family Caregivers* to veterans that served on or before May 7, 1975 (in addition to on or after September 11, 2001.) The Veteran must have a VA disability rating (individual or combined) of **70% or higher**. The Veteran's service-connected disabilities must have been caused or made worse by their active-duty service during one of the above-mentioned periods of time. The Veteran must also have been discharged from the U.S. military or have a date of medical discharge, **and n**eed at least 6 months of continuous, in-person personal care services. Please contact us for additional details or to apply.

The list of presumptive conditions due to herbicide exposure has grown by *three!* Bladder cancer, hypothyroidism, and Parkinsonism are the conditions added to the list of those connected to Agent Orange exposure as part of the FY 2021 National Defense Authorization Act (NDAA). A presumptive condition means that if a claimant's exposure to Agent Orange is validated, then the disease is presumed to be service-connected. The VA has not yet released any specific information on the process of extending these benefits to veterans.

Since our last report here are some basic statistics: The Department Service Office has assisted numerous veterans and their families with VA benefits and other services. This has been accomplished primarily by phone due to COVID-19. January 1 through March 25, the Service has represented **two** clients at virtual hearings with the Board of Veterans Appeals (VBA), brought on **42** new clients, filed **46** claims, and submitted **14** statements in support of claims. Assorted other paperwork was submitted for a total of over **130** forms.

The VA is experiencing a major delay in claims due to all the COVID-19 shutdowns. We have several veterans that have compensation claims well over a year old. We are seeing delays in the processing of pension claims as well. This is very frustrating and disheartening for the veterans as well as the service office.

We continue to see veterans and families frustrated at not being able to communicate with their previous advocates. Many are grateful that The American Legion continues to answer the phone and return calls. It has been a busy time.

A few highlights of the work performed these past few months:

Veteran A: This widow waited over seven years for resolution to her DIC (Death Indemnity Compensation) claim. He Vietnam veteran died in 2013 and the VA denied service connection for his death. Through a tragedy of errors, the waiting continued as well as the fight. There was a DRO hearing that confirmed the denial of a service-connected death. An appeal was filed, and the wait was on for a VBA hearing, that was held in January 2018. After a year of following up, we learned that the VBA had a technical malfunction, and the recording of the hearing was lost. Amid the COVID-19 shutdowns and slowdowns, we waited for a rescheduled VBA hearing.

The primary cause of death was complicated and involved. It was not a slam dunk, but it was well worth the research and efforts on behalf of the widow! In late February, we represented the widow at a virtual hearing in front of a VBA judge. In a very rare instance, the judge was clear in that the wait was over and stated that God works in mysterious ways. The widow was awarded nearly \$114,000.

Veteran B: This veteran contacted the service office on the recommendation of the family. He encountered delays and denials surrounding his claim for an increase, due to restrictions imposed by the response to COVID-19. In the end, the veteran's compensation increased from ten to forty percent and his family was able to escape homelessness.

Veteran C: This veteran contacted the service office in frustration. The previous VSO was not supporting the desire to file a claim for a knee problem. The veteran reported the VSO told them that "there wasn't a leg to stand on." The American Legion was successful in assisting the veteran with service connection for bilateral knees. Your service office promotes supporting veterans and not adjudicating claims in lieu of submitting them.

We continue to work with veterans; advocating for their benefits from the VA and aiding as needed. Please contact either one of us to assist you in filing an initial claim and/or keeping your appeal/review current!

Thank you for volunteering for this important job within your Post and Unit! Boys and Girls State American Legion and American Legion Auxiliary's premier programs for our American youth; a well-prepared, informed, and supported Chairman is essential for its success. This packet contains a variety of things designed to assist you in fulfilling the responsibilities of your position and make your chairman experience rewarding and successful.

We are going virtual for the first time in over 80 years of these programs. We will touch on the required items that will make this virtual program successful. You will be supported by the Oregon Boys and Girls State Committees if you have any issues.

The 2021 program will be virtual and conducted in the Zoom format 1 June 14-15th. The packets

the boys and girls will receive will have all essential information to attend this program including access to breakout sessions and joint sessions with Oregon Girls State. Yes, we are partnering with the Oregon Girls State Committee to share guest speakers that we feel will have an impact on both boys and girls. We will also have guest speakers for the boys and girls only. This is a huge endeavor and we are very excited to bring this to you.

PLEASE DISPOSE OF ALL PREVIOUS YEARS' MATERIALS! (EXCEPT BROCHURES AND POSTERS)

Below are guidelines and suggestions for delegate recruitment, interview, and selection procedures. The documents and information referenced in this letter are available on either www.orlegion.org or www.alaoregon.org website.

Delegate Recruitment and Selection

- 1. Due to the Covid-19 pandemic, Posts, and Units are having trouble communicating with schools and it is suggested, if you are having trouble, contact the School District Office directly and jointly. This will ensure that the information, "if they cooperate" will be sent through email from the office and/or announce the cooperation so when you drop off the packets to the schools, they will know you are coming with a date and time. Be diligent and contact the school often to ensure they are aware you are dedicated to the program and to those who will attend the session.
- 2. Once the information is at the schools, again be diligent and consistent with communication. Because we are having a virtual session, interviews can be conducted through Zoom. Contact either the Department Headquarters or the Department Girls State Chairman for help to get a Zoom account set up. It's easy and free if doing small groups. You'll have to allow the boys and girls access and it will make this process much easier. Zoom is also the system we will use for the virtual sessions also, so using it will help you understand how we will conduct the session and if the boys or girls have questions, you will have the knowledge to assist them. Don't be afraid of the change to virtual. We are here to support you in any way we can.
- 3. Do not forget the alternative high schools and Home School students when promoting the program. They are valuable participants for the programs and should not be left out. They too have to use the virtual world to attend portions of their schooling so this should be an easy program to attend.
- 4. The TAL and ALA Oregon Boys and Girls State application is a fillable PDF

form available on the TAL and ALA websites. Potential delegates should fill out the online form, print it, and have the school and parents sign it. Please make sure you fill out the post and Unit contact information on the forms so that the boys and girls know who is sponsoring them. Post and Units will need to mail or email the TAL and ALA brochures and School Information Letter to high schools in your area. Department Headquarters has brochures from National. You may stop by the office, print your own from the website, or have Department mail them to you. (You may be charged for the cost of mailing.) 5. Materials and resources for Posts and Units to use in contacting schools and recruiting Boys and Girls State Delegates are at www.orlegion.org and www.orlegion.org and www.orlegion.org and chairman contact information on materials you submit to schools and potential delegates because delegates must include their sponsor information on the online application.

- 6. A comprehensive interview must be conducted by the sponsoring Post or Unit. **NOT BY THE SCHOOL.** This can be done virtually and or with social distancing in place. The interview process is a valuable tool in selecting appropriate and interested delegates. For the ALA there is a short version of the interview questionnaire on the www.alaoregon.org website. Having a committee of Post or Unit members or a combination of both should be created to ease the interview process. Joint committees are very successful in the selection process. If the Post and Unit are small, a District wide interviewing session could be highly successful and maximize manpower. Contact Department for questions or assistance in conducting a virtual interview.
- 7. Delegates should be selected on the basis of leadership, character, and interest in community and government.
- 8. Once the selection of delegates is complete, you may either call, email or send a letter to the delegates. Customize any of your communications for either your Post or Unit, so the delegate is excited to be selected.

Fees

1. Delegate fees are \$100.00 for either a boy or girl. This fee will cover the mailings and items given to the boys and girls including shirts, pins, certificates, and the printing of the Girls State Handbook. Boys will

- receive their handbook through email, and they will print it themselves.
- 2. The \$100 fee may be paid by the delegate, a family member, a sponsor, or the Post or Unit.
- 3. Potential sponsors include other service organizations such as the Elks, Eagles, Moose, Soroptimist International, Lions, Kiwanis, school booster clubs such as PTA, and local businesses.
- 4. The community organizations have money that must be spent yearly so they are a great resource. Also, the local Native American Tribes have community-based grants that are given yearly. The Casinos also give grants.
- 5. A scholarship to attend is available for those who do not have a sponsor or cannot afford to pay the fee. We don't want to lose a boy or girl because they cannot afford the fee. Find either a sponsor or apply for a scholarship through Department.
- 6. Post Boys State Chairman will send the \$100 fee to TAL Department of Oregon and the Unit Girls State Chairman will send the \$100 fee to ALA Department of Oregon.
- 7. Refunds are at the discretion of the TAL or ALA Department of Oregon. There is a cut-off date of June 1St as we will be sending the Oregon Boys and Girls State packets after the 1St of June and we want the delegates committed to the program.
- 8. All checks from Delegates/Alternates and outside sponsors should be made payable to:

Oregon Boys State: TAL Department of Oregon PO Box 1730 Wilsonville, OR 97070

Oregon Girls State: ALA Department of Oregon PO Box 1730 Wilsonville, OR 97070

- 9. Girls State Chairmen please include your Delegate/Alternate form with the fees collected and send it to Department. To make it easier for the Unit, have the sponsors make checks out directly to the "ALA Department of Oregon".
- 10. Boys State Chairmen please make sure your delegates pay the sponsoring Post the delegate fee and the Post send in the fees once collected. The sponsoring Post may pay the entire delegate fee prior to collecting from the delegates. It is the choice of the Post how the fees are paid.
- 11. PLEASE make sure your delegates and alternates know that they need to tell you immediately if they cannot attend so an alternate if we have any can attend. In the last several years, we have not had any alternates, but we must include them in the information just in case.

Obtaining and Submitting Forms:

- 1. Documents, Resources, and materials can be accessed by Posts, Units, Students, and Schools on The American Legion website at www.orlegion.org and the American Legion Auxiliary website at www.alaoregon.org.
- 2. The 2021 Applications are an online fillable form, accessed on either website.
- 3. **Make sure the applications are completed in full.** All signatures must be collected.

Report: The 2021 Department Oratorical Contest was conducted on Saturday, Feb 20, at Santiam Post 51 in Lebanon. Given the challenges presented by the pandemic over the past year, including locating a host venue four weeks prior to the event, the contest was successful. We created opportunities, safely, for youth to grow and develop – how could it not be a success.

The success of the program is built upon a strong foundation of teamwork among our veterans. Our committee recognizes that and offers its gratitude and appreciation to everyone involved that worked safely to support the oratorical program. From those posts that actively sought to conduct their program, to the districts supporting posts and conducting district contests, to the volunteers who unselfishly stepped forward to help conduct the contests at the department level down to the posts — well done!

Many of our districts were active in engaging schools, but not always with success. And from what appeared would be six district contests, ended up being three. Those three district contestants vied for scholarships at the department contest with the results being:

The Oregon state legislative session got underway on Jan 19th. This is an odd year so the session will be no more than 160 days. So far there are more than 60 veteran bills have been submitted. However, there are more in the works and it is changing daily.

I have been in contact with Jennifer Donovan, the Senior Policy Advisor and Legislative Director of the Oregon Department of Veterans Affairs (ODVA). I am also working with the other veterans' groups though out the state of Oregon. ODVA publishes updates on the bills and what the status of them is. I will be Emailing these updates out through the department adjutant as they become available, which is usually weekly.

Anyone can submit testimony for a bill but remember to give a clear indication of which organization you represent. It is important to remind everyone that if the state that they represent The American Legion must have contacted National to get their support. Likewise, if you state you represent The American Legion, Department of Oregon, you will need to contact Headquarter in Wilsonville to insure all of Oregon is in line with your testimony.

There has been a number of bills that have started to be heard in committee. One of the top bills is the ODVA budget. Public hearings have been heard in the Ways and Means subcommittee Transportation and Economic Development from the Director of ODVA. She has requested about \$8 million from the general funds and about \$20 million from the lottery funds. There was a lot of concern from Representative Paul Evens on the amount of the lottery funds. This amount was an estimate of 1.5% of lottery funds for the biennium. With the COCID-19 restrictions were put in place, the lottery sales are down as the sale in bars and

restaurants have been low. He was told that there is a reserve fund to back the low sale estimates up.

SB 319 for the Vietnam memorial at capital grounds had a public hearing and a work session scheduled on Mar 2. The response for the Senate Veteran and Emergency Management committee was positive. Parks and Recreation were also present and were also positive although he had to remain nutria.

HB 2201 requires veterans in pretrial detention to receive their VA medical treatment. There was mixed feeling about this bill. Two sheriff departments testified that it would be too difficult for rural detention centers to provide this care and it may not be available. They also stated that it was too expensive to provide. Representative Wilde argued that when a veteran is taken into custody that the detainee was required to get his medical care. Others on the committee echo our concerns.

SB 184 changes the way preference points are given for veterans in public employment. Currently, there is 5 point given for a veteran and 10 for a disabled veteran. As the number of points may vary this bill will to a percentage of the total points. This bill was passed by the committee by 3 to 1 and will now move on.

There were three bills submitted by ODVA that came before the Veteran and Emergency committee. The ODVA director, Kelly Fitzpatrick, and the Senior Policy Advisor, Jenifer Donavan, testified on HB 2139, HB 2140, and HB 2141. HB 2139 establishes the Rural Veterans Healthcare Transportation Grant Program within the Department of Veterans Affairs. Directs department to provide grants to entities to provide transportation to veterans in rural areas to access services for physical, mental, or behavioral healthcare. HB 2140 put back the Department's explicit statutory authority for certain lending activities which were Inadvertently removed by SB 36 of the 2019 Legislative session. Additionally, HB 2141 will extend the Veteran Educational Bridge Grant.

A Legion member questioned SB 306 which Directs the Department of Veterans Affairs to study and make recommendations for policy proposals for the tax treatment of military pensions. Requires the department to submit a report on findings by January 1, 2023. A public hearing held where a retired Army Reserve veteran question why there was an arbitrary line drawn in the sand in 1991. He believes all veterans should not have their pensions taxed. There were few comments from the committee and another public hearing is scheduled. Any retiree that was in Oregon around the late 90s knows where the "line in the sand" for 1991 comes from. It will be interesting to watch this bill proceed.



The **100** Miles for Hope program is a vi1tual l00-mile walk/run/ride challenge to invigorate donations for the Veterans & Children Foundation, as well as encouraging American Legion Family members to be active in this time of social distancing. The foundation serves two primary functions. It provides critical grants for military and veteran parents in unexpected financial crises, and support for service officers in their tireless efforts to obtain care, benefits, and opportunities for disabled veterans and families. The American Legion's 3,000 accredited service officers provide free assistance for any veteran in need. The registration fee is \$20 and rewards every participant with a medal.

The program will be using the Kilter app that allows participants to take full advantage of pushing donations toward the foundation. It does not matter whether you walk, run, swim, cycle, use an elliptical trainer, or some other form of movement. The app has more than 40 different activities to choose from even rucking, dancing, and playing pickleball. And American Legion Riders can log their activities by choosing "advocacy" or "volunteering," or manually entering a ride. Participants may go to www.legion.org/100miles for information and registration about **100 Miles for Hope.**

The American Legion and Chip Ganassi Racing (CGR) have created a multiyear sponsorship agreement for the No. 48 Honda in the NTT IndyCar Series. The Permanent Finance Commission held the annual budget meeting at 9:00 am on February 27th, 2021. All of the commission members were in attendance along with the Department Commander, 1st Vice Commander, 2nd Vice Commander, Department Adjutant, and Lynn Newton were also present. This like every other year we continue to see a decline in membership which greater affects our annual budget. The first goal was not to reduce the amounts that fund the programs of our Department. They are the cornerstone of the Four Pillars for what we do as an organization. The sections of the budget were divided up between the members of the Commission to help everyone understand the budget, but also to fact find for ways to save money and not cut line items. The Administrative section was looked over with a microscope to help reduce costs that will prevent us from having to lay off employees in our Headquarters. Working with the Department Adjutant we were able to trim 5% reduction in the amount of over ten thousand dollars that could be used to balance the budget. The next important section was the Department Officers and District Commanders' travel budgets. Across the board, everyone took some form of reduction, minus the Department Judge Advocate.

The rationale is simple, we seem to be seeing more and more issues appearing at our Posts with the potential for more travel, that being said, it does not mean that all the funds will be used, but rather available. The budget included the Department Commander not attending the Washington Conference, one the Membership Chairman attend the National membership Meeting, no funds for the Alternate National Executive Meetings in the fall and the spring. When the final numbers were put in, we had a shortfall of over \$74,000. We were able to balance the budget by funding the VAVS section of the budget with 100% funding from the Oregon American Legion Foundation with a grant. This money can only be used for VAVS which supports our Service Officers. As you can see this year was no easy task. The hope is membership will pick up, sales from our Revenue Enhancement Program will pick up, LIT Insurance will provide extra needed dollars along with USAA Insurance. I know some will be unhappy with the outcome, but we all need to remember why we belong, and we all are volunteers. Money everyone receives for the various Offices and Commissions to help defray some of the costs is not to pay the entire way. I want to thank the Commission for their dedication to help prepare next year's budget and want to remind everyone this is a budget and increase revenue with the items mentioned above, can restore items that may have taken a cut.

pA Toxic Legacy-Vietnam to the GWOT

Millions of veterans have been deployed in the Global War on Terror, and a disturbingly high percentage of them have been exposed to airborne toxic hazards during their service as a result of burn pits. The Department of Defense (DoD) is beginning to track locations where it utilized burn pits, but this data is far from exhaustive and many years late. Regrettably, the conversation on toxic exposures is not a new concept to the American Legion and the Department of Veterans Affairs {VA}. The American Legion has for decades fought for service-connected disability benefits for adverse health conditions linked to toxic exposures from a variety of toxic substances.

As the VA Public Health Department tells us, "Veterans may have been exposed to a range of chemical, physical and environmental hazards during military service." These exposures result in health concerns such as; burn pit-related illnesses, Agent Orange-related diseases, Gulf War Veterans' illnesses, radiation-related diseases, vaccinations, and medications, etc. Exposure to toxic chemicals may have happened across various wars and operations, including Operations Iraqi Freedom, Enduring Freedom, New Dawn, the Gulf War, and Vietnam.

Most recently and as a result of the NOAA 2021 bill, three new illnesses have been added to the presumptive illnesses associated with Agency Orange exposure. They are Bladder Cancer, Hypothyroidism, and Parkinsonism. To determine if you are service-connected for these illnesses, you are encouraged to contact the Department of Oregon's American Legion Service officers.

The American Legion continues to push for the inclusion of Hypertension as a service-connected illness associated with exposure to Agent Orange. While this illness is not yet approved, the American Legion will notify our members if this illness is added by the action of the US Congress.

Your VA&R Commission expresses great appreciation to the Washington DC Legislative staff for their continuing efforts to add these illnesses to those that now qualify for service-connected compensation for our members.
