The Proposed 2021-2022 Department Budget will have been presented and discussed with the Department Executive Committee (DEC) at our Spring DEC Meeting at La Pine Post 45 Sunday, April 11th. After those discussions, the Proposed Budget will be published in the Oregon Legionnaire per our Constitution and By-Laws and presented to the Delegates at our Department Convention in June 2021 at Seven Feathers for discussion and adoption.

Yes, I will continue to repeat this. It is tax season, and please make sure that your Post files their taxes. March 15th is the due date for filing 990 tax reporting if your reporting year is January 1st to December 31st. With COVID 19, not being able to hold meetings face to face, not visiting our Posts, some Post activity is not being done. Please ask your Post if they have filed their taxes. District Commanders ask at your Posts meetings or phone if they have filed their taxes. Every Post is a separate corporation and is required to file a 990, 990EZ, or 990-n each year; there are no exceptions.

place. De- PDC, Bob Huff partment DEPARTMENT FINANCE OFFICER By-Laws, Article V - Convention, Section 1. Reads "The several Posts of the Department shall, at least fortyfive (45) days before the opening of the annual Department Convention, elect their delegates and alternates and certify them to the Department Adjutant. The registration fee for all authorized delegates, alternates and delegates-at-large, as it shall be determined by the Department Executive Committee, shall be sent in accordance with the Convention Committee Code of Procedure.

No delegate shall be seated at the Convention unless certification of such election is received by the Department Adjutant at least thirty (30) days prior, except as hereinafter provided." The Department Adjutant has sent out Convention Delegate Forms with the authorized Post Delegate strength. The delegate fee is \$15.00 for each delegate. The Post is responsible for sending the Delegate Form with certification from the Post Adjutant and \$15.00 for each delegate strength.

If a Post is authorized three (3) delegates and only has two (2) attending, the Post is still responsible for sending in the delegate fees for three (3) delegates. Those Posts not returning their Certified Delegate Forms and delegate fees will not be in good standing and will have no delegate vote. The delegate forms are also located on our Department Web Site.

The American Legion Calls for Expediting Visas for Afghan Interpreters

WASHINGTON (April 29, 2021)

- Stating that "time is of the greatest essence," American Legion National Commander James W. "Bill" Oxford wrote to President Joseph Biden and Secretary of State Antony Blinken and called on the administration to speed up the processing of visa applications for interpreters who assisted U.S. troops in Afghanistan.

Oxford explained that he sent the letters because of the dire consequences that interpreters face. "A Michigan Legionnaire who served in Afghanistan described the situation in stark

May 28, 2021, is National Poppy Day. The American Legion and the American Legion Auxiliary have long utilized

the red poppy in memori-

am to promote reverence for our military who sacrificed their lives for our freedom and long promoted remembrance of our veterans for their sacrifices in service to our country. After World War I, the poppy flourished in Europe.

Scientists attributed the growth to soils in France and Belgium becoming enriched with lime from the rubble left by the war. From the dirt and mud grew a beautiful red poppy. The red poppy came to symbolize the bloodshed during battle following the publication of the wartime poem "In Flanders Fields." The poem was written by Lieutenant Colonel John McCrae, M.D., while serving on the front lines.

Alexis Hannum Helmer was killed in battle during the Great War while serving with the 2nd Battery, 1st Brigade, Canadian Field Artillery. He is known as being part of the inspiration for In Flanders Fields through his friendship with John McCrae.



The day before he wrote his famous poem, one of McCrae's closest friends was killed in the fighting and buried in a makeshift grave with a simple wooden cross. Wild poppies were already beginning to bloom between the crosses marking the many graves. Unable to help his friend or any of the others who had died, John McCrae gave them a voice through his poem. It was the second last poem he was to write.

On September 27, 1920, the poppy became the official flower of The American Legion family to memorialize the soldiers who fought and died during the war. In 1924, the distribution of poppies became a national program of The American Legion. Led by the American Legion Auxiliary, each year, members of The American Legion Family distribute poppies with a request that the person receiving the flower donate to support the future of veterans, active-duty military person-

nel, and their families with medical and financial needs.

The American Legion World Series to be held as originally scheduled

INDIANAPOLIS (April 26, 2021) – The head of the nation's largest veterans organization announced that The American Legion World Series will be played in Shelby, N.C., August 12-17. The eight-team championship tournament is returning after the premier baseball event was cancelled in 2020 due to the coronavirus pandemic.

"As a former American Legion Baseball coach, I am extremely excited about the return of this fantastic event," American Legion National Commander James W. "Bill" Oxford said. "With the availability of vaccines and additional data showing that young people participating in outdoor activities represent a low risk for spread of the virus, we feel that we can conduct a safe world series. This is a very different environment than what we faced last year. Many of us eagerly await the umpire's welcoming words of 'play ball!"

Though final details are still being considered, officials at national head-quarters plan to conduct American Legion Boys Nation at Marymount University and the American Legion 3-Position Air Rifle Junior Shooting Sports National Championships in Colorado Springs as originally scheduled. The American Legion will observe Center for Disease Control guidelines and local and state public health mandates for all of its national programs.





The American Legion calls for ending 'Forever War,' repealing, replacing Authorization for Using Military Force

WASHINGTON (April 15, 2021) – Calling the White House plan to fully withdraw troops from Afghanistan by September 11, "a good start," the leader of the nation's largest veteran service organization, The American Legion, is calling for an end to the "Forever war," nearly twenty years after troops were deployed there.

Acknowledging that the United States "had little choice but to strike back hard" after the 9/11 attacks, American Legion National Commander James W. "Bill" Oxford called for the repeal of the "outdated authorizations for use of military force" that are currently being used to keep U.S. troops in Afghanistan and Iraq.

"Today, there are men and women defending our nation in uniform who were born after 9/11." Oxford wrote in the May issue of The American Legion Magazine. "Thousands of American lives have been lost or broken fighting the global war on terrorism. An entire generation grew into adulthood without knowing a time when the United States was at peace."

Oxford's position mirrors a national resolution titled "Addressing the 'Forever War,' passed by The American Legion National Executive Committee (NEC) during its virtual meeting October 14-15, 2020. The NEC Resolution also states, "Our servicemembers accomplished their original objectives in Afghanistan long ago at great cost..."





The Trust has been so successful in its over fifty years that today over 500,000 Legionnaires in 50 participating Departments are enrolled in this unique program.

Also, in the same period of time, almost \$1 billion dollars in claim benefits have been paid to Legionnaires and their families through the LIT; and over \$100 million in allocations have been paid to participating Legion Departments. The first Trust insurance plan to be offered was the Hospital Income Protection plan, a program designed to pay fixed dollar amounts for periods of hospital confinement. #### Vet Charity Watch Update 68: Sham 'Healing Heroes Network' Charity

The charity, founded by a Palm Harbor, Fla., doctor, was called Healing Heroes Network. Its stated goal: To use generous contributions from donors for medical care, therapy and rehabilitation for veterans wounded in Iraq and Afghanistan after 9/11. "Often, these men and women are unable to receive the medical treatments that would help them return to a productive civilian life," read a fundraising letter.

But this year, after a multistate investigation, the Florida Attorney General's Office called Healing Heroes "a sham veterans charity." A recent court settlement would prevent Dr. Allan Spiegel, 68, wife Stacey Spiegel, 59, and son Neal Spiegel, 31, from running a nonprofit for five years. They will also pay \$95,000 that will go to a veterans' charity that provides the kind of services Healing Heroes promised. Healing Heroes Network, Inc. was formed in Palm Harbor in 2008, according to court records, and sought donations through telemarketing and direct mail. But "very little of the charitable contributions" went toward care for wounded veterans, the Attorney General's Office said. Instead, money went to professional telemarketing fundraisers, ads, salaries for Stacey and Neal Spiegel, and T-shirts from a family member's clothing business, according to state officials.

In 2016 and 2017, Healing Heroes "falsely claimed" on social media that 100% of its proceeds went to wounded veterans, the Attorney General's Office said. In those two years, Healing Heroes provided or paid for medical services for only 10 veterans across the country, according to the civil action filed in Pinellas County court earlier this year. In 2016, Healing Heroes' revenue was \$2.7 million. A small fraction of that — \$13,387 — was spent on grants and other direct services to veterans, court records said. "This is outrageous," Attorney General Ashley Moody said in a January news release. "The fact that anyone would exploit the service and sacrifice of our wounded military heroes to solicit money under false pretenses is deserving of the highest level of contempt." Dr. Spiegel did not return messages left at his medical office. Stacey Spiegel could not be reached for comment. Lawyers listed in court documents did not respond to phone and email requests for comment. Contacted by the Tampa Bay Times, Neal Spiegel declined to speak with a reporter.

Healing Heroes was dissolved in late 2017, and Hero Giveaways formed soon after. Court documents say Hero Giveaways did not use proceeds to provide benefits to veterans and their families "as advertised." Hero Giveaways was voluntarily dissolved in 2019. In the settlement court documents say was agreed to by the parties, Healing Heroes and Hero Giveaways cannot solicit for charitable donations again. The Spiegels agreed to pay the \$95,000 and can't oversee, manage or solicit donations for any nonprofit for five years, the Attorney General's Office said. The Florida proceedings were part of a joint action with California, Illinois, Maryland, Minnesota, Missouri, New Mexico, Ohio, **Oregon**, Virginia and Washington state. The multistate settlement is final in Florida, but awaiting court approval in one other state before the \$95,000 is recovered and distributed.

In 2013, as part of a yearlong investigation into charities across America, the Times and the Center for Investigative Reporting reviewed Healing Heroes. The report cited a few red flags. Dr. Spiegel, a specialist in hyperbaric oxygen therapy, advocated it to treat some combat injuries, the Times reported. During a two-year period when the charity said it spent about \$160,000 on services for veterans, he got paid more than half of that. Stacey Spiegel ran the nonprofit a few doors down from her husband's medical practice and in 2012 earned \$110,000 as its treasurer, the Times reported.

## FEMA to Help Pay Funeral Costs for COVID-19-Related Deaths

Jan. 20, 2020 for deaths related to coronavirus (CO-VID-19) to help ease some of the financial stress and burden caused by the pandemic. The policy was finalized today, and FEMA is now moving rapidly to implement this funeral assistance program nationwide.

"At FEMA, our mission is to help people before, during and after disasters," said Acting FEMA Administrator Bob Fenton. "The COVID-19 pandemic has caused immense grief for so many people. Although we cannot change what has happened, we affirm our commitment to help with funeral and burial expenses that many families did not anticipate."

To be eligible for COVID-19 funeral assistance, the policy states:

- The applicant must be a U.S. citizen, non-citizen national, or qualified alien who incurred funeral expenses after Jan. 20, 2020 for a death attributed to COVID-19.
- If multiple individuals contributed toward funeral expenses, they should apply under a single application as applicant and coapplicant. FEMA will also consider documentation from other individuals not listed as the app-

Release Number licant and co-applicant who may have • penses were incurred. incurred funeral expenses as part of the registration for the deceased individual.

- An applicant may apply for multiple deceased individuals.
- The COVID-19-related death must have occurred in the United States, including the U.S. territories and the District of Columbia.
- This assistance is limited to a maximum financial amount of \$9,000 per funeral and a maximum of \$35,500 per application.
- Funeral assistance is intended to assist with expenses for funeral services and interment or cremation.

In the coming weeks, a dedicated 800 number will be established to help individuals who apply. In the meantime, potential applicants are encouraged to start gathering the following documentation:

- An official death certificate that attributes the death to COVID-19 and shows that the death occurred in the United States. The death certificate must indicate the death "may have been caused by" or "was likely the result of" COVID-19 or COVID-19-like symptoms. Similar phrases that indicate a high likelihood of CO-VID-19 are considered sufficient attribution.
- Funeral expense documents (receipts, funeral home contract, etc.) that include the applicant's name, the deceased individual's name, the amount of funeral expenses and dates the funeral ex-

Proof of funds received from other sources specifically for use toward funeral costs. Funeral assistance may not duplicate benefits received from burial or funeral insurance, financial assistance received from voluntary federal/state/local/tribal/ agencies, territorial government programs or agencies, or other sources.

terms. Interpreters who are discovered by the Taliban will be swiftly beheaded. The unlucky ones will have to watch their families die first," he said. "While we welcome an end to these endless wars, we must never abandon the brave Afghan and Iraqi allies who took great personal risk to assist our military with its missions. We must not leave them behind. They have earned safe passage to America."

Oxford directed his Washington staff to work with the Biden administration on the best way to fix what has been described by Brown University as a "slow and inefficient" processing program that takes over two years. In his letters to Biden and Blinken, Oxford noted that Special Immigrant Visa (SIV) recipients "go through the strictest vetting and approval process of any category of person coming to the U.S. already, but we must balance security concerns with a commitment to those who fought alongside us."

The American Legion foresaw this issue in 2018 when its National Executive Committee unanimously passed Resolution No. 16, which called for Congress and the president to recognize Afghan and Iraqi SIV recipients who "stood shoulder to shoulder" with U.S. troops and diplomats.

Oxford further promised that "The American Legion will not let this go. Military equipment is being removed from Afghanistan right now. But people are our greatest asset. We urge every American to contact their congressional delegations and insist that they prioritize the protection of our heroic allies and their families."



The most important thing you can an interested

do as an interested candidate for an of-

ficer role at the Department, District, or Post level is to request and get a copy of the Constitution and Bylaws for the respective level. I say this is 'most important' because it will spell out the officer positions, whether they are elected or appointed positions, and the general responsibilities of the role.

Elected positions are those where the majority of the present members are given the opportunity to select the candidate of their choosing, whereas appointed positions are put in place without the voice of the membership but hopefully within the boundaries of succession planning. Here is my perspective of some of the officer positions:

**Commander** (elected or appointed via succession) - If you have a strong officer team, this is one of the easiest positions at a Post. Must be willing and retention. At our Post, this role reaches out to delinquent members, participates in DMS activities, performs Buddy Checks, and reports to the commander on the current and future of Post membership. Second Vice Commander (typically elected) - leads to make decisions, right or wrong, and stand by them. Often a strong public speaker can manage a meeting, has at least a basic understanding of parliamentary procedures, and is often looked at as the 'figure-head or CEO of the organiz-

ation. Commanders plan the years' operations, appoint committee leaders, and motivates members to participate and 'get excited' about Post operations. Commanders motivate, encourage participation, and support the activities of the members and other leaders. This is a position that can change year over year, but at the Post level, it is more effective to have some continuity, and past commanders are the strong mentors for tomorrow's commanders.

Adjutant (elected or appointed) – Is the primary administrative officer for the organization. They document the meetings, complete the reports, and provide continuity year over year, as Posts are best served by an Adjutant that can provide multiple years of support and training for their replacement (eventually). While TAL Officer's Guide states, "the only indispensable qualifications for the job of adjutant are honesty and willingness." I would add that organization, communication, and not procrastinating are also key qualities in a good adjutant

Finance Officer (elected or appointed) - is charged with all receiving and distributing of funds. It is paramount that the individual in this role is trusted and trustworthy as they are touching the organization's day-to-day funds and financial activities. First or Vice Commander (typically elected or appointed via succession) - is primarily responsible for membership positions:

**First Vice Commander** (typically elected or appointed via succession) – is primarily responsible for membership and retention. This role reaches

out to delinquent members, participates in DMS activities, performs Buddy Checks, and reports to the commander on the current and future of Post membership.

**Second Vice Commander** (typically elected) – leads the Post and organizations programs to the 'Community, State, and Nation.' This is not to say this position does everything in regard to the programs but appoints and manages other leaders and oversees the post's programs and activities, and keeps the commander informed of the results and needs.

Keep in mind; these are all accompanied with 'and other duties and responsibilities as assigned and necessary.

Origin: Amendment to Department Constitution and Bylaws on Elections

**Submitted By:** Ad hoc Exigency Action Committee

WHEREAS, The Department of Oregon adheres to the principles and abides by the jurisdictional guidance described within the National, and Department, Constitution and Bylaws; and,

WHEREAS, The legislative body of the Department of Oregon shall be a department convention to be held annually at a location determined by approval and vote of the Department Executive Committee; and.

WHEREAS, Critical business functions occur at the Department Convention including the election and ratification of officers, approval of an annual budget, election and ratification of delegates to the National Convention, and taking action on resolutions brought forth before the convention voting delegation; and

WHEREAS, The potential exists for the postponement or cancellation of the Department Convention due to unforeseen or unactionable outcomes of events, which negatively impacts the ability of the Department of Oregon to conduct perfunctory duties and obligations; and,

WHEREAS, Department of Oregon remains steadfast with resolve to fulfill our mission statement that "The American Legion strengthens our communities, states and nation with programs and services for our veterans, the military and their families"; and,

WHEREAS, Current modern business practices and technologies have evolved since The American Legion originated and it is leadership's responsibility to advance recommended best practices to the benefit of The American Legion and all veterans; now, therefore, be it,

RESOLVED, That the Department of Oregon Constitution and Bylaws be amended to permit, upon exigency, the conducting of a virtual convention whereby the requirements, obligations and actions of a typical convention are fulfilled via audio-visual conference technology, in accordance with statutory law, as stipulated further within this resolution; and, be it further

RESOLVED, That the Constitution of The American Legion Department of Oregon Article V, Section I. be amended to "The legislative body of the Department of Oregon shall be a Department Convention to

be held annually; the location of such Convention shall be fixed by a vote of the Department Executive Committee upon the recommendation of the Department Convention Commission. In the event of such exigency that the Department Convention cannot be conducted where, and as, scheduled, the Department Executive Committee shall fix, by vote, a decision to conduct a virtual Department Convention by audiovisual conference technology upon such dates commensurate with the exigency."; and, be it further

RESOLVED, That in consideration and concurrence with the Convention Commission, an electronic voting platform be utilized as deemed necessary during exigency, in accordance with statutory law, to conduct, collect and document for record all voting measures that be conducted; and, be it further

And, as deemed necessary, an electronic voting platform be utilized, in accordance with statutory law, to conduct, collect and document for record all voting measures that be conducted."; and, be it further

RESOLVED, that minor edits to language described herein be permitted provided no substantial deviation occurs from the context of this resolution; and, be it finally

RESOLVED, This amendment be adopted upon acceptance by The American Legion, Department of Oregon, at the 2021 Department Convention, Canyonville, Oregon.

WHEREAS, One of the purposes The American Legion was congressionally charted on September 16, 1919 was "To uphold and defend the Constitution of the United States of America," that has not changed 102 years later; and

WHEREAS, One of the value principles in The American Legion's mission statement is "American Values and Patriotism meaning "The American Legion advocates for upholding and defending the United States Constitution...", and

WHEREAS, American Legion members, having served in America's Armed Forces as Officers and Non-Commissioned Officers took an oath "...to defend the Constitution of the United States of America, against all enemies, foreign and domestic...;" an oath that has been taken since 1775 with some revision; and

WHEREAS, Certain documents such as DOD Directive 1344.10 and the Hatch Act of 1939 (revised in 1993) direct the military to maintain a nonpartisan position regarding politics, and

WHEREAS, According to published open-source documents, statements of a partisan or political nature were made by high-ranking military officers and non-commissioned officers, a clear violation of their oath of office, DOD Directive 1344.10, and the Hatch Act of 1939, and

WHEREAS, The Department of Defense has conducted "stand downs" for the possible purposes of indoctrination of a partisan political nature detracting focus from America's national security interests around the world; now, therefore, be it

RESOLVED, By the 102nd Convention of The American Legion, Department of Oregon meeting assembled in Canyonville, Oregon on June 24-26, 2021, that as the largest veteran service organization The American Legion publicly express its concern for the above-mentioned events and speak out in defense of our oaths of allegiance; and be it further

RESOLVED, The American Legion encourage Departments to be vigilant of violations of a partisan political nature by any person or organization under the auspices of DOD Directive 1344.10 or the Hatch Act of 1939 and inform their elected representatives when they occur; and be it further

RESOLVED, That The American Legion use multi-media resources to reaffirm its advocacy to America of its perpetual commitment to its congressional charge of upholding and defending the constitution of the United States of America and of The American Legion's long-standing commitment to its 4-Pillar multi-faceted national security position, and the promotion of American values and patriotism; and be it finally

RESOLVED, That upon acceptable vote at The American Legion, Department of Oregon Convention on June 25, 2021 at Seven Feathers Resort in Canyonville, Oregon this resolution be forwarded to the National Organization to be presented at The American Legion 2021 National Convention to be held in Phoenix, Arizona.
