

Okay. Legionnaire of the Year Mike Speers. I want to keep this meeting short. After all, we have a party to conduct this afternoon but a couple of things that we need to take care of before we can move on. And one thing I want to say, as I've been traveling around, we really need to focus on the programs. If we get our program back on track, that what's going to solve our membership issues. That's going to make people see what they want to be involved in. So there's going to be a big push to work on programs, and use public affairs capabilities to be able to do that. So that's key for our success in the future.

Now, that being said, what I really expect from district commanders this year, is I want to know, how our department and how our committees can help you. That's where we need to get that traction. What do you need to increase the visibility of these things? So take advantage of these resources. I don't believe we get to fully utilize all of our committees and commissions in the past. So let's start with working those guys and get our money's worth out of them.

Gene Hellickson:

Members of the Department Executive Committee here and now referred to as DEC as used in the standing rules are set forth in Article seven section one of the department constitution and article four section two of the department by-laws.

Minutes of the previous meeting shall be sent to all DEC members at least 15 days prior to the meeting date.

The meeting agenda shall be sent to all DEC members at least 15 days prior to the meeting date. Roll calls shall include Past Department Commanders. No other visitors will be introduced.

A voting member of the DEC may request a suspension of the Standing Rules that a non-member of the DEC be given the privilege of the floor for the purpose of explanation of a specific proposal that has been proposed to the DEC and is under discussion. Time shall be limited to five minutes. However, additional time may be granted to answer pertinent questions. A two-thirds affirmative vote of members of the DEC shall be required for an extension of time.

All requests for expenditure of funds in excess of a budget adopted at the annual convention shall be sent to the DEC or the members of the Permanent Finance Commission at least 15 days prior to the DEC meeting date, and must be in resolution form.

The proposed annual budget as prepared by the permanent finance commission shall be sent to all members of the DEC not less than seven days prior to the DEC meeting.

Voting shall be by roll call on all resolutions in the following order. District Commanders, Department vice Commander, Department finance Officer, Junior Past department Commander, National Executive Committeeman. The Department Commander shall vote only in the case of a tie.

Members of the DEC should submit their reports in writing, and reports will be limited to five minutes and a copy of the same shall be given to the Department Administrative Assistant.

All Chairmen of Department standing commissions and committees shall submit their reports in writing.

All motions must be originated by a voting member of the DEC.

All of codes of procedure shall be submitted in writing to members of the DEC at least 15 days prior to the date of the Fall DEC meeting.

These Standing Rules may be suspended for a specific cause by a two-thirds affirmative vote of the DEC members present.

The advance time notices are waived for the Post Convention DEC meeting.

Any time a poll is needed, the Department Adjutant shall send out a letter of explanation with a ballot to be returned within five working days.

And so, one of the goals that we have is to make this as simple as possible. We have a membership award, a retention award and a transfer award. The membership award is real simple. The district must hit goal and be the highest. There aren't really a whole lot of rules and regulations to that. But what you get is a dinner for two, cruise along the Columbia River through the historic Scenic Area aboard the authentic sternwheeler, and the executive chef... I'm reading this off their website... So basically, you get the Admiral's package includes the window seat and bar-drink, beverages, upgraded dessert, souvenir glass, boarding photo and appetizers, all that is included in that price.

Then we have the retention award. Again, my goal this year was to make everything very simple and easy to attain. Retention reward is \$100 to your favorite restaurant to take you and your spouse out for a fun evening. The way you win that is district with the highest retention percentage by May 1. Then we have a transfer award. Working with the DMS114 list. We have different stuff, but this one here is going to be a little bit different. So the transfer award, again is \$100 to your favorite restaurant.

However, what it will be is a district that gets the highest percentage of their 114 DMS transfers completed, again by May 1, wins. But this award will be handed over to the district, and the district gets to decide what member of the district receives it. So while the other ones, it's highlighted one's a district Post-Convention DEC

membership chair, and the other one's a district commander. This one, the district will actually get to decide who deserves that award. Down at the bottom, it's real simple. Given our current dilemma with my Legion not reporting accurately, it is highly advised and recommended to have your post commanders keep track the best they can have transmittals and transfers. So that way at some point in time, this will get cleaned up. And then if we have a record of it, we can go in and start fixing this. But if we're shooting from the hip. 
