That was eight votes for Mick Wilson from post 180.

Post 184, Travis [inaudible 00:34:03] has three votes.

John:

John Leaf, post 184, casts three votes for Larry Whitmire.

Bob Huff:

Thank you. I will now ask ... I'm a voting member also. [crosstalk 00:34:22]. I am post 192, the last post.

Speaker 1:

Post 192, White City, has four votes.

Bob Huff:

All four votes are for Larry Whitmire ... are for Larry Hill, excuse me. That is four votes from post 192, for Larry Hill. [crosstalk 00:34:41].

Susan Hughes:

185?

Bob Huff:

192.

Susan Hughes:

I know, but what about [crosstalk 00:34:51].

Bob Huff:

Musician's is zero votes, sorry. I got excited. [crosstalk 00:34:53].

Speaker 4:

At your age, you got excited?

Bob Huff:

I sometimes get excited. I had five cups of coffee this morning.

Susan Hughes:

Hey TMI, TMI, TMI.

Bob Huff:

Hey, [crosstalk 00:34:53]. That concludes the voting. We will now await the final count. [crosstalk 00:34:53].

Speaker 4:

Say Bob, what is the majority? What number is the majority? How many votes? 51%.

Bob Huff:

51. [crosstalk 00:34:53]. It came out to like-

Speaker 4:

What's the number? How many votes?

Bob Huff:

Oh, I'm sorry. [crosstalk 00:35:38].

Speaker 1:

Bunny Bigly from 122. [crosstalk 00:35:48].

Bob Huff:

I need to take care of this one. 51% of the votes, let me calculate that. [crosstalk 00:35:59]. No, I actually have it written down in the book. [crosstalk 00:36:06]. Remember, we have several folks that didn't vote. [crosstalk 00:36:16].

If all the posts in good standing were here, 279 would have been the total vote. I'm going to go through now and calculate the posts that voted, what would be 51%.

We have the total, [crosstalk 00:37:03].

51% of the votes would be 104 votes. There were 206 votes cast.

Speaker 1:

But it's not 51%, it's majority voting. So 50.5 would be majority voting. [crosstalk 00:40:23]. The majority [crosstalk 00:40:26].

Bob Huff:

50 point what? [crosstalk 00:40:27].

Speaker 1:

Is that the same number you got? [crosstalk 00:40:27].

Bob Huff:

Oh shit, [crosstalk 00:41:36]. This is ... [crosstalk 00:41:46]. We have two posts that have [crosstalk 00:41:51].

Speaker 1:

The one was ... 68 was [inaudible 00:42:08] Galloway.

Bob Huff:

Yeah, and 90 ... [crosstalk 00:42:14].

Speaker 1:

Right. [crosstalk 00:42:17].

Bob Huff:

I knew it was the first [crosstalk 00:42:25].

Speaker 1:

I got 104. Bob Huff: That's what he got. Speaker 1: Then I got 86, for [crosstalk 00:42:36]. Bob Huff: I was thinking [crosstalk 00:42:42]. Speaker 1: I never did see this lady come in the door. [crosstalk 00:43:28]. Bob Huff: They won't say the count. [crosstalk 00:43:48]. Speaker 1: Hey Bob? Can you check something for me? On page two ... 129 central [crosstalk 00:47:47]. Bob Huff: Yes. Speaker 1: Can you tell me [crosstalk 00:47:49]. Bob Huff: Yeah, that's right there. [crosstalk 00:47:53]. Speaker 1: My numbers are wrong. I thought it was [crosstalk 00:48:00]. Okay, so what's Larry Hill then the 37 votes to [crosstalk 00:48:03]. This drops by three, to 90. [crosstalk 00:48:03].

Bob Huff:

Huh?

Speaker 1:

It's what they have, too. So what I'm saying is I'm going to double check. So this is 81, [crosstalk 00:48:39]. On this one, it turns out to 78, it's 81, so this total ... well actually, excuse me. Yeah, you have to add three to his. It was 78, post 81, [crosstalk 00:49:36]. Because central [crosstalk 00:49:36]. I actually had it [crosstalk 00:49:36]. That's what I'm saying if you move that over, this number goes up three, [crosstalk 00:49:36].

Speaker 2:

Please take your seats, [crosstalk 00:49:36].

Speaker 1:
