### Steve Adams:

I deserve that, Rob, yes. Okay, I'm going to make these opening remarks short. We've had a year and a half of struggle. We've had a year and a half of things that were come our way that we had no control over and it was something new and we had to learn how to cope through it. We have learned should it happen again, we have the knowledge that we have obtained in the last year and a half and it won't be as bumpy. I would like since this is my last DEC, I would like to thank everybody in this room for the support and encouragement that they have given me for two years. Thank you very much.

I will now call on the Judge Advocate, Gene Hellickson to read the standing rules of the DEC.

## Gene Hellickson:

Bylaws Article 10 Rules of Order, section one, all proceedings of this Post, department, excuse me, shall be conducted under the pursuant to the Robert's Rules of Order except as herein otherwise provided. Excuse me.

I apologize, I grabbed the wrong piece of paper. Members of the department executive committee here and referred to as the DEC as used in these standing rules are set are as set forth in article seven, section one of the department Constitution in article four, section two of the department bylaws. Minutes of the previous meeting shall be sent to all DEC members at least 15 days prior to the meeting date. The meeting agenda shall be sent to all DEC members at least 15 days prior to the meeting date. Roll call shall include the Past Department Commanders, no other visitors will be introduced. A voting member of the DEC may request a suspension of the standing rules that a non-member of the DEC be given the privilege of the floor for the purpose of explanation of a specific Department Convention Pre-DEC Meeting Minutes June 23<sup>rd</sup>, 2021, Canyonville Oregon

proposal that has been proposed by the DEC and is under discussion. Time will be limited to five minutes however, additional time may be granted to answer pertinent questions.

A two-thirds affirmative vote of the members of the DEC shall be required for an extension of time. All requests for expenditure of funds in excess of the budget adopted at the annual convention shall be sent to the DEC members and the members of the permanent finance Commission at least 15 days prior to the DEC meeting date and must be in resolution form. The proposed annual budget as prepared by the department of finance Commission shall be sent to all members of the DEC, not less than seven days prior to the DEC meeting. Voting shall be by roll call on all resolutions in the following order: District Commanders, department Vice Commander, department Finance Officer, junior Past Department Commander and national executive committeeman. The Department Commander shall vote only in the case of a tie. Members of the DEC should submit their reports in writing and reports shall be limited to five minutes and a copy of the same be given to the department administrative assistant.

All chairmen of department standing Commissions and committees shall submit their reports in writing. All reports must be originated by a voting member of the DEC. All codes and procedures shall be submitted in writing to members of the DEC at least 15 days prior to the date of the fall DEC meeting. These standing rules may be suspended for a specific cause by a two thirds affirmative vote of the DEC members present. The advanced time notices are waved for the Post convention DEC. Any time a poll is needed, the Department Adjutant shall send out a letter of explanation with a ballot to be returned within five working days. Again, I apologize for grabbing the wrong form.

## Charles Schmidt:

Commander, members of the DEC, I believe this resolution is very appropriate. Jim Willis was a legacy in many, many ways, from his civilian life to his American Legion service. It summed up the spirit of our endeavors.

Whereas; alternative measures to public safety, national security, freedom of religion and speech, freedom of elections, education and other values are being injected to weaken our nation's inner structure. And now,

Therefore; be it resolved by the 102nd Convention of The American Legion Department of Oregon meeting assembled in Canyonville Oregon on June 24th through the 26th, 2021, that The American Legion has storied history and formulated positions to support the Constitution of the United States and The American Legion. And,

Be it further resolved; that the soul of The American Legion voice echo across the grassroots of America and our commitment to each individual phase in our Constitution's Preamble, America to here. And

Be it further resolved; that [inaudible 00:02:25] to America's of its perpetual commitment to the congressional change in upholding and defending the Constitution of the United States and The American Legion's longstanding commitment to promote and perpetuate 100% Americanism. And

Be it finally resolved; there upon acceptable vote at The American Legion Department of Oregon Convention, June 24th through the 25th, 2021, at Seven Feathers Resort in Canyonville, Oregon.

This Resolution be forwarded to the national organization to be presented at the 2021 National Convention to be held in Phoenix, Arizona.

Steve Adams:

Gene Hellickson:

These resolutions are convention resolutions, and should be read at the convention.

Lou Neubecker:

I need to do a report and to recording of those.

Gene Hellickson;

All right. These are being presented as a result of the report. The actual reading of these resolutions will take place during the convention. So right now they're just being read to show what the committee came up with. And that's basically it. It's just for information right now.

Lou Neubecker:

Okay. That was the first one. Then on the second one, which is number C, for violation of oath convention,

Whereas; one of the purposes of The American Legion was congressionally chartered- [crosstalk 00:53:02] ... on September 16th, 1919. Was to uphold and defend the Constitution of the United States of America, which has not changed in a hundred and two years. And

Whereas; one of the valued principles of The American Legion's mission, American values and patriotism meeting that The American Legion advocates for upholding and defending the United States Constitution. And

Whereas; The American Legion members having served in America's armed forces as Officers and non-Commissioned Officers have taken an oath to defend the Constitution to the United States of America against all enemies, foreign and domestic, an oath that has been taken since 1775 with some revisions.

#### And

Whereas; certain documents, such as, DOD Directive 1344.10, and the Hatch Act of 1939, revised in 1993, direct the military to maintain non-partisan positions regarding politics. And

Whereas; according to established open source documents, statements of partisan or political nature were made by high ranking military officials and nonCommissioned officials, a clear violation of their oath of office DOD Directive, 1344.10 and the Hatch Act of 1939.

Whereas; the Department of Defense conducted stand downs for the possible purpose of indoctrination of partisan political nature, distracting focus from America's national security interest around the world. Now,

Therefore be it resolved; by the 102<sup>nd</sup> Convention of The American Legion Department of Oregon meeting assembled in Canyonville, Oregon on June 24th through 25th, 2021, that the largest veteran service organization, The American Legion publicly expresses its concern for the above mentioned events and speak out in defense of our oath of allegiance. And

Further it be resolved; that The American Legion encourages Departments to be vigilant of the violations of the partisan political nature by any person or organization under the aspects of the DOD 1344.10 or the Hatch Act of 1934, and inform their elected official when they are heard. And

Further it be resolved; that the American Legion use multimedia resources to affirm an advocate to America, there's perpetual commitment to the congressional change in upholding and defending the Constitution of the United States of America and The American Legion's longstanding commitment to its four pillars, [inaudible 00:56:17], National Security position, and Promotion of American Values and Patriotism. And

Be it finally resolved; that upon acceptance vote at The American Legion Department of Oregon Convention on June 25th, 2021 at Seven Feathers Resort in Canyonville, Oregon, this resolution be forwarded to the national organization to be presented at The American Legion 2021 National Convention to be held in Phoenix, Arizona.

Ed does that cover everything that you were talking about at the La Pine DEC [inaudible 00:57:00]?

Steve Adams:

The legislative Commission report? John Lee.

John Lee:

So most of my report is in the Book of Reports. It's just one thing that I'd like to add. Senate bill 319, which gives part of the Capitol grounds for a Vietnam War Memorial was hung up in committee. However, due to the letters that were written by veterans, that came out of committee two days ago and last night at six o'clock, it did pass. So it's on its way to the government secretaries.

Grassroots movements do work. I want to thank everybody that did send letters to the committee. I'd sent that out, I know Flynn had sent that for me to get those letters out to that committee chairman, chairwoman and her two Vices. And within one day it apparently made a difference because it did come out. So anyway, that did move forward. And so I do have a copy of the bills, that veteran bills, if anybody wants them, I'll have them in the back and I hand them out.

If you have any questions later, you're more than welcome to come to me. I don't want to try to answer questions now when it comes to legislation, be it come lengthy conversations. So we'll keep it short. Thank you.

#### **Kevin Owens:**

Therefore, be it Resolved; That the American Legion Department of Oregon and Santiam Post 51 does mourn the passing of our comrade, Jim Willis, That we commend to all the works of the American Legion and to God the spirit he had for community, state, and nation; and

Be it further Resolved; That in token of our common grief, a copy of this resolution transferring Jim Willis to Post Everlasting, the American Legion, be presented to the family and is signed Steve Adams, Department Commander, and S.Flynn Phillips, Department Adjutant. And as a member of the DEC, I move to approve the resolution.

Jerry Patton:

Steve Adams:

Thank you, Jerry.

Steve Adams:

Steve Adams:

As a motion to approve the resolution for Jim and second it, any discussion?

Here... Judge Advocate Gene Hellickson.

Gene Hellickson:

Commander, I would just recommend that we read this motion also at the convention.

Steve Adams: This resolution will be read when the convention opens, Gene. At the convention. We have a motion, it's seconded. Any more discussion? All in favor, say aye. Group: Aye. Steve Adams: Those opposed? Motion carried. For the good of the order. Renee Ohler: We're honored to have our National Commander coming to visit the American Legion Department of Oregon next week. I would like to make a motion that we present National Commander Oxford with a check for the Veterans and Children Foundation in the amount of \$5,000. Lou Neubecker: Commander Lou Neubecker, District 1. I'll second that motion. Steve Adams: A motion has been made and seconded to present Commander Oxford, when he's here next week, National Commander Oxford, with a check for \$5,000 for Children and Youth... For Veterans and Children. Steve Adams: Oh, for Veterans and Youth, excuse me. Any discussion? **Kevin Owens:** 

Commander, Kevin Owens, Chairman of the Permanent Finance. We had a discussion. We had a vote. Four out of the people responded to the vote, and then we had a... So it was a positive vote. Three yes, one who wanted to change, but we went with the \$5,000. It's not in the scheme of the budget, but we

have a Permanent Finance Fund that has money in that, so the money would come out of our fund that we hold and reserve for instances like this.

So I think a lot of people are not aware of the VCF Fund and I would like to allow privilege of the floor to past National Commander Charlie Schmidt, just for clarification of why we are doing this, if that's all right with you.

#### Steve Adams:

I'm in favor of that, Kevin. Past National Commander Charlie Schmidt has the floor.

#### Charlie Schmidt:

Commander, members of the DEC: So there were boys in Paris, France, in 1919 getting ready to come home, and their number one concern was "Who's going to take care of the boys when they come home?" And also, equally important is, "Who's going to take care of their families," because some of the boys would never go home. And of course, as they came home, they started lobbying of, "Who's going to take care of the boys? Because at that time there was no VA, there were no Service Officers. And as time goes on, "Who's going to take care of the families?"

In 1925, National Commander James Drain raised \$5 million. And in 1925, \$5 million was a lot of money. But that was to take care of the dependents of those boys that wouldn't be coming home. In the meantime, they were still jockeying for legislation to do something for the troops. Eventually, the Temporary Financial Assistance came into being one of the American Legion programs. And the Temporary Financial Assistance is to take care of a family on hard times, but the qualifier for those cash free grants is children. Children that hopefully won't have to worry about a roof over their head for a period of time, won't have to worry about food on the table, won't have to worry about maybe some emergency medical care, and certainly won't have to worry about food. And that is helping a family. And how does the veteran fit into that?

I know the American Legion, every department, even in our own department, we have two Department Service Officers - and I might add, we've got two of the best in the American Legion - but those Service Officers are required to be trained every year. And the American Legion, to accredit those Service Officers, offers training twice a year. One time it's in Washington, DC, and the other time it's at our national headquarters. Service Officers, who will take care and help a veteran with their needs. A Service Officer is a veteran's best friend, because those Service Officers are trained, current training, to stay abreast with all the changes, all the laws, and all of the mandates that VA puts on them. So they can take care of you and me and our buddies. So, they were two separate programs, and now they've been consolidated into the Veterans and Children Foundation.

\$5 million today really isn't very much, but our goal in the American Legion, throughout the American Legion, is now five times that. \$25 million. And until we reach the \$25 million, so we can invest that money and not have to worry about where it's going to come from, to take care of veterans and

take care of their children, every National Commander's goal is going to be... Their program is going to be Veteran and Children Foundation. In 2016, the National Commander's goal was to raise \$1 million to keep our Service Officers trained, to raise \$1 million so the children will always be taken care of. And it just so happens, the 2017-2018 National Commander carried that goal on, and now it has become a priority in the American Legion, again, to take care of our veterans and take care of their families.

And by the way, this is not a gift directly to Commander Oxford. It's a donation, one of the many donations from, including hopefully us, and a lot of departments and other fundraisers, to get that money set aside, so we won't have to worry about it, and maybe we... Luckily, we might be able to live

off of some of the interest, as well, to take care of veterans and take care of their children. Commander
and I, and We have the Marketing Director here, and I think he might be talking about something like
that tomorrow. We might hear something about that. But this is who we are. We take care of our
buddies and we take care of our families. And that's what the Veterans and Children Foundation does.
Steve Adams:

Rob Liebenow:

Thank you, Charlie.

Commander, the privilege of the floor [phonetic 01:22:00]

Rob Liebenow:

That's all we're trying to do. Just clarify that, and it's a great fund, and I can tell you that Oregon receives far more money from National and TFAs and emergency fund than we ever give. So just remember, we're trying to do our part as members, and the big scheme of the picture there. So thank you, Commander.
