Summary - Activities of Department 2nd Vice Commander

Report – The post-covid-19 era is now impacted by covid-variants; however, from post and district visits I have made, there is an evident resiliency of our veterans and Legion Family, as members press on and move forward. Our membership, in general, appears to be reconnecting, though cautiously and methodically, with "new normal" routine activities at the post- and district-levels.

Our Department will only be as successful as our membership will allow us to be. It takes all of us, at all levels, to make a difference in delivering our programs and helping recruit and retain membership. Thus, my continued sense, that increasing our visibility continues to be a critical role in our recovery from covid-driven shutdowns and into our future. It's not just about being seen, rather demonstrating leadership, and having a little fun while doing it. It's through volunteering that helps deliver programs; writing articles for the Oregon Legionnaire; and, overarching, in our ability to accomplish our mission – delivering on our four pillars.

This quarter I was able to attend district meetings for District 3 in Springfield, and District 4 in Grants Pass. Additionally, I have been able to visit eight different posts for various functions, from formal events to post activities; and, some posts were visited multiple times, including for Auxiliary and Sons of the American Legion events. Seven articles were provided to the Oregon Legionnaire.

"Project Outreach," an effort I have coined and undertaken, initiated with a small start-up grant from The Oregon American Legion Foundation (TOALF). The intent is to develop a cost-effective outreach and marketing piece, which can further our efforts on a number of vital objectives – Buddy Checks, membership engagement, community outreach, recruiting, TOALF donations, veteran suicide prevention and more. 6,000 bracelets are being made initially, 3,000 packs of two each, targeting our effort to leave no veteran behind and to increase veteran suicide prevention awareness. Donations received to date have already exceeded the start-up grant. Please ask me how you can help.

Leading candidate PNVC Jim Troiola's visit was very successful, and he appreciated and enjoyed all aspects of it; I was able to participate from

Wednesday evening dinner through Friday. From honoring our veterans at Korean and Vietnam Memorials and Willamette National Cemetery, to the Veterans Village in Clackamas County. Perhaps most, though, he commented that he really enjoyed the post visits and meeting our veterans.

Work continues on how Department of Oregon can further expand its outreach, within the veteran community as well as throughout the state. As an example, I was able to engage the Portland Winterhawks who reciprocated by posting a PSA: *"The American Legion thanks you for your service to our country and in your communities."* during their Hometown Heroes event in December. Additionally, efforts are underway in assessing potential for our participation in the Rose Festival's Rose Parade and CityFair at Tom McCall Waterpark. Both would garner significant visibility to Department of Oregon, along with our efforts to increase veteran suicide prevention awareness as well as increase our membership.

'Honor those who came before us' is one of our six value principles. In that spirit I attended the State of Oregon's Veterans Day Ceremony, conducted on the State Capitol grounds on Nov 10th. Surprisingly, there were only two in attendance wearing a Legion cover. A state legislator, who was one of 7-8 speakers, and me. While it isn't practical to expect just department officers to be present, we could have been much better represented; perhaps next year we have a table to increase outreach. On Veterans Day I provided the keynote at T. Les Galloway #68's ceremony and dinner, which was a fabulous event with a 125+ in attendance. And, I registered a Wreaths Across America (WAA) volunteer group, on behalf of our Department headquarters' office staff, as a means of demonstrating that same principle and in working together, to lay wreaths upon graves at Willamette National Cemetery.

Lastly, I supported Senate Bill 544, among other pending legislation, using the Legislative Action Center (LAC) at Legion.org; S.544 calls for the VA to create a National Buddy Check Week, among other supportive actions. The LAC utility is an easy, and powerful, way for each member to strengthen the voice – *our voice* – of The American Legion and I encourage others to explore the utility and make use of it.

Challenges – Many challenges lay before us; however, I feel the following are significant and needing immediate attention:

- Filling commission/committee vacancies;
- Curbing membership loss due to non-renewal; and,
- Increasing article submissions to improve the quality of the Oregon Legionnaire

the event for sure, and possibly we get a battery operated loud speaker for the event speakers as no one could hear them speak.

We are presently preparing for Jim Higuera the National Vice Commander to visit the Department right before the DEC, and he will make a presentation on Saturday, January 8th. His focus will be visiting Posts in the District 7 area.

The Fall DEC was well attended in spite of being all masked up for covid.

BOOK OF REPORTS for January 2022 DEC FOR

I am repeating this paragraph as it is important. We started our new Budget Year on October 1, 2021. Our Budget and Tax year is October 1, 2021-September 30, 2022. The Budget for 2021-2022 which was approved at our Department Convention provides a budget for our programs, our officers, our district commanders; all of which have responsibilities to perform in their office or function. We revisit the budget monthly as the budget is put together with all information that we have available, COVID did not help in our assumptions. We have processes for when items that are budgeted or that are our duties are not performed that we must reduce the budget line for that function. As our new budget started on October 1, 2021, I have reviewed the Oregon Legionnaire for October and November and December 2021, now January 2022, this month and am alarmed at the number of district commanders and chairs that have not submitted articles for the Legionnaire. I would like to congratulate and thank District 1 Commander Lou Neubecker who always provides a Legionnaire Article of the activity in his district and messages to his members. That is the purpose of placing articles in the Legionnaire. For the Months of October, November, and December 2021 we will be reducing the budget line on those required to write articles in the Oregon Legionnaire that have not submitted articles. District Commanders, Chairs, this is your means of communicating to your Districts and Chairs, information about your programs and what is going on in your programs. Also, all Officers, District Commanders, Chairs, will be holding our Department Budget Meeting in February, you are required to submit your budget requests for

your function, if not submitting Legionnaire Articles and Book of Reports, do you need a budget if nothing is going on? There is a lot going on in this Department.

As I asked all the District Commanders during our Fall DEC, when making their Post visitations and Post assessment, to verify that their Posts have filed their 990 Taxes. If the Post has not filed in three years, the IRS will revoke their EIN numbers and they will lose their 501 c19 status. This is part of the District Commanders' assessment of each Post in their District. If not doing your assessments, your budget line will be reduced.

We took a lower membership quota for income for our 2021-2022 Budget year. As I reviewed our membership numbers in December, we are behind our membership at the same time last year. We cannot continue to reduce our membership; we are holding our 2022-2023 Budget meeting in February; we will have to make some serious decisions on which direction to go which will be presented to the DEC in our spring meeting. Lower membership will mean reducing expenses in our other operations, our programs. Membership is the lifeblood of our organization. We have found that making Buddy Checks which is doing the right thing for our members is providing positive outcomes in renewing our members. We have other income, but membership supports our programs, supports our ability to support legislature on Veterans issues, supporting Veterans and their families and caregivers.

Remember the Oregon American Legion Foundation is a 501©3, contributions are tax deductible, funds are used for our programs. There is a lot of information and grant requests on our Web Site. Let's have a great year, face to face when safe, we have plenty of opportunities for a great year.

The following is the Judge Advocates report for the period following the Fall DEC. There are several issues that (**still**) need to be resolved and action taken as listed below.

- Request for copies of Department Resolutions has shown that there does not seem to be a logical or controlled method in use to control, track or store resolutions at Department Headquarters. <u>No change as of December</u> <u>2021. Additionally, missing Department Resolutions have not either been</u> <u>found or forwarded to Judge Advocate if they have been found.</u>
- 2. One Constitution and By-Laws or "no-change" review has been received since the Fall DEC. A standard form has been developed to show review by the Department Judge Advocate on submitted Constitution/By-laws and/or "no-change." The form is kept on file at Department Headquarters with the other required post documents. *However, there are still posts that have not submitted either Constitution and By-Law changes or Department form showing review with no changes needed.*
- 3. It is the recommendation of the Judge Advocate, that the Internal Affairs Committee be tasked in writing as to what their specific duties entail. Items such as a yearly review of required post documents on file, resolution,

accountability and storage procedure, and reviewing of the Department Adjutant's responsibility for review and action on Headquarters' policies that are under their requirement to review. Examples: Policy 20-04-020 Book of Reports; Policy 20-04-021 The Legionnaire Newsletter; 16-09-001 Conference Calls (Go to Meeting); Policy 16-09-004 Document Retention; Policy 16-09-005 Equipment Inventory Checkout and Usage; Policy 16-09-011 Op-007 Official Department of Oregon Vehicles(s); Policy 16-09-011 Rental of American Legion Facilities. *No action as of December 2021.*

- 4. Merger of Districts and Posts are not following the instructions of The Department of Oregon By-laws Annex "B." <u>Recommend that</u> <u>Department, Internal Affairs, Districts and Posts, keep the Department</u> <u>Judge Advocate up-to-date on these actions. Failure to do so delays</u> <u>proceedings until the Judge Advocate has the opportunity to review</u> <u>information concerning these actions.</u>
- 5. One item of interest is Post officers contacting the Judge Advocate, asking for advice on an issue regarding their post. When asked where I found the answer given them, they were informed that it was in their own Constitution and By-laws. *Apparently, it's easier to ask the Judge Advocate than read their own Constitution and By-laws.*
- 6. Department is still not forwarding information to the Judge Advocate. This causes delay when the Judge Advocate, Internal Affairs Chairman or others, have to forward the information to the Judge Advocate. <u>Recommend that the Administrative and Advisory committee, that has oversight of the Adjutant and Headquarters, ensure that all pertinent material be forwarded to the Judge Advocate in a professional and timely manner.</u>
- 7. <u>Recommend that the Department of Oregon look into forming a</u> permanent Internal Affairs "Committee." This committee would allow all Department of Oregon members to know who is on this committee and avoid the supposed accusation of a "cherry-picked" ad-hoc team to resolve issues as "certain members" desire what the outcome is to be. This suggestion has been brought up in the past, but there has not been any action to discuss, or bring before the DEC.

Roberts Rules of Order:

The other type of committee is a special committee, also called a select or ad-hoc committee. This committee is created to perform a special task and is dissolved

when the task is completed, and the final report is given. <u>The membership should</u> not create a special committee to do something that is within the designated function of a **standing committee**.

DEPARTMENT SERVICE OFFICER

This past year has been challenging to say the least. We have seen an uptick in veterans that contact The American Legion because their County Service Officer or other fraternal organization is not working or is understaffed.

COVID-19 restrictions on employers and defining "essential" workers have created a longer wait period on initial claims. Many of the initial/ new claims this office has filed since the winter of 2019 are just starting to be adjudicated. There is a lengthy delay for the VA to gain access to veterans' service records. Other claims from veterans with service records on file have been delayed due to the inability to schedule exams because of COVID-19 precautions or C&P exams requiring opinions or stuck in QA (quality assurance).

In August, the VA expanded the *Gulf War* presumptive conditions for service connection based on exposure to fine, particulate matter and the manifestation of *chronic asthma*, *rhinitis*, and *sinusitis*, to include rhinosinusitis. The new rules extend deployment qualification beyond Southwest Asia to include Afghanistan, Syria, Djibouti, and Uzbekistan; it includes eligible conditions that manifest to 0% non-compensable; applies a 10-year manifestation period after separation from service, which is a maximum time frame of manifestation supported by scientific research; eliminates minimum time frame required for the length of deployment; and does not require a specific level or dose of exposure to particulate matter.

The VA has implemented a new survey, VSignals, that gathers feedback from Veterans, eligible dependents, caregivers, and survivors in real time. VSignals provides Veterans with the opportunity to send VA feedback on what works well or needs to be improved, categorized by claim type. VA is asking all partners to encourage veterans to respond to these surveys. The top categories of survey responses have centered on Notification and Communication.

The addition of three presumptive conditions due to herbicide exposure (Agent Orange): bladder cancer, hypothyroidism, and Parkinsonism's, triggered a Nehmer review of all previously denied claims for these issues. *Nehmer v. U.S. Department of Veterans Affairs was a class action lawsuit that resulted in requiring the* VA, whenever it recognizes that the emerging scientific evidence shows that a positive relationship exists between Agent Orange exposure and a new disease, to (a) identify all claims based on the newly recognized disease that were previously denied and then (b) pay disability and death benefits to these claimants, retroactive to the initial date of claim. We encourage you to reach out to the Service Office if you have been denied for one of these conditions and we can check on the status of your review. In addition, please spread the word to surviving spouses you know that may be able to qualify for Death Indemnity Compensation (DIC) and have them contact us.

The *Nehmer* decision is also what triggered the Blue Water Navy (BWN) claim reviews. Unfortunately, the VA has routed these claims through a new division and that is creating a whole new backlog of claims.

We reported at the convention that virtual Board of Veteran Appeals hearings is now up and running. We have completed two since the convention and have twelve scheduled through the end of December. This is about the same number completed in the 2020-2021 membership year.

Recently, we received a call from a female veteran who voiced her anger, frustration, and dissatisfaction with her new primary care physician at the VA, a transgender woman...defined by Merriam Webster as: *a woman who was identified as male at birth*. Note, the doctor is assigned to the *Women's Clinic*. We can only assume that this is not an isolated incident. It appears to be based in part on a presentation to the VA Center for Women Veterans (CWV) Partners, dated May 5, 2021, by Harvey Johnson, Deputy Assistant Secretary. This presentation indicates it is ORMDI's Road to the Future (Office of Resolution Management, Diversity, and Inclusion. The presentation speaks to equality ("fair" is not everyone getting the same thing) vs. equity ("fair" is everyone getting what they need) and diversity and inclusion at the VA for staff leadership in terms of equal employment opportunities (EEO).

Between May 15 and September 15, the Department Service Office has assisted numerous veterans and their families with VA Benefits and other services. Due to COVID-19, this has been done primarily by phone. All toll we have brought on 70 new clients, represented veterans at virtual VBA hearings, filed nearly 46 new claims (for veterans and surviving spouses), and 11 lower supplemental claims or higher-level reviews.

The sense of fulfilling our obligation and ability to serve veterans and their families is immensely humbling. Here are some highlights.

Veteran A: This veteran went before the Veterans Board of Appeals (VBA) in December of 2020 after working through the lower appeals process since 2014. The initial rating, February 2014, was 50 percent. In 2018, after a review of the case, the Regional Office granted a disability rating of 70 percent. The veteran contended that their service-connected PTSD symptoms warranted a higher disability rating during the period on appeal. Just last month, the veteran was notified that his appeal was granted and was awarded \$28,000, the difference between 50 and 70 percent for the period from February 2014 and October 2018. This veteran's win was a direct result of his commitment to what he knew was correct, and the execution of meeting each deadline in keeping his claim open.

Veteran B: This veteran went before the BVA in November of 2020 from his appeal of an October 2013 decision in which he was denied for service-connected tinnitus and hearing loss because they missed the C&P exam. The delay stems from the veteran's frequent moves within Florida, where the claim originated and notices not received. Upon notification, we reached out to the veteran, and he was thrilled to have representation in Oregon. The BVA granted the tinnitus and remanded (sent back to Regional Office for further development) the claim for hearing loss. This veteran received a Combat Action Badge while in IRAQ after being within five meters of an IED explosion, comprised of two, five-gallon fuel canisters with an artillery shell of unknown size. While the hearing loss claim is being developed, the veteran was awarded \$23,000 for the tinnitus evaluation effective February 25, 2013.

We continue to work with veterans: advocating for their benefits from the VA and aiding as needed. Please contact either one of us to assist you in filing an initial claim and or keeping your appeal/ review current!

The principal activity of the Youth Shooting Sports Committee is the support of the American Legion National Junior Three-Position Air Rifle Tournament. Both the First Round Qualifier competition and the Second Round Qualifier competition are "postal tournaments" (in which the official competition target sets are ordered via United States Postal Service mail, the targets shot at a local shooting range, and the shot targets mailed to the Tournament Director via United States Postal Service Mail).

For the 2020-2021 American Legion Junior Three-Position Air Rifle Tournament, the official competition target sets for the Preliminary Round/State Championship Tournament were required to be ordered from the Civilian Marksmanship Program in Port Clinton, Ohio by Tuesday, December 15th, 2020.

The shot official competition target sets for the Preliminary Round/State Championship Tournament were required to be mailed to the Civilian Marksmanship Program with a postmark no later than Monday, February 1st, 2021.

Largely because of the COVID-19 Corona Virus Pandemic, youth shooting sports programs have been severely limited in 2020-2021, and again in 2021-2022, as compared to previous years. There were only five competitors in the Sporter Air Rifle Category and no competitors in the Precision Air Rifle Category for 2020-2021.

For the 2021-2022 American Legion Junior Three-Position Air Rifle Tournament, the official competition target sets for the Preliminary Round/State Championship Tournament were required to be ordered from the Civilian Marksmanship Program in Port Clinton, Ohio by Wednesday, December 15th, 2021.

Internal Affairs was also directed to look into Post 73 Maupin's desire to donate the Post building to the City of Maupin. The Department Constitution And Bylaws only cover the sale of the real property and do not cover donation of such. I asked Judge Advocate Gene Hellickson to review this and to contact National for their opinion. Gene received an email from National legal stating they probably can donate to the city depending on state laws and Dept. Const.& Bylaws. The city has been leasing the building from the Post since 2008 and has put over \$300,000 in building upkeep and repairs. Both parties want to terminate the lease agreement and pursue with the donation at a meeting held on December 17th Gene Hellickson and Lance Trowbridge District 5 Commander attended the meeting.

Internal Affairs will have a go to meeting on January 5th.

Attended (virtually) the House Veteran and Emergency Management committee meeting on November 16th at 8:00 AM. They discussed a possible problem around veteran plates. It is confusing and may need a change in the cost. Currently, it appears that for "Veteran Support" plated, available to anyone, the cost is \$20.00 but is \$40.00 for "Disabled Veteran" plates. There will be further investigations and may be addressed during the 2022 session.

Also attended (virtually) the Senate Veteran and Emergency Preparedness Committee meeting on November 16Th at 11:00 AM. Their primary concerns for the 2022 session are mostly around veteran mental health and rural transportation. It was stated that currently there are 17 veteran suicides a day US wide. In Oregon 1 in every 6 suicides is a veteran. This is a rate of 16.6% while veterans make up only 6% of the population. The committee is looking at outreach programs for veterans returning from Afghanistan. "You Are Not Alone"

There have been two special sessions for 2021. The first had legislation for redistricting the US Congressional districts. After the US census, Oregon gained a Congress representative, an increase from 5 to 6. Also, the Oregon legislative districts for both the Senate and the House were redistricts. Although the State courts upheld the redistricting there may be other filings. Attached it the current maps as it stands now. The first special session ended on September 27th

The second Special session appropriates money for Housing of homeless and rent protection. Also, appropriates money and legislation around illegal marijuana issue arising in Oregon. The second special session ended on December 13th.

The employment portion were for VA SORCC

Jobs with critical shortages, each position advertised was held in a different area, two check-in points outside before entry into a separate building with HR reviewing each applicant prior to an escort accompanying the applicant to each interview area, yes it was fogging and cold outside and we transported applicants to some of the areas. We had our partners DVOP's and Easter Seals working with Veterans that needed help with their Resumes or USA Jobs along with County Service Officers assisting Veterans with questions or requiring claims help and representatives from Southern Oregon University (SOU) and Rogue Community College (RCC) providing help with information on education programs. We also had our Veterans Homeless Program present for any assistance or questions. All our partners participated.
