Summary – Activities of Department 2nd Vice Commander

Report – Continued efforts were made to further increase our visibility amongst our peers – all veterans – as well as the public in conducting outreach and engagement opportunities. Increasing our visibility will further increase our viability and, with intention, help to increase membership, as well as, gain support from other groups, be they veteran-related or the general public.

Engagement with the Rose Festival Foundation was made to explore opportunities which could be leveraged to further increase visibility of American Legion, Oregonian veterans, and one of our top priorities, veteran suicide prevention. Specifically, desired was the opportunity to participate in the Rose Festival Parade with the #48 NTT IndyCar, along with a display booth at City Fair to engage veterans and the public. Numerous meetings and email discussions were held with Kara Landen, executive assistant & sponsor relations, and Jeff Curtis, chief executive officer of Rose Festival Foundation, along department representatives Charlie Schmidt, public relations chairman, Kevin Owens, TOALF president, and myself. Additional contacts with National Headquarters were made by Chairman Schmidt to engage Dean Kessel, chief marketing officer, and Mary Jo Dial, marketing commission executive, on potential for accessing the #48 NTT IndyCar and/or a Chip Ganassi Racing Team driver. CEO Jeff Curtis and staff developed a tailored marketing package for Department of Oregon that included multiple platform exposures. This included options for entries in both Rose Festival parades, to fleet week, to multiple display booth options, web-based visibility, and more. In the end, while both parties could agree there was mutual benefits available, ultimately, Rose Festival Foundation is a non-profit organization and could not accommodate a no-cost or very low-cost option to us. Opportunities for a future partnership do remain open.

I have also engaged Pacific Outdoor Advertising to explore opportunities available in digital billboard displays. Digital billboards provide an attractive and highly valuable marketing opportunity. While not as prevalent across the landscape as static billboards, digital billboards within the metro area and along the I-5 corridor south to Salem provides millions of engagements with commuters on a weekly basis. Public Service Announcements (PSA) may be available, but work continues on that as an option. Work continues to determine the potential for smaller, shorter targeted effort and period of time, such as 1-2 weeks during a Buddy Check week or around Veterans Day.

Similar lines of outreach include contacts already been made with the Eugene Emeralds and the Hillsboro Hops; both teams are Class High-A, which came about in the last two years with Major League Baseball's (MLB) reorganization of the minor league system. There are only 30 Class High-A teams in the U.S. and Oregon has two of them.

Also, pending contacts include Portland Timbers (MLS), Portland Trail Blazers (NBA), Portland Winterhawks (WHL), and the Oregon State Fair. This is not to exclude all other opportunities, rather for Department to gain access to those organizations that have a very large visibility basis.

Districts and posts should seek similar engagements within their local and regional areas to further explore and conduct outreach opportunities. Outreach creates opportunities to support veterans through sharing what American Legion pillars and our programs can do – positively engage veterans for membership recruitment; etc.

This quarter I attended two district meetings for District 5 at Ray Johnson #44-Redmond and Crook Co. #29-Prineville, along with yet another trip to honor and remember S.A.L. Past-NEC Willie Williams at his memorial service, also at Crook Co. #29-Prineville. In addition to District 5, I attended post, district, and/or department meetings and events in Districts 1, 2, 3, and 8. Among activities were two district oratorical contests and the department oratorical contest; a Four Chaplains Ceremony; and, other private events.

Six articles were submitted to the Oregon Legionnaire covering VA&R benefits and TOALF topics in addition to the monthly department 2nd vice commander updates.

I sat in on the quarterly ODVA Advisory Committee Meeting and heard updates from committee members around the state. Please review the report by accessing it at: https://issuu.com/odva/docs/march_ac_report_2022

While the Washington Conference was virtual again this year, there was no shortage of good information put forth from the National Legislative Commission, National Security Commission, and the VA&R Commission's meetings, of which I took in portions of each of them live via live-streaming. NATIONAL EXECUTIVE COMMITTEE OF THE AMERICAN LEGION 2022

Resolution No. 1: Statement on Ukraine Origin: Register Resolution No. 2816 (NC) Department Executive Committee Submitted By: National Security Commission

WHEREAS, The American Legion believes in a rules-based international order where the territorial boundaries of any sovereign nation should not be changed by force; and

WHEREAS The North Atlantic Treaty Organization (NATO) is an essential element of U.S. national security in an increasingly multi-polar world where rising powers have become increasingly adversarial and have committed to work together to revise the rules-based international order; and

WHEREAS, After the end of the Cold War, the United States and NATO created a European security architecture that gave no role to Russia; and

WHEREAS Article 5 is an essential element of the NATO alliance and should be upheld, but this mutual defense clause does not extend to non-member states; and

WHEREAS The U.S. should thoroughly exhaust all diplomatic and economic tools at its disposal before utilizing military force; and

WHEREAS The U.S. Constitution grants Congress the sole power to declare war; and

WHEREAS, The National Security Commission met on February 25, 2022, at 2:00 p.m., and this resolution has the approval of the National Security Commission; now, therefore, be it

RESOLVED, By the National Executive Committee of The American Legion by a vote pursuant to Rule 12 of the Rules of the National Executive Committee, That The American Legion support a peaceful conflict resolution in Ukraine, in conjunction with the North Atlantic Treaty Organization (NATO) and the Russian Federation; and supports a European security architecture that takes into account the national security interests of all parties; and be it further

RESOLVED, That The American Legion does not support the deployment of troops for combat operations in defense of non-NATO member countries in connection with the ongoing Ukraine-Russia conflict but urges the administration to continue the supply of lethal and non-lethal aid to Ukrainian forces; and be it further

RESOLVED, That the administration and U.S. Congress maintain a strong stance and resist any agreement that could undermine the strategic rationale for the normalization of agreements between NATO, Russia, and Ukraine; and be it further

RESOLVED, That U.S. service members should not be deployed in support of combat operations in any theater unless four conditions have been fulfilled:

- 1. That there will be a clear statement by the president of why it is in our vital national interests to be engaged in a particular operation
- 2. Guidelines will be established for the mission, including a clear exit strategy
- 3. That Congress is consulted and authorizes the use of military force
- 4. That it be made clear U.S. forces will be commanded only by U.S. officers; and be it finally

RESOLVED, That The American Legion reaffirms its unwavering admiration of, and

support for, our American men and women serving in uniform throughout the world, and we reaffirm our efforts to provide sufficient national assets to ensure their well-being.

This report is for the Department Executive Committee (DEC) Meeting at Harney County Post #63. Has this membership year gone fast, in two and a half months we will meet for our Department Convention in Aloha? We met in February to work on the Proposed 2022-2023 Department Budget. We are presenting the outcomes at this DEC and if required make recommended changes. After this DEC we will publish the proposed budget in the May edition of our Oregon Legionnaire as is required by our Constitution and By-Laws and then the proposed budget will be presented to the Finance Convention Committee at our Department Convention and the Convention Committee will present their outcomes to the Convention Delegates on the floor of our Convention for discussion and acceptance.

Department completed our Tax reporting, and it has been submitted to the IRS. The 990 and 99ez and accompanying documents were reviewed by the DEC members prior to submitting to the IRS.

District Commanders and attendees, as your Post is holding your Post Elections, remember to vote for your Post Delegates and Alternates to attend your District Caucus and Department Convention. Department will send out Post Delegate Forms and new Officer Forms. Post Delegate Forms must be completed and sent to Department 45 days before the Department Convention with the completed Delegate Forms and \$15.00 for each Delegate and Alternate Delegate. When you receive your delegate forms, they will include a table indicating your authorized delegate strength for your Post membership. At your District Caucus you will vote on your District Officers and Delegates for our National Convention. Those forms with your new District Officers and National Delegates need to be sent to Department once your election is completed. Along with the District Forms, any

new officers and delegates that do not have their DD214 on file at Department; a copy must be sent to Department with the District Forms. All delegates attending the Department Convention must have their Post Delegate Forms with their Adjutant certification sent to Department.

District Commanders, yes, it is Tax Time, if your Post has a Tax Filing Period of January 1 through December 31, it is time to put your financial records together to file taxes if you haven't which are due for a 990, 990EZ or 990N by May 16, 2022. There are no exceptions. We, Department and Posts are under the National Umbrella and are under Group Exemption Number 0925, that is our 501c19. Remember, every Post is a separate corporation, it is a business, you operate under Corporate Laws of Oregon, you pay a filing fee each year to the Secretary of State, Corporation Division.

Remember the Oregon American Legion Foundation is a 501©3, contributions are tax deductible, funds are used for our programs. There is a lot of information and grant requests on our Web Site.

As there will be additional information that will be reported to the Spring DEC, I will verbally report the additional information as many changes that are taking place at this time.

The following is the Judge Advocates report for the period following the Mid-Winter DEC. There are several issues that (**still**) need to be resolved and action taken as listed below.

- 1. Request for copies of Department Resolutions has shown that there does not seem to be a logical or controlled method in use to control, track or store resolutions at Department Headquarters. No change as of March 2022. Additionally, missing Department Resolutions have not either been found or forwarded to Judge Advocate if they have been found.
- 2. Several Constitution and By-Laws or "no-change" review has been received since the Mid-Winter DEC. . <u>However, there are still posts that have not submitted either Constitution and By-Law changes or Department form showing review with no changes needed.</u>
- 3. It is the recommendation of the Judge Advocate, that the Internal Affairs Committee be tasked in writing as to what their specific duties entail <u>Some</u> action has been taken, however, there are still several that need reviewing and editing.
- 4. Merger of Districts and Posts are not following the instructions of The Department of Oregon By-laws Annex "B." Recommend that Department, Internal Affairs, Districts and Posts, keep the Department Judge Advocate up-to-date on these actions. Failure to do so delays proceedings until the Judge Advocate has the opportunity to review information concerning these actions.
- 5. Department is still not forwarding information to the Judge Advocate. This causes delay when the Judge Advocate, Internal Affairs Chairman or others, have to forward the information to the Judge Advocate. *While there*

- has been some improvement it is still recommended that the Administrative and Advisory committee, that has oversight of the Adjutant and Headquarters, ensure that all pertinent material be forwarded to the Judge Advocate in a professional and timely manner.
- 6. The Department of Corrections has performed an audit at Deer Ridge post 131 and Corrections has determined that Post 131 cannot have officers as they are incarcerated. I was instructed by the Department Commander to look into this issue. However, the Department Adjutant, and the District Commander have taken this matter into their own hands. Therefore, the Judge Advocate will not be involved in this issue.
- 7. As Judge Advocate, I have received several complaints and letters concerning problems with Post 99 and its SAL Squadron. The SAL appears to not be following requirements of the Department Constitution and Bylaws. *Until Post 99 takes some action, and an appeal is submitted to the Department, the Judge Advocate will not be involved.*
- 8. No action has been taken on the recommendation that the Department of Oregon look into forming a permanent Internal Affairs "Committee." This committee would allow all Department of Oregon members to know who is on this committee and avoid the supposed accusation of a "cherry-picked" ad-hoc team to resolve issues as "certain members" desire what the outcome is to be. *This suggestion has been brought up in the past, but there has not been any action to discuss, or bring before the DEC.*

Roberts Rules of Order:

The other type of committee is a special committee, also called a select or ad-hoc committee. This committee is created to perform a special task and is dissolved when the task is completed, and the final report given. The membership should not create a special committee to do something that is within the designated function of a standing committee.

We continue...

To see the delay of claims processing skyrocket. We have been advised that across the VBA (Benefits Administration) backlogs are starting to rise and they are trying to work as quickly as they can. The official word is, "VA has seen an increase in the number of claims pending and the length of time to process these claims due to pandemic-related issues and new legislation regarding presumptive conditions for military environmental exposures. VA has taken proactive steps to reduce the number of claims in our inventory by mitigating pandemic-related barriers, hiring additional claims processors, and utilizing funds for overtime. VA is committed to processing claims as quickly and accurately as possible."

To illustrate, Veteran 1, participated in a BVA hearing in the spring of 2019 on an appeal submitted in early summer of 2015. In the late summer of 2019, the BVA decision remanded several issues back to the Regional Office. Some two and half years later (945 days) the veteran is still waiting for the VA to receive information to substantiate the claim.

Veteran 2 filed an initial claim in the fall of 2019. This Navy Reservist was called to active duty 1968-1970 and for 4 months in 1991. In summer of 2020, a grant of hearing loss and tinnitus was completed, and all other issues have been deferred, also waiting for the VA to receive information to substantiate the claim...some two and half years later (943 days).

We continue...

To be baffled by the way in which the VA processes claims. As previously reported, *Nehmer v. U.S. Department of Veterans Affairs* was a class action lawsuit that resulted in requiring the VA, whenever it recognizes that the emerging scientific evidence shows that a positive relationship exists between Agent Orange exposure and a new disease, to (a) identify all claims based on the newly

recognized disease that were previously denied and then (b) pay disability and death benefits to these claimants, retroactive to the initial date of claim.

CFR § 3.816 provides awards under the Nehmer Court Orders for disability or death caused by a condition presumptively associated with herbicide exposure. To be considered a Nehmer class member (veteran eligible for this provision) you must be a Vietnam Veteran defined as "boots on the ground" in Vietnam or on a US vessel operating in the inland waterways, or on a US ship within 12 nautical miles of the shores.

Veteran 3 was denied service connection for bladder cancer in 2015. This prompted a Nehmer review of the claim, as mandated by the federal court. In mid-February 2021, the VA confirmed and continued the denial. In the decision, the VA stated that they conceded herbicide exposure based on service (1966-1969) in the Korean DMZ. VA went on to state that since the records indicate no evidence of in-country service within the Republic of Vietnam, further review under Nehmer is not required as it does not apply to other herbicide-exposed veterans. Prior to this review, this veteran was already granted service connection for diabetes mellitus and prostate cancer. All presumptive diseases of herbicide exposure.

It is unclear if members of the rating teams are restricted by procedures and environment to truly evaluate the best decision, are less skilled, new hires, overworked, or just doing the bare minimum. A conservative estimate of man hours to get this point is 750 - 1000.

The VA rater showed some empathy and contacted the veteran by phone to explain the situation prior to getting the decision in the mail. VA asked or "invited" the veteran to file a supplemental claim by mailing him a packet that included 30 pages - some 17 pages of explanation and instruction, in addition to three (3) blank forms depending on which type of claim he wanted to file. Without representation, this volume of information and paper, would likely result in the vet being so overwhelmed that the claim would stop there. It will be interesting to see how long it will take to process the supplemental claim that has been filed by this office.

We continue...

To be frustrated at inability of VA to adequately roll out an improved or expanded benefit. Case in point, the Comprehensive Assistance for Family

Caregivers (**PCAFC**) is a clinical program that focuses on the needs of participating Veterans (including qualifying Service members) and their Primary and/or Secondary Family Caregiver(s). In October 2020, the VA expanded this program to family caregivers of eligible Veterans who were seriously injured in the line of duty on or before May 7, 1975. Previously, this program was limited to on or after September 11, 2001. A veteran must have a VA disability rating (individual or combined) of 70% or higher and must need at least 6 months of continuous, in-person personal care services. The VA Fact Sheet on this program touts "Eligibility Decision Within 90 Days of Application Receipt."

This office has submitted ten applications for this program since October 2020. Not one received a decision within 90 days. Not one has been approved. Everyone that we have filed exceeds the stated requirements. Every denial indicates that there is no evidence of the need of at least 6 months of continuous, in-person personal care services. This includes the veteran in motorized wheelchair for years (VA provided) that has been determined by the VA to have loss, or permanent loss of use, of one or both feet and/ or one or both hands.

One serious issue is that PCAFC is administered by the Health (VHA) side of the VA. There is no way for a service officer to track the progress of these claims as we are restricted to the Benefit (VBA) side. The Power of Attorney a veteran sign with us (benefits) is not recognized by the VHA (healthcare). We have many questions...does the VHA have criteria similar to VBA for disability ratings...what is the process for a service officer to help, who do you call, how can you cross the HIPPA barrier?

Since October 2020, the VA failed to implement and notify veterans the ways in which to appeal Caregiver claims. It appears that VA recently recognized their error and have just announced various ways these denials can be appealed. Just like disability claims, a healthcare denial, such as eligibility, payment of services, etc., can be reviewed/ re-opened with a Supplemental Claim, a Higher Level Review.

Between September 16 and March 8, the Department Service Office has assisted numerous veterans and their family with VA Benefits and other services. During this period, we brought on 71 new clients, filed nearly 71 new claims (for veterans and surviving spouses), filed 20 lower supplemental claims or higher-level reviews, and represented 15 veterans at virtual VBA hearings. Between the writing of this report and the DEC, we will have conducted an additional two video hearings at the Regional Office and one virtual hearing.

The sense of fulfilling our obligation and ability to serve veterans and their families is immensely humbling. Here are some highlights.

Veteran A: This veteran went before the Veterans Board of Appeals (VBA) in September of 2021 after working through the lower appeals process since 2018. The VBA decision granted service connection for all five (5) issues on appeal, resulting in an increased combined rating from 60 to 90 percent.

Veteran B: This veteran came to this office in December 2020 after being denied on his most recent claim. At that time, the combined rating was 50%. After a review of the STR's (service treatment records) and many conversations to educate and inform the veteran of what was needed to re-open the claim, a supplemental claim was filed in March of 2021, and subsequently denied by mid-April. In May, a claim for Higher Level review was submitted. By early July, an informal conference was held in which it was pointed out that the buddy statement and medical opinions submitted in March are enough to warrant at least a new exam and opinion. Six months later, in early October, the VA granted service connection for one issue and deferred the other. The result, a combined rating of 80% (effective Sept 2019) and an award of \$15,000. A few weeks later the deferred issue was resolved and resulted in a favorable decision, bringing the combined rating to 90% (effective Apr 2020) with an additional \$10,000. A claim for increase in a specific condition was filed by this office in early February 2022, bringing this veteran to a combined rating of 100% and granting permanent and total status.

We continue to work with veterans: advocating for their benefits from the VA and aiding as needed. Please contact either one of us to assist you in filing an initial claim and or keeping your appeal/review current!

Report of the Chairman of the Youth Shooting Sports Committee

Department of Oregon, The American Legion Submitted on March 18th, 2022

The principal activity of the Youth Shooting Sports Committee is the support of the American Legion National Junior Three-Position Air Rifle Tournament. Both the First Round Qualifier competition and the Second Round Qualifier competition are "postal tournaments" (in which the official competition tournament target sets are ordered via United States Postal Service mail, the targets shot at a local shooting range, and the shot targets mailed to the Tournament Director via United States Postal Service Mail).

For the 2021-2022 American Legion Junior Three-Position Air Rifle Tournament, the official competition tournament *target sets* for the Preliminary Round/Oregon Championship Tournament were required to be *ordered* from the Civilian Marksmanship Program in Port Clinton, Ohio by Wednesday, *December 15th*, 2021.

The *shot* official competition tournament *target sets* for the Preliminary Round/Oregon Championship Tournament were required to be *mailed* to the Civilian Marksmanship Program with a post mark not later than Tuesday, *February 1st*, 2022.

All official tournament scores were ranked and posted on the Civilian Marksmanship Program web site by *February 15th*, 2022.

Largely because of the COVID-19 Corona Virus Pandemic, youth shooting sports programs have been severely limited in 2020-2021, and again in 2021-2022, as compared to previous years. There were 18 Oregon competitors in the Sporter Air Rifle Category, and no Oregon competitors in the Precision Air Rifle Category, for 2021-2022.

Lebanon High School Team 1 was ranked 6th nationally, and Team 2 was ranked 18th nationally, out of a total of 101 teams. Team 1 was among the top ten teams, and so is invited to the Second Round Qualifier Competition.

Daniel Evers of American Legion Post 46 in Woodburn (the former Chairman of the Youth Shooting Sports Committee) ordered medals for the three top-ranked

individual Oregon competitors, and also for the four members of each of the three top-ranked Oregon teams. He then took all of the medals to an engraving shop to have them custom-engraved so as to be personalized for each recipient. Mary F. Laudon (Office Administrative Assistant for the Department of Oregon) picked up the engraved medals from the engraving shop, and shipped them to the American Legion Posts with which each team is affiliated, there to be presented to each recipient. She also created certificates for each individual, and for each team member (also personalized for each recipient), and shipped them also to the American Legion Posts with which each team is affiliated, there to be presented to each recipient.

The support and willingness to step up and train the next group of Department Legion leadership have been greatly appreciated and rewatching. Thank you to Commander Don for his support, Committee members, and all the speakers who came along for the ride.

March 10, 2022

Met with the Director of Oregon Department of Veteran's Affairs, Kelly Fitzpatrick, and United Veteran's Groups of Oregon Legislative committee member, Marco Oswald, on February 1st, 2022. Director Fitzpatrick notified us that both the Past ODVA past legislative director and present legislative directors were leave ODVA, As she still looking for a new one, she would be take care of the ODVA legislative duties until one was hired. We discussed the upcoming short session and what may be expected. Committees would most likely be submitting omnibus bills and the number of bills would be limited.

The short session ended March 7th, 2022. There were 6 bills that would affect veterans and Military. 3 in House and 3 in the Senate. 3 passed both Senate and House. 2 died in committee and 1 a solution was found without a need for legislation. Following is a review of each bill.

SENATE BILLS

SN1509

Provides that Oregon Route 35 shall also be known as Oregon Nisei Veterans World War II Historic Highway.

There was a lot a testimony given on both the Senate and House sides. This was some of the most heartfelt and emotional testimony I have seen on any bill. It passed in both and is waiting for the Governor to sign which should happen shortly.

SN1522

This was an educational omnibus bill with multiple part to it. The only section of this bill affecting veterans and military is it will "Repeals provision exempting distance learning from requirement that eligible veterans be provided with in-state tuition".

Passed in both Senate and House and has been signed by the President. Now wait on the Speaker and Governor to sign. Both should sign shortly.

SN1542

Exempts from state income tax military pay received by Oregon National Guard service member on state active duty.

This was somewhat of a confusing bill. The original informational testimony was to exempt National Guard allowances (Housing, Food, Clothing) for taxes. However, the bill was written to exempt state taxes on all pay while deployed under state orders. Senator Manning requested the Enlisted Association of the National Guard of Oregon, the Oregon Military director, and Revenue meet to correct the problem of reporting pay rather than a law to put a band-aid on it. This bill did not come out of committee.

HOUSE BILLS

HB4066

This is another omnibus bill that had close to a dozen parts. One of the parts was the renaming of Highway 30.

The House Veterans and Emergency Management committee was able to get it passed on the House floor the Senate Veterans and Emergency Preparedness committee felt that this bill was too complicated to complete in the short session. There was also a lot of funding also attached to this bill. This bill will not come out of committee. In Oregon this means the bill will die and it will need to be resubmitted in the long session.

HB4082

Directs County governing body of each county to designate person to ensure interment of unclaimed cremated or reduced remains of veteran or spouse, dependent or survivor of veteran.

This was a hot bill and had a lot of visibility. Although this bill passed the House it did not come out of committee in the Senate. Unfortunately, this bill did not have

all the information and funding necessary to pass. This bill brought about a lot of controversies to the point that Senator Manning was being threatened. To further understand this bill, listen to the Senate Veterans and Emergency Preparedness committee meeting on February 22nd and 24th. They are available on OLIS (the Oregon Legislative information System)

HB 4095

Establishes Veterans Dental Program in Oregon Health Authority to provide oral health care to low-income veterans who reside in Oregon beginning in 2023.

Passed in both the House and Senate. Now waiting on signatures.

It is important to remember that bills are never as clear as they may seem on the surface. What may seem to be a straightforward and should pass without question may acutely have underlying conditions that make the bill impossible or bad for veterans.

VETERANS AFFAIRS AND REHABILITATION (VA&R) COMMISSION

As of this writing of the Book of Reports for the Spring DEC, the plan is for our Veterans Service Office at the Portland Veterans Benefit Administration (VBA) to reopen at the end of March. This will support the VBA's Traveling Boards and fill a void when our Veterans with appeals need computers and support that we can support that need. We are currently assessing the impacts and how we can support our go forward plan to best support our Veteran community. The Commission also has oversight of our Department VAVS Program which has representatives at our VA Facilities in Oregon. On Thursday, March 3d I attended a virtual meeting with the VA Directors from Portland VA, Roseburg VA, and the VA SORCC in White City. The meeting was to learn about the Oregon VA's recommendation to the Asset and Infrastructure Review (AIR) Commission. This is a Mission Act-required initiative to study the current and future health care needs of Veterans across the country. Oregon VA is the Southern Cascade which includes the Portland VA, Roseburg VA and Eugene, and VA SORCC in White City and all Community Based Outpatient Clinics (CBOC) in Oregon. The recommendations which will be submitted on the 14th, some have started already to better support rural areas, will be moving some CBOC's from Portland to Roseburg/Eugene and some from Roseburg to VA SORCC in White City. Some of the recommendations will be recommended for implementation over the next ten years to support rural areas and an aging Veteran population. A lot of good questions were asked with transportation for Veterans to where services will be available for Veterans and those services that are being addressed at this time

with an immediate need. As recommendations are approved and planned, we will forward the information to our members. Both our Department Service Office and VAVS Program have been impacted with positive COVID cases and have continued to support with reduced in-person support and continued to support with virtual support. The VA will not allow anyone to fill volunteer positions without being complete on their COVID shoots, by Federal direction. Face mask requirements continue at all Federal facilities. If going to a VA or Federal Building, you are required to wear a face mask. We are currently participating in meetings with recommendations to start the VA&R Meetings at our Department Convention to include speakers from our National Organization. Our National VA&R Chair has accepted our invitation to speak at our Department Convention this year. We are looking at inviting representatives from our Local VA's, Veterans Health Administration, Veterans Benefits Administration, and National Cemetery Administration and recognize our VSO and Volunteers that do so much in our Department of Oregon Legion Family. We will be supporting and speaking at the March 29th Vietnam Era Veterans Day Ceremony for our Welcome Home Vietnam Veterans and pin ceremony. The VAVS arm also supports the National Cemetery Administration (NCS) with activity at our National Cemeteries. We have additional responsibility at the VA SORCC and Eagle Point National Cemetery as we have more face-to-face contact, Employment and Education, and VSO activity at these facilities. The Commission also represents our department along with the Veterans Employment, Education and Homelessness (VE&E) Commission at Veterans Stand-Downs, Benefit and Employment and Education Events, Woman Veterans Events, Mobilization, and Yellow Ribbon Events in The Department of Oregon. If your District is holding their meeting and would like more information or support with our Pillar I Veterans activities, please contact me and we will be happy to support. With the changes in VA, COVID, still changing, additional information will be presented at our Spring DEC during my report.
