As I write this article, we have just returned from our Spring Department Executive Committee (DEC) Meeting at Harney County Post #63 in Burns. A lot was discussed and voted on; your District Commanders should be discussing this information with you in your District Caucuses. In one and a half months, we will meet for our Department Convention in Aloha, and our Post delegates to the Department Convention will need to be prepared for the discussion thereon important topics.

Here has been considerable work accomplished on our Proposed 2022-2023 Department of Oregon Budget and a lot of discussion at our Spring DEC meeting as we have some big challenges for this next membership year. Some important decisions will have to be made for the future of our Department. A copy of our Proposed 2022-2023 Budget is included in this Legionnaire, and please review it. As income has reduced with declining membership and our other sources of income have reduced, and our expenses increase, we must make decisions for our future. The proposed budget will be presented to the Finance Convention Committee at our Department Convention, and the Convention Committee will present its outcomes to the Convention Delegates on the floor of our Convention for discussion and acceptance.

Our Posts are holding Post Elections and voting for Post Delegates and Alternates to attend your District Caucus and Department Convention. All Post Delegate Forms, New Officer Forms, District Forms, National Delegate Forms, and instructions are available on orlegion.org under Forms and Publications. Post Delegate Forms must be completed and sent to Department 45 days before the Department Convention with the completed Delegate Forms and \$15.00 for each

Delegate and Alternate Delegate.

With your Delegate Forms is the formula on a table with your authorized delegate



strength PDC, Bob Huff for your Department Finance Officer Post membership. Your Post Forms, new officers, and contact information is due at Department NLT on May 15, 2022. At your District Caucus, you will vote on your District Officers and Delegates for our National Convention. Those forms with your new District Officers and National Delegates need to be sent to Department once your election is completed. Along with the District Forms, any new officers and delegates to National Convention that do not have their DD214 on file at Department; a copy must be sent to Department with the District Forms. All delegates attending the Department Convention must have their Post Delegate Forms with their Adjutant certification sent to Department. Remember, Posts that do not submit their Post Delegate Forms and Delegate Fees are not in good standing and cannot be admitted to the Department Convention once it has been called to order or have a vote on the business of the Department.

It is Tax Time, May 16, 2022, is the due date to file our 990 Tax filing for Posts that have a Tax Filing Period of January 1 through December 31, 21. District Commanders, this is on your Post assessment sheet. There are no exceptions. We, Department, and Posts are under the National Umbrella and are under Group Exemption Number 0925, which is our 501c19. Remember, every Post is a separate

PDC, Kevin Owens NECMAN The HIS-TORY of the American Legion is something that we often look at, and why does it matter. I recently was in the digital

archive on the National web-

site and was looking at The American Legion Weekly starting from the beginning. I find the articles by famous people who wrote for this newspaper most interesting. We must have mattered and were influential in 1919. The American Legion was still in the forming stage, with Posts starting to pop up in every State. The numbers of posts that were being Charted at a rate that may be unbelievable today.

What has happened today in Oregon? Posts were popping up all over the State, and today we are not forming new Posts but canceling Charters; the question is, why is this happening? We continue to drop an average of 1500 members over the past ten years. It's not the loss of our brothers and sisters to death. What is the reason we're not asking them why? Why don't you want to renew? Our renewal rates average around 87%, which we can reach 93% if we contact our members regularly and use Buddy Checks, which is not a membership tool but a way to make everyone feel that they matter.

In the early days of the American Legion, we did not have the youth activities we do today. Why would they join then, and with the tools we have today, why would someone not want to join today? No organization has more to offer the youth than the American Legion. We bring programs that shape lives, promote patriotism,

and encourage sportsmanship.

Our programs sell the American Legion and what we offer not only for the youth but the most incredible Service Officers in the world, bar none. The dedication of the ones who help Veterans get the benefits they earned for their service to this Nation. As a department, we have the tools and ammunition to sign up new members in our great organization, and it's up to all of us to continue to be relative in our towns, counties, and states.

The 2022 NALC class is scheduled for December 11-16, 2022, and will be conducted at The American Legion National Headquarters, Indianapolis, Ind. The 2022 student application may be downloaded at legion.org/college.

The prerequisites to apply for the National American Legion College are as follows: all candidates must be a member in good standing, be a member for a minimum of three continuous years, have completed Basic

Training online with a certificate dated after August 2016, and must be vetted and endorsed by their department leadership. The Basic Training course is completed online and can be found at legion.org/alei.

The Department of Oregon seeks to send 1-2 highly motivated candidates as well as begin developing a list of interested candidates for future years. Candidates should submit their completed applications to adjutant@legion.org as soon as possible so that leadership can vet applications in a timely fashion. All applications must then be submitted and endorsed by department leadership by July 31, 2022. Any applications received without the department's endorsement will not be accepted.

Birmingham, H.S. Junior Sweeps to Victory, Earns \$25K Scholarship in American Legion Oratorical Contest

INDIANAPOLIS (April 24, 2022)

A junior from Alabama School of Fine Arts in Birmingham capped a busy weekend of competition in Indianapolis by earning a \$25,000 college scholarship and first place in The American Legion High School Oratorical Scholarship Program – "A Constitutional Speech Contest." Emma Noble's winning prepared oration was titled "The Power of the Executive Order: Because I said so."

Noble, who lives in Birmingham, started the weekend as one of 50 state or department champions in the 83rd annual contest. She advanced to the championship through three rounds of intense competition. Noble was sponsored by American Legion Post 555 in Pelham, Ala.

Ashley Tuell, a senior from Johnson City, Tenn., earned a \$22,500 college scholarship with a second-place finish, while Jackson Boone, a 12th grade

student from Calvert City, Ky., earned \$20,000 and third place in the competition. The scholarships account for a small portion of post-secondary scholarships that The American Legion, the nation's largest veterans organization, awards annually.

In her prepared oration, Noble compared the use of presidential executive orders to the common parental admonishment of authority "because I said so." She pointed out positive examples of its use, such as the Emancipation Proclamation and the desegregation of the military but also mentioned that it was used by President Franklin D. Roosevelt to establish Japanese American internment camps during World War II.

Noble encouraged people to consider the use of executive orders when they vote. "Executive orders are an extremely valuable tool because they are much faster than passing a law through the legislative branch; how-

ever, they are not trivial to undo so you must have confidence in the person making them. It is a citizen's responsibility to vote. Not only that, but to vote for someone you trust with the power of executive orders. Because I said so."

In each round of the weekend competition, orators delivered a rehearsed 8- to 10-minute address and a randomly assigned 3- to 5-minute oration on a constitutional topic, each without the benefit of notes and in front of a live audience, including the judges. The nearly 2-million-member American Legion developed the contest to encourage young people to improve their communications skills and to study the U.S. Constitution. More than \$3 million in scholarships have been awarded over the history of the contest.

On Sept. 27, 1920, the poppy became the official flower of The American Legion and was led largely by the American Legion Auxiliary, and it has since become an annual tradition. Congress has yet to act on the advocacy of The American Legion and American Legion Auxiliary (American Legion Resolution No. 4, October 12-13, 2016) to establish a National Poppy Week around Memorial Day to bring greater significance to the poppy as a symbol of the sacrifice our veterans made for our freedom. Let's wear a poppy to honor those who have worn our nation's uniform.

Neither the PUFL membership nor the in-lieu cash-value prize is transferrable. The PUFL membership cannot be substituted/exchanged for an in-lieu cash-value prize.

<u>Location of Drawing</u>: 2022 Oregon Department Convention Banquet – Aloha, Oregon

<u>Ticket Cost</u>: No cost.

Odds of Winning: Dependent upon the number of participating registered attendees at the department convention.

The month of May is a reminder that two months remain in the 2022 membership campaign. In a recent veteran publication, a reporter shared his views on

membership declining in two major veteran organizations because the newest generation of veterans is not joining the VFW and The American Legion. Has anyone mentioned membership decline to you? Or said we have five-year plans to grow membership, but they do not seem to be working? Why? The plans contain all the essential elements for growth; brand

awareness, education, post creation, recruitment, retention, and "A Veteran is a Veteran." What is missing?

The American Legion was born in March 1919 in Paris, France, after which the St. Louis caucus was held. Chartered in September 1919, the Legion's first convention was in Minneapolis in November of 1919. And it was an unknown organization throughout the entire world due to its infancy. Yet, by the end of the first year, the Legion had 843,016 dues-paying members. That is without the internet, television, radios, telephones, and Direct Mailing Solicitation (DMS).

Transportation was limited at that time. And we must remember, this was even before the interstate highway system that we have now. Most people lived, in those days, their entire life and never went more than a hundred miles away from where they were born, and yet, in the first year, the Legion grew to 843,016 members. Over the years, The American Legion grew to become the largest veteran's organization, strengthening its voice and credibility on Capitol Hill while advocating for all veterans.

From 1984 to 1994, the Legion enjoyed a membership that exceeded three million. From 1919, fast forward past four major wars to a culture today that has given us so many avenues available to us that they did not have "back in the day" through technology and transportation advances along with a continued sizeable veteran population. Today, our organization is losing close to 65-75,000 members a year, and our Department loses approximately 1,500 members a year.

I keep asking myself, why? Could the answer lie in a quote by author Elijah Wood, "Safety and comfort come from complacency, and that is never a good place to be working from?" World War I veterans who fought the war to end all wars came home not satisfied but determined that no veteran, no widow, no orphan would do without the care and comfort of a grateful nation because of the sacrifices that they had made.

Yes, they could have become complacent once home, but they had a missionary zeal to make sure that no veteran was left behind, to make sure that no veteran lacked the medical care that he or she needed. No veteran's widow went without food or shelter. No veteran's orphan went without clothing and education. They wanted to make sure that no person who had served in the Great War would miss the opportunity to be a member of The American Legion. They did not care about the cost of the member-Continued on page 14 ship;

Could the missing link in our plans be a sincere urgency to ensure that we carry forward the great legacy that The American Legion has built? Are we exhibiting the enthusiasm for The American Legion and all it has done, is doing, and will be doing tomorrow that enables us to share what we have with another veteran who has earned it? If we do not give every veteran an opportunity to be part of The American Legion, then we are failing every veteran with the opportunity to help those who are not as fortunate as we and to continue the bond that brings us together as people who have served in the armed forces of our nation since Pearl Harbor.

Three hundred twenty-six thousand (326,000) veterans live in Oregon today. Currently, there are approximately 2,048 Legionnaires in our Department's Holding Post #114 awaiting our invitations to transfer their memberships into a Post like yours and mine. Our Department's current membership is 12,706.

Where could our Department membership be if every current member recruited just one new member or transferred a Post #114 member into a Post? Membership is a responsibility of every Legionnaire and about who we are. Mark Twain suggested, "The secret of getting ahead is getting started." Now is time for each of us to act with doughboy urgency, enthusiasm, and determination to grow membership. The future of our Department depends on what we achieve today.

over VA&R activities for our Department. Our Department of Veterans Service Officers, hands down, do an excellent job. They work virtually and in person and support our Veterans and their families. During this Pandemic over the past two years, they have adapted and adjusted to support our family of veterans during this critical time.

They continue to support the Veterans Benefits Administration (VBA) Traveling Boards and fill a void when our Veterans with appeals need computers and support that we can support that need. When you see one of them, Ed VanDyke and Jody Marsh, thank them, they are our first team. The Commission also has oversight of our Department VAVS Program, which has representatives at our VA Facilities in Oregon, which all need more volunteers. With recommendations for the tenyear plan for the Missions Act, The Asset and Infrastructure Review

The VAVS is in desperate need of more volunteers to support needs. If going to a VA or Federal Building, you must wear a face mask.

We are currently participating in meetings with recommendations to start the VA&R Meetings at our Department Convention to include speakers from our National Organization. 



My home post is Aloha #104, where I am a nine-year, Paid Up For Life member. And I am proud to have received the endorsements of both Aloha #104 and District 1's general memberships for the high office I seek.

I have held numerous officer and leadership positions at the post-, district-, and department levels. And in addition to serving as your Department's 2nd Vice Commander this year, I also serve on the Permanent Finance Commission and The Oregon American Legion Foundation.

Previously, I have chaired the Americanism Commission and the Media and Communications Commission, and I have served on numerous committees, all of which further strengthen my qualifications to serve you as Department 1st Vice Commander.

I have completed the American Legion Extension Institute Course, the Basic Training course, and Oregon Legion College. I am a graduate of the National American Legion College – (Rohan) Class of 2017.

In addition to The American Legion, I am a member of ANAVICUS - the Army, Navy, and Air Force Veterans in Canada - United States Unit. I am also a Lifetime Member of the Air Force Association and a member of their Wings Society, which provides aid and support to airmen and their families. I am a member of the U.S. Air Force Academy Foundation's Sabre Society, whose mission includes developing innovative leaders of character for the nation, supporting graduate programs and services, and other operational strategies.

In looking to the 2022-2023 year ahead...and beyond that...

My friends, we are at a critical crossroads within our Department of Oregon. The pandemic caused a significant impact on our lives and a huge disruption in the delivery of our Legion programs, no doubt. But, to be honest, and direct...our Department has been experiencing a decline in membership numbers, in participation, and in support of many of our programs for quite some time.

We must look <u>strategically</u> at how we can position our Department to support our members – and all Oregonian veterans – in the years to come. And most importantly, we must then be <u>decisive</u> in taking the strategic steps necessary to improve and ensure our ability to deliver on our four pillars of service.

There is serious work to be done in our Department. Having said that, let me be clear...in no way do I believe our best days are behind us. Not at all. We do, however, need to critically address how we are organized and function.

I see five critical areas needing attention; those are <u>leadership accountability</u>, <u>improved</u> <u>communications</u>, <u>membership engagement</u>, <u>fiscal resourcefulness</u>, and a <u>strategic plan</u> for organizational change.

Latent <u>leadership</u> is deteriorating our organization. It proliferates throughout, from elected officers at all levels, to appointed positions, to individual members.

As just one example, we began this past year with greater than 25% vacancies on our commissions and committees' roster. And beyond that, many roster members are cross-listed on multiple committees. We must strive for better accountability when taking on a position, regardless of the position.

Foundationally, it begins with an improved Oregon Legion College framework that gets back to teaching the basics of how we are organized and function, roles and responsibilities, and rebuild our foundation.

Good <u>communication</u> doesn't just happen. It's intentional, and there is a framework to it regardless of the medium. Good communication applies to each of us, be it establishing meeting dates and times, sending errant emails, accuracy in messages or letters, or taking up inordinate staff time in the office – we all must strive to communicate more thoroughly, more transparently, and more effectively. Effective communication also leads to *positive visibility*.

As for <u>membership</u> – it's not just a numbers game, it's also a matter of caring for our members, for each other. However, the added challenges of a decreasing membership further compound the diminishing effect on our ability to successfully deliver our programs.

Buddy Checks aren't really new nor is renewing members. However, we do need to better educate posts on the 'how-to' of developing a systematic framework for conducting 'Buddy Checks' which support renewals. Again, foundationally, an Oregon Legion College that gets back to the basics can help improve resources for members.

Our <u>fiscal resourcefulness</u> is linked to our need for a <u>strategic plan</u>...one that gets implemented. We can no longer put off making changes within our organization in hopes of magically making membership goals. Change is inevitable. If we continue to do nothing, the resultant 'change' will continue — membership will keep dropping, participation will keep diminishing, and support will squander. Our membership numbers have a direct impact and consequence — decreasing membership equates to decreased budgets, it is that simple.

As example, at this time, our Permanent Finance Commission is working to address a projected \$93,000 budget-deficit for operating next year, which begins 1-October. Work continues and it's not easy. The Administration & Advisory Commission, along with our department leadership, has extremely difficult decisions to make but, together, we will seek the means to provide a zero-deficit budget to our membership at convention. And, frankly, it may be a short-term fix over a long-term solution.

Thus, we need a strategic plan that will address organizational and functional utility that strives to realistically meet our ability to deliver on our four pillars. It requires significant changes to how we have historically functioned. In a broader vision, as a department, we need to develop the means to further minimize nearly all paper processes. This includes membership cards. And, it includes using technologies available for Department to conduct direct renewal solicitation to members throughout the Department in further supporting posts.

We must improve efficiencies by leveraging the investments on technology, and drive overhead and routine business costs down. This includes actions such as: increased virtual meetings; shorter headquarters' office hours; teleworking; web-serviced business center operations; substantially decreasing travel budgets or shifting to stipend-only; significantly cutting down copy and print services; reorganizing downward from 10 districts; and, more. While some of these actions may seem new, they really are not. They are industry standards in the private sector and in government.

I will support the department commander and will work to achieve strategic leadership improvements that strengthen our Department. I look forward to working with our Department and American Legion Family leadership, and with *you*, in moving our Department forward.

As a Legionnaire I serve *as one of you*! I ask for your support – *and vote* – in electing me to the high office of Department 1st Vice Commander, 2022-2023.

Dillard pushes Senate on PACT Act during national tour

In the midst of a multi-state tour, American Legion National Commander Paul E. Dillard is focused on increasing Senate support for a comprehensive bill that will provide needed care and relief for veterans sickened by exposure to burn pits, atomic radiation and other toxic substances during military service. Before the anticipated vote at the end of May, he will travel to seven different states, ranging from Alaska to Georgia, to meet with Legionnaires and build support for this once in a generation piece of legislation.

"The Honoring Our Pact Act is aptly named because it is a solemn promise that we must honor," Dillard said. "It took far too long for government to recognize high cost that

the men and women of my generation paid because of Agent Orange. This bill will provide VA health care for more than 3.5 million contaminant-exposed veterans who served in the Global War on Terrorism. It also includes benefits for atomic vets and others who have been exposed to dangerous substances and have gone decades without government accountability or rightful treatment for diseases they contracted because of it. This bill has passed the House. I'm calling on every member of the U.S. Senate to support it. We have called for a vote before Memorial Day, and I can think of no better way to honor

the fallen than taking care of their brothers- and sisters-in arms."

Dillard and his team of national vice commanders have been carrying this message to Legionnaires across the country. Dillard has already given several media interviews in Minnesota and is scheduled to visit Georgia, Alaska, South Dakota, Indiana, Kentucky and Illinois in the weeks leading up to Memorial Day.

"People are dying," Dillard said. "This bill establishes a service connection for 23 illnesses and cancers linked to these exposures. I would like to ask any member of Congress who opposes this legislation, which veterans do you want to leave behind? Those with Gulf War Illness? Camp Lejeune vets? Those with stage 3 cancer? I call on all Americans to contact their U.S. senators and insist that they vote for the Honoring Our Pact Act. These benefits were earned by our veterans who put their lives on the line for America and suffer today due only to their willingness to serve in the U.S. Armed Forces."

Legion, Ganassi leading effort to reduce veteran suicides through 'Be the One'

With the most fabled track in motor racing as the backdrop, The American Legion joined with others to address one of the most critical issues facing veterans today: a high suicide rate that a new campaign will address, starting on one of motorsports biggest stages.

With the unveiling of 2013 Indianapolis 500 champion Tony Kanaan's livery for this year's "Greatest Spectacle in Racing" came the unveiling of an effort spearheaded by The American Legion and Chip Ganassi Racing that calls on the public to become involved.

Kanaan was given the OK from teammate Alex Palou – the 2021 IN-DYCAR Series champ – to use the No. 1 for the race – an honor bestowed each race on the previous year's series champ. On Kanaan's No. 1 American Legion Honda is the phrase "Be the One", the name for the campaign to address veteran suicides. It's a cause that Kanaan, who finished 10th in the Legion car at the 500 in 2021, believes in strongly.

"It's such a good cause – 'Be the One," Kanaan said during the April 20 press event outside of the pagoda at Indianapolis Motor Speedway. "I made the pledge to the veterans to advocate that ... if you need help, ask. Voice it up. I've learned that 17 veterans take their lives every day. We're here for that. Hopefully we'll get the word out."

During the event Kanaan was joined *Continued on page 23*

by Indiana Gov. Eric Holcomb and American Legion Chief Marketing Officer Dean Kessel, who called the number of daily suicides "the biggest issue facing this generation of veterans." He said the challenge behind the "Be the One" campaign is that that "if you can save the life of one veteran today, would you be the one to do it? You're going to be hearing that from us a lot, what we're going to be doing and how we're going to be doing it."

At the start of the press conference, a group of veterans symbolically stood behind the No. 1 Honda, a mix of American Legion Riders and Ganassi employees. "That was 17 veterans to represent the 17 veterans that take their lives daily," Kessel said. "That's got to stop. That's this generation (of veterans') biggest challenge, and we have to do something about it. And there's no organization more poised than The American Legion to do that. With our political capital on Capitol Hill. With our 1.8 million members across the country, our peer-to-peer network is unrivaled.

"This is not just a campaign. It's a generational lift. The primary goal of our 'Be the One' campaign is eliminating the stigma involved with asking for help. That is the No. 1 hurdle for veterans seeking mental help. We want to de-stigmatize that."

Holcomb, a U.S. Navy veteran and member of Historic Fort Benjamin Harrison American Legion Post 510 in Indianapolis, drove from the Statehouse to IMS with Kanaan.

"There couldn't be a better reason why we started the day today together than this cause at this time on this hallowed ground," Holcomb said. "I think it's our duty, as citizens of this nation and state, for those (service-members) fortunate to make it back.

to be there for them. To understand the burdens that they bring back with the orders they've received, going to some hairy and scary places in this world. We're there to help them destigmatize and help them get through the days ahead because of the burdens they bear for us. They stepped forward."

Holcomb said Indiana will be a part of the 'Be the One' campaign. "We could not be prouder to align all of our state efforts on mental health alongside (The American Legion)," he said. "I would just encourage everyone to be the one. You could be the one. If you don't know how to help but you want to, get them connected with the Legion. Get them connected with the Indiana Department of Veterans Affairs. Not only can they help, they want to help. It's their mission."


For CGR team owner Chip Ganassi, the issue of veteran suicides "is something that needs attention brought to it, first and foremost. When you're losing 17 veterans a day to suicide, that's something you can almost see with your bare eyes. How do you make the awareness of such an issue? How do you bring it to light? There is no better place to do it than in Indianapolis on Memorial Day – the day that we have put aside to honor veterans. And these guys need honored, believe me. They've seen things that none of us will ever see in our lifetime."

Ganassi said partnering with The American Legion – an <u>official charity</u> <u>of INDYCAR</u> – opened his eyes to the issue he and the Legion are addressing with "Be the One."

"It just brought a new awareness to me personally, I guess, being involved with the Legion here on Memorial Day in Indianapolis," Ganassi said. "I just want to help." Among the group of American Legion Riders that escorted Kanaan and Holcomb from downtown Indianapolis to the track were ALR National Advisory Committee Chairman Mark

"The fact that the Chip Ganassi Racing team has partnered with The American Legion ... to help us fight the veteran suicide crisis that's occurring in our country today, to be a part of that is humbling," Clark said. "I know veterans that have taken their own life. I'm hopeful that this campaign will bring awareness to the challenge (and) help folks understand it's the right thing to seek out help. But more importantly, to bring attention to the resources that are available to veterans. I really think this campaign can open a lot of doors for us."

Kessel said the campaign is focused on making an incremental change that will long-term continue to grow. "We want to stop talking about the 17 and focus on the one," he said. "If we can save one a day, that number will come down, and that's the goal of everything that we're doing here."



Past Oregon department commander sees 'new windows' being opened with INDYCAR relationship

Thomas Harris of American Legion Post 119 in Vernonia, Ore., is a "Legion Legacy."

His family has been a part of The American Legion dating all the way back to its inaugural year in 1919 after the Great War, later known as World War I.

"I've been supporting The American Legion since I was 17," said Harris, Oregon's department commander from 2018-2019, which made him a centennial commander. "I'm 65 now, and my father, grandfather and great grandfather were all legionnaires from World War I, on.

"It's not only a good foundation for me, but it has also been since I got out of the Marine Corps in late Vietnam. I came home and was one of those guys trying to find my way. It was difficult finding a job, and we were dealing with the community not having a really good feeling about the Vietnam War at that time."

Harris served in the U.S. Marine Corps from 1973-1977 as the United States' involvement in the Vietnam War was winding down. Many servicemembers returned home from the conflict in Southeast Asia and were suddenly in need of purpose and direction.

"(The American Legion) helped me stabilize myself because I could spend more time with my veteran friends than I made after I came home," Harris recalled. "It was good for the Army, Navy, Air Force, Marine Corps. Even the Coast Guard got involved. Even today, I've found it is more important what The American Legion is doing in our nation, not only for national security, but to help veterans coming home. We are developing more and more critical teams for those veterans that are coming home. They are not stable and don't know what to do and have a direction. So, we give them a direction, we give them a place to go, we share with them our service officers.

"There are several outlets in Oregon and I'm going to share that over in

Idaho, share some of my knowledge and learn some of the knowledge they have on what they do with their crisis centers to help the 22 veterans a day that are falling victims of suicide."

Harris can relate to that plight. When he returned home from Vietnam, he wasn't exactly welcomed back with open arms. The war was unpopular with many in the United States, and there was little to no "Hero's Welcome" when servicemembers returned to their hometowns.

"It was very quiet, and I didn't get it as severely some of my upper classmates that I knew in junior high and going into high school," Harris said. "A lot of us went in early, we left high school because we felt it was our duty. We came back and it was that silent treatment, or once in a while you got told off. A lot of men and women know that and those are some of the things we had to deal with."

There was one place, though, where Harris and other servicemembers were always welcomed and made to feel a member of a greater fellowship. It was The American Legion.

"The Legion is there to support those people," Harris said. "When we come together now, it's like rivals on a baseball or football team. When you come together afterwards, it's more of a brotherhood or sisterhood and everybody supports each other. The American Legion and other organizations are here to support veterans and veterans in need."

The Legion's voice has been amplified through its official partnership

Continued from page 26 with INDCAR and the NTT INDY-CAR SERIES. That partnership has grown from major associate status on Jimmie Johnson's No. 48 Carvana/American Legion Honda at Chip Ganassi Racing to become an official charitable partner of INDYCAR.

"This gets the message out there," Harris said. "It's a lot stronger. We have people coming in every day now asking questions how they can get support and pull themselves out of their problems, whether it be mental, physical, or trying to find a job.

"It was The American Legion that helped create the VA. We have members from many posts that go up to the VA every day and talk to them, pass out ice cream and just get to know them. It's a good program, but like everything, we try to improve it every year."

Harris has always been interested in cars and was an INDYCAR fan before the Legion started its relationship with Chip Ganassi Racing in 2021.

"I watch the Indianapolis 500 every year," Harris said. . "My dad and grandfather did, also. I think it is something that is always there. Season to season to season, you watch cars, baseball and football. We were all into that. I've met the pit crews and the guys on Chip Ganassi's team. It's really an awesome thing.

"I really love it. I think it's exciting. We are already seeing a lot of interest. A lot of people are asking us questions. A lot of people are interested in Indy cars long before The American Legion got involved that were veterans and American Legion members.

It opened up some new windows and access to support of veterans in a positive way.

"I was always interested in cars and driving, but it takes money to get into that. It's a pretty select thing. You don't go to college and learn how to be an Indy driver."

INDYCAR and The American Legion have created a program that helps create awareness for The Legion, it's membership and its programs.

It's exposure that an organization can't really buy. "I couldn't say it better," Harris said. "It's great for the causes we represent and promote for our veterans. I'm really proud of them for stepping up and allowing us to be a part of that.

"There is a lot to the American Legion emblem."



The Legionnaire Insurance Trust (LIT) was formed in 1966 with two primary goals: to provide Legion families with low-cost insurance protection, and to provide a source of revenue to participating Legion Departments.

The Trust has been so successful in its over fifty years that today over 500,000 Legionnaires in 50 participating Departments are enrolled in this unique program.

Also, in the same period of time, almost \$1 billion dollars in claim benefits have been paid to Legionnaires and their families through the LIT; and over \$100 million in allocations have been paid to participating Legion Departments. The first Trust insurance plan to be offered was the Hospital Income Protection plan, a program designed to pay fixed dollar amounts for periods of hospital confinement. Over the years, other insurance coverage offered included: Cancer, Accidental Death, Critical Illness, Disability Income, Emergency Assistance, Long Term Care, Medicare Supplement, Discount Cards, Dental, Whole Life, Auto, Homeowners, Identity Theft, and Home Health Care.



The Lincoln Memorial in Washington D.C. was dedicated during May. The dedication ceremony was officiated by former U.S. President and Chief Justice of the Supreme Court William Howard Taft. Special guests at the ceremony including Robert Todd Lincoln (Abraham Lincoln's son), Robert Morton (the President of the Tuskegee Institute), President Warren G. Harding, and Vice President Calvin Coolidge. The memorial was designed by Henry Bacon to resemble a Grecian-style temple complete with columns and a 19-foot-tall marble statue of Lincoln that was sculpted by Daniel Chester French.

Mrs. Roshak has served as the American Legion Post 44 Commander since 2008, coordinates Wreaths Across America fundraiser and others for local veterans, and continues to be an inspiring role model demonstrating how one person can truly make a difference."

Medal of Honor Highway Across America





Illinois and Ohio have just designated their state Medal of Honor Highways, joining eight other states for a total of 10 states. That leaves New York and Massachusetts to complete the 12 states, 5-year project. New York plans to designate its Medal of Honor highway before the Legislature adjourns on June 2. Massachusetts is working hard to finish its designation. Together, New York and Massachusetts account for 1,073 MOH recipients and the last 16% of the MOH Highway across America.

Thus 84% of the 3,365 mile Medal of Honor Highway Across America through 12 states has been designated by ten state laws/resolutions.

Recall that each state honors its own Medal of Honor recipients, and collectively the 12 states will honor about two-thirds of all 3,511 recipients (Civil War to present) from ALL 50 states. That means the other 38 states account for about one-third of all 3,511 recipients.

As previously discussed, a National Medal of Honor Highway across the



USA on US Hwy 20 would honor all 3,511 recipients from all 50 states and territories and any future recipients, and that is our next objective. It would parallel the coast to coast Lincoln and Eisenhower Highways. Pres. Lincoln signed legislation in 1861 and 1862, creating the Medal of Honor award. President Eisenhower awarded Medal of Honor awards during his presidency and probably during WWII. Great pairings!

As Oregon kicked off our most noble enterprise five years ago, I have discussed federal legislation creating the National Medal of Honor with Oregon Senator Ron Wyden's staff in Washington, DC. They are anxious to start the ball rolling but only after New York and Massachusetts designate their Medal of Honor highways. Will need help convincing your delegation in DC to support the cause.


By separate email, I will ask veterans groups to help dedicate Ohio, New York, and Pennsylvania Medal of Honor Highways. I'll send state streamers to those volunteers to attach to the Medal of Honor flag during ceremonies.

American Legion will lead the dedication of the Illinois Medal of Honor Highway and has its streamer. At-
