

newly elected 2022-2023 officers. While my schedule would not permit me to attend all of them, it is an honor to be asked - thank you. For those I was able to attend and serve, thank you for the warm welcome and hospitality. It is a joy to slow down a bit and reconnect with veterans and posts.

The 2022 Spring Meetings of The American Legion, including those of the National Executive Committee (NEC), were held May 2-5 in Indianapolis. It was a very busy week, and I

will touch on just a few of the highlights here now. And to be clear, it was an honor representing the Department of Oregon - you - on committees and in our meetings.

Media and Communications Commission (MCC) continues to make exciting and significant advances in print, digital and audio media arenas in evolving to meet the changing information needs of our membership body. We have an extremely diverse membership and the MCC is making advances in those three media arenas to ensure our members are reached and well-versed in the actions of our organization and in the myriad programs we deliver.

The standard-bearer remains *The* American Legion Magazine which continues to implement very subtle redesign measures to ensure contemporary, pulsed newsprint is meeting the desires of its readership. It is working as the magazine ranks #19 in

circulation in the U.S. and is rated #1 in readership in 3 of 4 and 4 of 4 of the last magazines read. However, the magazine industry continues to face stiff challenges in paper supply availability, printing, mailing, and distribution cost increases, labor shortages, keen competition for new hires, inflationary pressures worldwide, and more.

Electronic media, including Legion. org, e-newsletters, and online updates, continue to grow in increase click-throughs. Social media outlets see increased activity, as is the Tango-Lima-Alpha podcast. In just its second year, Tango-Lima-Alpha continues to soar in record-setting downloads and in critical acclaim, receiving two major awards in just the past six months.

Americanism Commission has, of note, a resolution concerning the oratorical program, which is on hold for further study, that seeks to both de-

Marketing Commission (MC) is making exciting strides in identifying member engagement and satisfaction opportunities. This includes efforts to reimagine membership to improve first-year member experience with fewer mailings and a simpler online renewal process, including auto-renewal options.

The roll-out of the American Legion brand mark continues to be well received with positive engagement and feedback. Efforts are underway by the MC to further increase brand guidelines distribution and use throughout departments and posts.

Additionally, a study is underway to further evaluate membership renewal options, including a rolling renewal based upon the date of sign-up and the possibility of multiple-year renewal options, such as three- and five-year renewal options.

Lastly, and quite fitting for June 14th, Flag Day, is the report from National Emblem Committee that first-quarter flag sales were \$898,000, which is the largest first-quarter for flags in our history!

In closing, I acknowledge our U.S. Army's 247th birthday - Hooah!

A heartfelt thank you to everyone supporting our American Legion, and it has been an honor to serve you as your department's 2nd vice

commander. We are Veterans strengthening America!

Your Post Forms, new officers, contact information is due at Department NLT May 15, 2022. Please verify that your Post sent in all the Post Forms. At your District Caucus you will vote on your District Officers and Delegates for our National Convention. Those forms with your new District Officers and National Delegates need to be sent to Department once your election is completed. Along with the District Forms, any new officers and delegates to National Convention that do not have their DD214 on file at Department; a copy must be sent to Department with the District Forms. All delegates attending the Department Convention must

have their Post Delegate Forms with their Adjutant certification sent to Department. Remember, Posts that do not submit their Post Delegate Forms and Delegate Fees are not in good standing and cannot be admitted to the Department Convention once it has been called to order or have a vote on the business of the Department.

All Post 990 Tax Forms were due May 16, 2022 for Posts that have a Tax Filing Period of January 1 through December 31, 21. District Commanders, this is on your Post assessment sheet. There are no exceptions. We, Department and Posts are under the National Umbrella and are under Group Exemption Number 0925, that is our 501c19. Remember, every Post is a separate corporation, it is a business, you operate under Corporate Laws of Oregon, you pay a filing fee each year to the Secretary of State, Corporation Division.

Remember the Oregon American Legion Foundation is a 501©3, contributions are tax deductible, funds are used for our programs. There is a lot of information and grant requests on our Web Site.

The Spring National Executive Committee just concluded after two days of business in Indianapolis. During the NEC, reports were delivered by the various committees of the American Legion. With those reports, the NEC voted on the thirty-one resolutions brought to the floor. I will highlight a few that were presented.

One of my interests was to allow multi-year membership. This would allow annual membership to be paid in three or five years, which would cut down on dues,

renewals, and postage savings. Resolution 4 changes some of the rules and money allocation to apply to the Legacy

Resolution 5 was the creation of the American Legion 1919 Society. Money raised from this program will support the new Veterans & Children's Foundation. I would encourage everyone in our department to become a member. Resolution 10 was much discussed and did pass to ensure care for the LG-BTQ+ Community once separated from service. When discussed on the NEC Floor, all felt that a Veteran is a Veteran no matter their sexual orientation. These are just a few of the resolutions that impact the American Legion.

I highly encourage all the members to go to the Legion website and type in the search engine resolutions. You will find the current thirty-one resolutions at the Spring NEC and all the resolutions in the digital archive that have passed since 1919. The National Executive Committee is the governing body between National Conventions like our Department Executive Committee. The role is to continue to support the Aims and Purposes of this organization and the Four Pillars.



Oregon Membership. I want to appeal to everyone reading this to remember membership is not just about numbers, and it is about our members. We joined this organization for various reasons, but one common reason is to take care of our veteran brothers and sisters. For this reason, I have been pushing for "Buddy Checks" all year

There are about 300k veterans in the state of Oregon, imagine how strong our organization would be if we had just 10% of those as members, but a handful of people at Department and District can't do this alone. Membership is everyone's responsibility, so I ask for your assistance. Let's rebuild this Department stronger than ever together.

I would like to take a moment to talk about the word "inclusiveness." The definition of this word in the Cambridge Dictionary is as follows, "the quality of including many different types of people and treating them all fairly and equally." We have, over the past couple of years, developed ways of creating divides within ourselves. Alienating members, and we are all guilty of it in some fashion.

These are a couple of examples of ways we might do this. When we hold events at our Posts, is every member invited? Within our Districts, do Posts help each other out? 

Department Headquarters has no control over the day-to-day operations of Posts. There is a chain of command for complaints regarding officers or members of a Post, beginning with the Commander of the Post. If the Commander is the problem or fails to solve the problem, the next step is to go to the Post Judge Advocate, then the District Judge Advocate, and THEN the Department Judge Advocate.

Failure to follow this chain of command will only slow or impede an issue you wish to resolve.

If you have an issue with a Program of The Oregon American Legion, refer your questions to the appropriate Committee Chair and then that committee's Commission Chair if the further resolution is needed. Again, calling the Department of Oregon Headquarters will only slow down the proper response to your issue at hand.

The Department Headquarters staff is there to provide support for the functioning of the Department, not as the place to ask questions concerning items in your Post's Constitution and By-laws, then as specified above.



The month of June supplies several Public Relations opportunities for Posts to inform Legion Family and community members of Legion programs, activities, and observances.

Legion Americanism calendar published in the January 1942 edition of The National Legionnaire gave readers some suggestions for June that are still customary today. "FLAG DAY is observed on June 14 and, as a part of this observance, all posts should see that Old Glory is properly displayed on every business house and home in the community. Pageants and playlets showing the history of the Flag should be a part of such programs." The June calendar also suggests visiting Boys' State. Make a final check-up on the eligibility of all boys enrolled in the Junior Baseball program and see that every boy in the community who wants to play baseball is given an opportunity to enroll. Start your plans for a huge Fourth of July celebration."



The U.S. flag is the symbol of our patriotism. Ronald Regan said, "When we honor our flag, we honor what we stand for as a Nation --

freedom, equality, justice, and hope." As we observe Flag Day 2022, the U.S. Flag Code provides guidelines to follow when displaying our nation's Flag. The origin of the U.S. Flag Code dates back to June 14, 1923, when the National Flag Code was created by representatives of over sixty-eight organizations under the auspices of the National Americanism Commission of the American Legion. Congress adopted the code in 1942. More flag protocol can be found in Let's Be Right

on Flag Etiquette booklet at <a href="www.legion.org/media/">www.legion.org/media/</a> publications.

Americanism is one of the Legion's 4-Pillars. Together we recite the Legion preamble during official gathers that reminds us all "... to foster and perpetuate a one hundred percent Americanism..." 




#### **Greetings, fellow Legionnaires!**

#### In looking to the 2022-2023 year ahead...and beyond that...

My friends, we are at a critical crossroads within our Department of Oregon. The pandemic caused a significant impact on our lives and a huge disruption in the delivery of our Legion programs, no doubt. But, to be honest, and direct...our Department has been experiencing a decline in membership numbers, in participation, and in support of many of our programs for quite some time.

We must look <u>strategically</u> at how we can position our Department to support our members – and all Oregonian veterans – in the years to come. And most importantly, we must then be <u>decisive</u> in taking the strategic steps necessary to improve and ensure our ability to deliver on our four pillars of service.

There is serious work to be done in our Department. Having said that, let me be clear...in no way do I believe our best days are behind us. Not at all. We do, however, need to critically address how we are organized and function.

I see five critical areas needing attention; those are <u>leadership accountability</u>, <u>improved</u> <u>communications</u>, <u>membership engagement</u>, <u>fiscal resourcefulness</u>, and a <u>strategic plan</u> for organizational change.

Latent <u>leadership</u> is deteriorating our organization. It proliferates throughout, from elected officers at all levels, to appointed positions, to individual members.

As just one example, we began this past year with greater than 25% vacancies on our commissions and committees' roster. And beyond that, many roster members are cross-listed on multiple committees. We must strive for better accountability when taking on a position, regardless of the position.

Foundationally, it begins with an improved Oregon Legion College framework that gets back to teaching the basics of how we are organized and function, roles and responsibilities, and rebuild our foundation.

Good communication doesn't just happen. It's intentional, and there is a framework to it regardless of the medium. Good communication applies to each of us, be it establishing meeting dates and times, sending errant emails,  $\,$  accuracy in messages or letters, or taking up inordinate staff time in the office - we all must strive to communicate more thoroughly, more transparently, and more effectively. Effective communication also leads to positive visibility.

As for membership – it's not just a numbers game, it's also a matter of caring for our members, for each other. However, the added challenges of a decreasing membership further compound the diminishing effect on our ability to successfully deliver our programs.

Buddy Checks aren't really new nor is renewing members. However, we do need to better educate posts on the 'how-to' of developing a systematic framework for conducting 'Buddy Checks' which support renewals. Again, foundationally, an Oregon Legion College that gets back to the basics can help improve resources for members.

Our fiscal resourcefulness is linked to our need for a strategic plan...one that gets implemented. We can no longer put off making changes within our organization in hopes of magically making membership goals. Change is inevitable. If we continue to do nothing, the resultant 'change' will continue membership will keep dropping, participation will keep diminishing, and support will squander. Our membership numbers have a direct impact and consequence – decreasing membership equates to decreased budgets, it is that simple.

As example, at this time, our Permanent Finance Commission is working to address a projected <u>\$93,000</u> budget-deficit for operating next year, which begins 1-October. Work continues and it's not easy. The Administration & Advisory Commission, along with our department leadership, has extremely difficult decisions to make but, together, we will seek the means to provide a zero-deficit budget to our membership at convention. And, frankly, it may be a short-term fix over a long-term solution.

Thus, we need a strategic plan that will address organizational and functional utility that strives to realistically meet our ability to deliver on our four pillars. It requires significant changes to how we have historically functioned. In a broader vision, as a department, we need to develop the means to further minimize nearly all paper processes. This includes membership cards. And, it includes using technologies available for Department to conduct *direct renewal solicitation* to members throughout the Department in further supporting posts.

We must improve efficiencies by leveraging the investments on technology, and drive overhead and routine business costs down. This includes actions such as: increased virtual meetings; shorter headquarters' office hours; teleworking; web-serviced business center operations; substantially decreasing travel budgets or shifting to stipend-only; significantly cutting down copy and print services; reorganizing downward from 10 districts; and, more. While some of these actions may seem new, they really are not. They are industry standards in the private sector and in government.

I will support the department commander and will work to achieve strategic leadership improvements that strengthen our Department. I look forward to working with our Department and American Legion Family leadership, and with you, in moving our Department forward.

"The work is still not yet complete, but the agreement between Senate Veterans' Affairs Committee Chairman Jon Tester, D-Mont., and ranking member Jerry Moran, R-Kan., is proof that Democrats and Republicans can achieve great things for veterans when they work to put country ahead of partisanship," American Legion National Commander Paul E. Dillard said. "The Honoring Our PACT Act would deliver needed benefits for up to 3.5 million veterans who were exposed to the poisons of war due to the prevalence of burn pits, radiation, contaminated water, Agent Orange and other toxicants during deployments and military assignments. The House of Representatives deserves great credit for passing this legislation, and I am confident that with the continued support of The American Legion, the Senate will now follow suit. #### **Cases in Point**

Tennessee Legionnaire Walter Culberson lost his job when the pandemic hit.

The American Legion responded by providing him with a one-time grant that paid for two months of utilities, food and gas. It was the lifeline he needed until he got a new job and could provide for his family once again.

From June 2020 to April 2021, Oklahoma American Legion Post 88 anticipated the need for benefits assistance during the pandemic.



to "honor those who sacrificed everything." Hosted by the Vietnam War Memorial Fund, the event was held at NW Events in Hillsboro.

Moreover, the event seeks to jumpstart efforts underway by Vietnam Memorial Fund to raise the necessary funds to place a Vietnam War Memorial on the Oregon State Capitol grounds in Salem.

Fund-raising was slowed during the recent pandemic but is now back on course and pressing onward. Event coordinator Dan Mason stated that \$80,000 was raised during the evening dinner program, and more donations were still being tallied. In addition to those in attendance at NW Events, the program was also live-streamed to support donors who could not attend the event in person.

The full course dinner, featuring Cornish game hen and salmon steak, was followed by a brief welcome from Hillsboro Mayor Steve Callaway.

The evening's program featured reflections of war experiences encountered by a slate of Vietnam veteran speakers, which included:

Commander Douglas Sheehan, United States Coast Guard (Ret.),

Captain Greg Wooldridge, United States Navy (Ret.) and

Captain Steven J. Ahlberg, United States Navy (Ret.).

The keynote address followed and was given by General James N. Mattis, United States Marine Corps (Ret.), who also served as the 26th U.S. Secretary of Defense under then-president Donald J. Trump.



General Mattis' address focused on the sacrifices made by soldiers, sailors, airmen, and Marines during the war, which sought to halt the domination of communism in Southeast Asia. In doing so, he also shared how families and loved ones at home were also encumbered with sacrifices, which are often overlooked.

Noted during the evening was the presence of Gold Star families in attendance at the event.

Mattis, born in Pullman, Wash, graduated from Richland High School and attended Central Washington University. He shared that he declines 98% of the speaking engagement requests he receives but that returning to the Pacific Northwest for this cause was more than worthy.

Members of The American Legion Family from the Department of Oregon as well as the Department of North Carolina were in attendance and sponsored a table to support the cause, further creating a legacy of remembrance for Oregon's Vietnam Veterans.


