S. FLYNN PHILLIPS If you remember, DEPT ADJUTANT Membership our Chair Dan Burks spelled it out pretty well back at the DEC in Burns, Oregon. We need about 6000 members department-wide to be where we need to be budget-wise, or a constant inflow of donations to cover operations. The projected membership number is what we use to base the budget on, and it has declined steadily over the years. But there is still a considerable population of Veterans to tap into right here in Oregon. So you see, increasing membership is so much simpler. It allows more veterans to get involved in the greatest Veteran's organization.

Think back to *WHY* you joined the Legion and tell others why you joined the Legion. That positive attitude will rub off on the very people we need in our organization. Membership will grow, and you can feel comfortable that our legacy will continue when you die. So, my fellow Legionnaires, the rest is up to you.

All District Commanders and Department Officers have attended meetings on our reduced Department income with declining membership, and our other sources of income have been reduced, and our expenses have increased. We have held discussions and have a plan which is achievable. A resolution was presented at a special Department Executive Committee (DEC) meeting and approved to go forward with our plan. Information has been presented by your District Commanders at District your District Meetings and from Department Officers and through this publication and our Department electronic communications. Each Post has received a flyer with the Commanders Challenge for your Post and Members asking for your assistance in the form of donations.

Repeated, District Commanders and New District Officers, 990 Tax filing for your Posts are on your Post assessment sheet. There are no exceptions. All Posts must file their 990 taxes. We, Department, and Posts are under the National Umbrella and Group Exemption Number 0925, our 501c19. Remember, every Post is a separate corporation. It is



a business, PDC, Bob Huff and you DEPARTMENT FINANCE OFFICER operate under the Corporate Laws of Oregon. You pay a filing fee each year to the Secretary of State, Corporation Division.

Remember, the Oregon American Legion Foundation is a 501©3. Contributions are tax-deductible, and funds are used for our programs. There is a lot of information and grant requests on our Web Site. Department Program Chairs, there are grants available for most of our programs. All you must do is apply for them. We have our Foundation, which is a 501c3 which grants can be made out to earmarked for your Program.

Remember these facts from the National Judge Advocate when your Post decides to have some items with the American Le-

gion Emblem on them.

**Legion emblem**. The use of the emblem or brand mark by an individual Legionnaire is limited to wearing the

official insignia and possessing authorized jewelry or merchandise bearing the insignia. Posts are confined to using the emblem or brand mark, or reproduction of the emblem or brand mark, on stationery, Post publications, notices, posters or place cards, or matters of similar character used in the ordinary routine and conduct of legitimate post business. Any other use of the name "The American Legion" or the emblem/brand mark shall be subject to the approval of the national adjutant.

For frequently asked questions about the emblem, please visit <u>www.legion.</u> <u>org/emblem</u>.

If you have something specially made with The American Legion emblem that wasn't made through Emblem Sales and wasn't approved by the National Adjutant, there are some legal ramifications.

The name, brand mark, and emblems of The American Legion are registered service marks in the U.S. Trademark Office and protected by criminal and civil provisions of federal law (18 U.S.C.S. 705 and 36 U.S.C.S.S. 21704 and 21705). "What this says is that it's illegal to manufacture the emblem of a veteran service organization without the written consent of that organization,"

LARRY HILL Post 16, other DISTRICT 9 COMMANDER I-5 posts, the Douglas County Veterans Forum, have joined forces with Vietnam Veterans #805, who this time are spearheading the save the Roseburg VA Hospital from extinction. For the past four efforts, the Legion was at the "tip of the spear". We obtained some favorable actions, and when the director moved on and was replaced, all our work went away. Then 3 or 4 years later, there would be another frontal assault on the hospital by VA - trim services, move services to Eugene, and numerous other actions that have resulted in the gutting of the hospital. Almost all specialty clinics are now in Eugene, and the building continues in

Roseburg, but the question is why. There are no inpatient beds except for 28 or so for dementia care. The dental clinic now has four dentists, and they are overbooked but still here. And so, it goes. More information can be supplied upon request.

VVA leadership met with their National Commander and staff about three weeks ago, and they have agreed to champion our (Roseburg's) cause on a national level. Roseburg will be the prime example of the deterioration of the state of rural health care within the VA nationwide. So, it would also be great for other veteran groups to agitate for the cause. Good luck to those of you preparing for hunting season(s). See you all at DEC.

Along with Marc Chaney, Ward Allen, and Larry Horne, I attended the 50th National Convention of The Sons of The American Legion in Milwaukee, WI. While there, I completed Detachment Commander's training and participated in the VA&R meetings and Membership Meeting, where I received our 100% Detachment Ribbon. The Detachment of Oregon was 13th in the Nation at just under 107%. We did this through new members, and that is a good thing. But our retention rate was just 85% and should be at least 90%, so we need to work on that for 2023.

Congratulations to Seaside Squadron #99 for receiving the 2022 National Children & Youth Best Regional Report Award. I will present the certificate at their meeting on Sept. 13th.

The Detachment of Oregon received a citation for achieving and exceeding the \$2 per capita to the Child Welfare Foundation. That is great, but I think we can do better in 2023.

Looking at membership, we have 41 squadrons on the books, but only 31 of them are active. You could lose your charter if your squadron had a 0 membership for 2022. Please get the 2023 membership in and save your squadron. I sent 24 squadrons their membership cards before I left for the convention. I am still waiting for the other 7 to fill out and return their confidential report. Out of the ten squadrons with no activity, we are looking at pulling five and voting on another 3 to pull. We hope to rebuild Sheridan #75 and Salem #136 and charter a new squadron in Vernonia, Sweet Home.

DEC will be October 29TH in Springfield at 1 pm. I will send out details when we get closer to that date. Squadron Commanders should attend or have someone there to represent their squadron. Attendance has been down, and we need to turn it around.

When the PACT Act was stalled,

there were 34,000 letters sent to our representatives. In 4 days, the PACT act came out of committee and is now law. Can you imagine what the results would have been if every Legion member had sent letters to their legislative representatives?


an immediate needs requirement which we are also working with them on.



By Henry Howard Dave Berken-SEP 27, 2022 field had heard enough. He closed the binder full of PowerPoint slides, marketing slogans and colorful graphics.

"All you need to do is save one life, and that's it," the retired Navy SEAL said, zeroing in on a single word to brand and describe The American Legion's campaign to reduce the veteran suicide rate.

One.

Berkenfield understands why Be the One is important. He's lost a brother and fellow SEAL to suicide. Anyone can "Be the One," he says. Veterans, spouses, friends, civilians and caregivers all have the opportunity to save the life of one veteran.

"Be the one person to recognize that maybe you need some help or be the one person to recognize that a family member needs some help, or be the one friend who actually makes a phone call and asks someone how they're doing," says Berkenfield, an American Legion member and adviser on a "Be the One" panel. "You just have to be a true connection with someone who needs it. That's what Be the One is about."

At its core, the campaign aims to increase awareness of the veteran suicide epidemic, destigmatize mental health counseling and develop solutions.

Be the One also encourages veterans to ask for help when they need it.

Bergenfield's advice to family members, caregivers and friends is to not wait until the veteran says things like, "I'm selling everything in my house," "I'm drinking myself under the table" or "All my relationships are failing." Instead, pursue a connection early on to build trust. "Once you start getting in front of that, veterans know they have a support system."

There's no one-size-fits-all guideline for creating one's own support system, though. Berkenfield found his working for Chip Ganassi Racing (CGR), running its Extreme E program. He travels worldwide with the all-electric, off-road program, which promotes awareness of electrification as well as women in motorsports. While he's still part of a team, he says the stakes were higher when he was serving in uniform.

"There are levels of accountability in the special operations community and in the whole military that are higher than most other organizations," he says. "Life-or-death moments are there. If I'm a parachute rigger in charge of packing my team's parachutes, their lives are in my hands. There's a million versions of



that throughout the military. But for someone, say a hedge fund manager, It's not life or death."

Both the racing team and SEALs, though, require every member to prioritize the group over the individual. Berkenfield is on a mission to further solidify that teamwork at CGR. He's developing a wellness program to help forge bonds among teammates while easing their stress and improving their performance.

The American Legion is also a way for veterans to find the camaraderie they often miss after separating from the service.

# **American Legion News Clips**

Good morning, Legionnaires and veterans' advocates, it's Thursday, September 29, 2022.

# Today in American Legion history:

**Sept. 29, 1920:** The American Legion Committee on Americanism becomes a national commission.

**Sept. 29, 1926:** Billed as the world's largest and fastest ferry boat, *The American Legion* is launched from the yards of the Staten Island Shipbuilding Co. *The American Legion* can cross from Staten Island to Manhattan in an unprecedented 15 minutes.

Sept. 29, 1946: A.R. McAlester Memorial Band of Harrowed Post 5 in Joliet, Ill., claims its first Lemuel Bolles Trophy, awarded annually to the first-place band in The American Legion National Convention contest. Post 5 would go on to win the trophy 22 of the next 24 years; Joliet Post 1284 would claim first place at the convention 11 times between 1971 and 1997; and Joliet Post 1080 would win it in 2003, 2006 and 2007, making Joliet the perennial home of American Legion band championships.

**Sept. 29 - Oct. 2, 2014:** After 11 successful Veterans Crisis Command Centers throughout the country from Charlotte, N.C., to Honolulu -The American Legion shifts the message of its outreach program to better reflect efforts by local VA staff to assist frustrated veterans. Renamed "Veterans Benefits Centers," the events continue through much of 2015. Hundreds of veterans and their families receive firsthand assistance and more than \$1 million in overdue retroactive disability benefits are paid to veterans whose cases were bogged down in the system.







Anyone who has served federal active duty in the U.S. Armed Forces since Dec. 7, 1941, and has been honorably discharged or is still serving, is eligible for membership in The American Legion.



# Happy 247 years



A 13 October 1775 resolution of the Continental Congress established what is now the United States Navy with "a swift sailing vessel, to carry ten carriage guns, and a proportionable number of swivels, with eighty men, be fitted, with all possible dispatch, for a cruise of three months...." After the American War of Independence, the U.S. Constitution empowered the new Congress "to provide and maintain a navy." Acting on this authority, Congress established the Department of the Navy on 30 April 1798.

In 1972, Chief of Naval Operations Admiral Elmo R. Zumwalt authorized official recognition of 13 October as the birthday of the U.S. Navy. Since then, each CNO has encouraged a Navy-wide celebration of this occasion "to enhance a greater appreciation of our Navy heritage, and to provide a positive influence toward pride and professionalism in the naval service."

13 October 2022 will mark the Navy's 247th birthday. The central theme of this year is "On Watch - 24/7 for 247 Years," which highlights our Navy's enduring ability to remain fully ready to respond to and effectively deter emergent threats.

The American Legion was chartered and incorporated by Congress in 1919 as a patriotic veterans' organization devoted to mutual helpfulness.

In 1944, President Franklin D. Roosevelt signed into law the original GI Bill, or Servicemen's Readjustment Act, ushering in monumental changes in U.S. society. Six months earlier, The American Legion wrote the first draft of what later became the "GI Bill of Rights" – considered The American Legion's single greatest legislative achievement. Higher education becomes democratized after 8 million veterans go to school on the GI Bill, get better jobs, buy houses in the suburbs and raise families.

Today, more than 2,000 high school students annually participate in The American Legion's Junior Shooting Sports National Air Rifle Championships at the Olympic Training Center in Colorado Springs, Colo. The first event was held in 1991.

The American Legion provides free, professional assistance -- for any veteran -- in filing and pursuing benefits claims before the Department of Veterans Affairs.

Since 1938, The American Legion National High School Oratorical Program: "A Constitutional Speech Contest," has presented participants with an academic speaking challenge that teaches important leadership qualities, the history of our nation's laws, the ability to think and speak clearly, and an understanding of the duties, responsibilities, rights and privileges of American citizenship. Many politicians and news anchors have been participants, including CNN anchor Lou Dobbs.

There are nearly 2 million members of The American Legion, making it the nation's largest wartime veterans service organization.

The American Legion donated \$1 million to the Vietnam Veterans Memorial Fund for construction of the Wall in Washington, becoming the largest single contributor to the project.

# Facts About The American Legion

The American Legion announces its sponsorship of an independent study on the effects of exposure to Agent Orange on Vietnam War veterans. Congress receives the results of the "American Legion-Columbia University Study of Vietnam-era Veterans" in 1989.

Approximately 20,000 young men annually participate in Boys State, a Legion program dedicated to promoting leadership. Boys State alumni include former President Bill Clinton, news commentator Tom Brokaw, professional basketball player Michael Jordan, astronaut Neil Armstrong and many more

The American Legion has more than 12,000 Posts in communities throughout the United States. In addition to Posts in every state, The American Legion has Posts in the District of Columbia, France, Mexico, Puerto Rico and the Philippines.

On Aug. 9, 1921, a Legion-led effort resulted in the creation of the U.S. Veterans Bureau, which later became the Veterans Administration.

The first "Flag Code" is drafted during a Legion conference in Washington in 1923. Congress adopts the code in 1942. Today, The American Legion is at the forefront of efforts to pass a constitutional amendment to protect the U.S. flag from physical desecration.

In 2010, The American Legion's Operation Comfort Warriors program won first place and \$250,000 in PepsiCo's Refresh Everything Project. OCW received the most votes in an online contest and defeated hundreds of other groups and charities to take first place.

Legion Baseball was formed in 1925 during an American Legion South Dakota Department state convention. By 1926, Legion Baseball posts in 15 states developed. Today, the program registers more than 5,400 teams in all 50 states, Canada and Puerto Rico.

Since 1919, American Legion Posts have sponsored more than 2,500 Scouting units across the country. Annually, The American Legion honors an Eagle Scout of the Year with a \$10,000 scholarship.
