Members of the department executive committee hereafter referred to as the DEC as using these standing rules are as set forth in article seven, section one of the department constitution and article four, section two of the department bylaws. Minutes of the previous meeting shall be sent to all DEC members at least 15 days prior to the meeting date, the meeting agenda shall be sent to all DEC numbers 15 days prior to the meeting date. Roll call shall include to pass department commanders, a voting member of the DEC may request a suspension of the standing rules that a non-member of the DEC be given the privilege of the floor for the privilege of explanation of a specific proposal that has been proposed to the DEC and is under discussion. Time shall be limited to five minutes. However, additional time may be granted to answer pertinent questions.

Speaker 9:

A two-thirds affirmative vote of the members of the DEC shall be required for an extension of time. All requests for expenditure of funds in excess of the budget of law adopted at the annual convention shall be sent to the DEC members and the members of the permanent finance commission at least 15 days prior to the DEC meeting date and must be in resolution form. The proposed annual budget as prepared by the permanent finance commission shall be sent to the members of the DEC not less than seven days prior to the DEC meeting. Voting shall be by roll call on all resolutions in the following order to street commanders, department first vice commander, excuse me, department second vice commander, department finance officer, junior pass department commander and national executive committee. The department commander shall vote only in the case of time. Members of the DEC shouldn't submit their reports in writing and reports shall be limited to five minutes and a copy of the same be given to the department administrative assistant.

Speaker 9:

All chairman of department standing commissions and committee shall submit their reports in writing. All motions must be originated by a voting member of the DEC all codes of procedures shall be submitted in writing to members of the DEC at least 15 days prior to the date of the fall DEC meeting. The standing rules may be suspended for a specific cause by a two thirds affirmative vote of the DEC members present. The advanced time notices are waved for the post convention DEC meeting. Any time a poll is needed, the depart management shall send out a letter of explanation with a ballot to be returned within five working days.

Not that they can't be flexed for whatever reason. Part of the challenges we had this year is we'd run from one quarter to the next and the district meeting dates were never firmed up. So please do that. The last item I've got, what am I going to be doing this year? Buddy check engagement, buddy check engagement. I'm working to increase our visibility at the department level while chairman Dan, your second vice working boots on the ground with the membership and post activities. Commander, that's my report.

Before we go onto the second vice commander's report, something came to mind. I was remiss telling you, not giving you all of the information about the up and coming Legion College, and I will be sending out an email to all the district commanders who I would appreciate they also provide it or provide that information to anybody in their districts that wants to come, but I'll get that out within the next couple of days. And so now we can hear from the second vice commander.

Speaker 7:

Thank you commander. This year, I haven't had a chance to speak with Lou New Becker, our Americanism chair, just because he had his own surgery. So immediately following this DEC I will be getting a hold of him, formulating a plan on making sure that he has everything he needs so we can push forward with programs and help him grow this year. For membership, again, I am going to be the membership and post activities chair, so we will be holding monthly meetings and district commanders I would expect that you'd make every effort to attend them, especially since we do them virtually along with you or in your place, please have your first vice or membership chairs for the districts, those are very important.

Speaker 7:

As soon as you can and following this meeting, once you guys establish who your membership chairs are going to be for the district, please get me their information, their email addresses. As I put out reports, I like to get it out to all of you. We are doing things just a little bit different this year, as we're going to have more than just the normal five people on the membership commission, and most of them are going to be stationary and calling around and helping assist you guys with stuff like revitalization, buddy checks and renewals. So with that being said, commander.

Next report will be from the department finance chair.

Commander report, Bob spoke, you're going to ask you question. You set the dates for Legion college and I'm not sure you're aware of that, there is could be some field of track in Eugene and you will not get a hotel. Members of the DEC, in front of you'll have a copy of the budgets, but I'm going to cover a couple other items before. This is not the one that was handed out at convention because we have voted on several things and they're incorporated in this budget. First, excuse me, our budget year has been changed. We changed it a couple years ago with the IRS and we will be not being able to change that for the next 10 years. Our budget, the existing 21/22 budget goes to the end of September 30th and the new budget that we just voted on and approved starts on 1, October. The budget that you have as a district commander is for DECs. It is for your hotel rooms at the DECs, it's not if you have budget money, which I'll get to, I'm doing all the good stuff first, if you are traveling in your own district, which you're supposed to, and you should be visiting all your posts at least twice during your term and doing assessments of those posts.

Bob:

If you're getting funds, those funds come from your own district, they do not come from department. The budget on this sheet is for these DECs and this convention. When you're doing your visitations, and by the way, this will be in every Legionnaire, and every time I talk during the year, and a lot of you are very familiar faces and we've done this before, you need to check that your posts have submitted their taxes for that year. A lot of our posts, because we don't have a lot of big posts are able to do 990 Ns. If

they do not do that or their other taxes, they will get a very nice letter that says that their EINs are revoked. And we've gone through this a lot. And I know one person here has asked me to check on their post, which I will, when I get back to my computer. There are other things on that visitation sheet that you need, questions you need to ask and fill out and please do it, it's part of what we do.

Bob:

And I'd like to reiterate on something that our NEC said, The Legionnaire and I was a district commander for three years, and at that time we put articles in all the Legionnaires and we would tell our members when our next DEC meeting was and the other things that we're working on and the good things that happened at a lot of our posts, Paul post, I don't care which district, we have some posts doing some good things. And at the same time, take a picture, send it to our adjutant and get it so everybody in the department knows what's going on. This which item that you have right here is an approved for our next budget for 22/23. It says proposed because it wasn't approved until we were in this meeting. Also in this budget, and I know Tim asked me about the actuals, the actuals go through April, the numbers that we had of money that was already spent.

Bob:

If you go back, and this also is for the chairs. If you go back to your item where it says district commanders, we had a lot of people, a lot of the previous chairs and district commanders, and they were called and they were asked to submit their budgets and did not submit any budgets. So there will be no funds there. And then of course, we had a few that said we don't need any money. And yet those programs, the next person may need the money.

Bob:

So what ends up happening, if you are going to need funds after October the first, you need to put in a resolution for that money and probably talk to somebody else to where the money is, that's going to be a little bit of an issue. So please look at these, please submit your reports. And I know Richard and I, when we were district commanders, and I know I'm not supposed to speak to you because you're out there, but we used to do assessments and doing the assessments like John is talking about where, and we all have posts in our district that have not been functional.

Bob:

And I know when I took over as a district commander, I walked into a post and didn't know I couldn't take their charter, but I took it because everybody was drunk at the meetings and there was no American flag that I made out the assessment and made the commander, I sent everybody home and had them come back the next morning and had the commander sign the report that they will not drink. But when you do the assessments, it will tell you the condition of that post. And some posts are doing stuff that are, I mean, it's good stuff, but you need to do the assessments. We need to get back to where we're in the post. Yes, these are the things that we need to do. And if that, if there's any questions I will take them or everybody has my phone number. If you don't, I will give it to you because I am available to talk to you at any time. Commander that is my report.
