We will count those on the unit, the post that you're currently in. Distinguished guests, I'd like to recognize Ralph Bozella, who has joined us, our National VA and our committee. Thank you for joining us. Well, it's that time of year. Thank you for the opportunity. Oh, I'm looking back there. I see we have our SAL Alternate NEC, Larry Horne. Good to see you, Larry. Okay. This week we had the opportunity to host the national commander who came to join us. We went to visit several posts on Monday in District One, and then District Two on Tuesday. During that time period, he talked significantly about the legislative work that the national organization has done for it. It's very clear listening to the responses from the people in the post that they don't realize how much work national really does to take care of veterans for us. His example, as he traveled, was the Pact Act, PACT. I cannot remember the acronym that stands for.

Terry Brown:

Political Action Committee.

Don Weber:

No, no. The Pact Act is PACT. It's a legislative action to protect veterans who have been exposed to toxic exposures on all deployments. It covers all war areas and it eliminates the need to prove that they were in a designated area that had that exposure. In the future, with the passing of the Pact Act, if they have the campaign ribbon, then they are covered by the presumed assumption of the exposures to all of the toxic elements, the air conditions, agent orange and anything else that is determined. That particular act was passed by Congress a couple of weeks ago. They sent it to the Senate. The Senate passed it with some modifications, which required it to go back to the Congress for approval of the modification. The national commander indicated that they fully expected the Congress to approve the modifications that the Senate had put on it.

Don Weber:

And in fact, this morning, the national commander received a call calling him back to DC. Last night Congress did approve the modifications from the Senate and it could potentially go to the president's desk tomorrow. So, he had to go back to DC for that. That's why he is not here with us today. It was indeed an honor to travel with him. The posts that we visited all did just an excellent job of sharing with him, the things that they do in their areas, the programs that they're working and the things that we are doing here in the state of Oregon. His comments at every stop were just remarkable. His visit was very productive and I certainly enjoyed being on it. I'd like to call on the judge advocate for reading of the standing rules.

Gene Hellickson:

Members of the department executive committee, here and after, referred to as the DEC as used in the standing rules are as set forth in article seven, section one of the department constitution and article four, section two of the department bylaws. Minutes of the previous meeting shall be sent to all DEC members at least 15 days prior to the meeting date. The meeting agenda shall be sent to all DEC members at least 15 days prior to the meeting date. Roll call shall include past department commanders. No other visitors will be introduced.

Gene Hellickson:

A voting member of the DEC may request a suspension of a standing rule, that a non-member of a DEC be given the privilege of the floor, for the purpose of explanation of a specific proposal that has been proposed to the DEC and is under discussion. Time shall be limited to five minutes. However, additional time may be granted to answer pertinent questions. A two-thirds affirmative vote of the members of the DEC shall be required for an extension of time. All requests for expenditure of funds in excess of the budget adopted of the annual convention shall be sent to the DEC members and the members of the permanent finance commission at least 15 days prior to the DEC meeting date and must be in resolution form.

Gene Hellickson:

The proposed annual budget, as prepared by the permanent finance commission, shall be sent to all members of the DEC not less than seven days prior to the DEC meeting. Voting shall be by roll call on all resolutions in the following order. History Commanders, Department Vice Commander, Department Finance Officer, Junior Past Department Commander, and the National Executive Committeeman. The department commander shall vote only in the case of a tie. Members of the DEC should submit their reports in writing and reports shall be limited to five minutes and a copy of saying be given to the department administrative assistant.

Gene Hellickson:

All chairman of department standing commissions and committees shall submit their reports in writing. All motions must be originated by a voting member of the DEC. All codes and procedures shall be submitted in writing to members of the DEC at least 15 days prior to the date of the fall DEC meeting. These standing rules may be suspended for a specific cause by a two thirds affirmation vote of the DEC members present. The advanced time notices are waived for the Post Convention DEC and any time a poll is needed, the Department Adjutant shall send out a letter of explanation with a ballot, to be returned within five working days.

Department Adjutant Flynn will get it published online quickly after convention. Please make sure that your home Posts get that. This year, Commander Don's theme was reconnecting veterans. That theme was born largely out of the pandemic and the COVID restrictions we've felt the last couple years.

Corey Brockman:

As I shared briefly at our Boy State and Girl State closing last weekend, comedian Milton Berle quipped once, "If opportunity doesn't knock, build a door." Comrades, I think that's where we're at right now. We can't wait for something to happen; we must make it happen. Opportunity doesn't always come knocking. I think we've had an outstanding year. I think we can do better. We can build on this year and take it the next step next year, both in membership. Congratulations to the membership and Post Activities Commission and the chair and the committee workers, but also all our youth programs. We're able to conduct youth programs this year, where we didn't last year. Just one quick note on Americanism. I do want to share in this, from these spring NDC meetings in Indianapolis. In 2022 first quarter flag sales were \$898,000, which was the largest first quarter for flags in the history of emblem sales and a 32% increase over last year. Just in the month of March, they had flag sales of just under \$500,000.

Corey Brockman:

Comrades, our flag is my pride flag and I hope it's yours as well. I know not all Posts in our Department are participants in the flag rewards program with Emblem Sales, but I strongly urge you to sign your Post up because you make money back for every flag sold by every member in that post. So, please get your Post signed up. We're not monitoring to you, but we encourage you. We want to collect some money to this weekend so, please do this.

Kevin Owens:

I would say the foundation has been very active this year. We've met every month. We've met every month, except this month, because we were at the convention. Just recently we attended the Hillsborough Hops game. Very productive. Thanks to Cory Brockman that happened to know somebody at the hops or had connection with them. We were able to go there on a veteran's appreciation night. We had a flyover by the Coast Guard helicopter from Astoria. We were interviewed for the big screen on the second inning. Fortunately, they had to interview me, but I don't know it turned out alright. We talked about one of the key issues that we're facing today and that's veteran's suicide. We talked about that. That's why we were there. The message is, be the one. Be the one, you be the one to prevent veteran's suicide. One veteran suicide is too many. Ralph will probably expand on that. He's very knowledgeable. I would encourage you to talk to Ralph about VA&R, veteran suicide. Anything you want to know about veterans, Ralph's the man, that guy knows everything, everything. He might not to say that.

Kevin Owens:

Ralph is very knowledgeable on VA&R. Please listen to his message tomorrow and encourage your members to stay in their seats and not wander off. He has a lot to say that's important and we're going to have a mixer on Thursday. Free to all of you. We're going to have a corn hole tournament. We had one last year. I think it was very successful. We had people that had never played corn hole in their life, won that tournament. We don't allow you to be ringers if you think you're good, Steve Shollenburg

Kevin Owens:

It's 10 bucks to join, to sign up. We expect everybody to sign up. We want you to sign up. It's fun. People laugh. We're having a good time. The best part of it is we're going to have free food and we know how much veterans love free food. Free, that's the key. Come and join that. Patronize the Post and let's support the Oregon foundation because that money gives back to your progress. We give 100%. We don't take money, we don't get paid, we don't get travel money, none of that. 100% of that goes to veterans. Please fill these buckets up. Let's them up every day. It doesn't take much. A dollar quarter penny. So, with that Commander, that's my report and go Yankees.

Don Weber:

I'd like to call on the Judge Advocate to explain the rules of voting.

Gene Hellickson:

Whenever we have a motion or a resolution, to present a motion, you need to be recognized by the chair or in this case, the commander. When he's asked for a second, you just don't say, I second the motion. You must be recognized by the commander and then you can say that you're seconding the motion. When we get into the discussion phase, the only person the person who has an item of discussion talks to is the commander. You do not talk to the person next to you. You do not talk to the person across the table. Everybody gets at least five minutes. One time. It goes around and when everybody that wants to speak has had a chance to speak, if somebody wants to speak a second time, they can. Okay? The other thing is... That made me lose my train of thought. Let me see.

Gene Hellickson:

The roll calls. All resolutions that affect money and other pertinent things require a roll call vote. The reason that this resolution, to move money around, didn't require a roll call vote, that one if it doesn't affect the money or anything like that, we don't necessarily have to have a roll call vote. A roll call vote can be called by any member. I think that was about it. When it comes to the time for somebody who would like to call the question, you do not sit there or stand and just say, question. It's the same thing. You must be recognized by the commander and then you can state that you're calling for the question.

Gene Hellickson:

The commander has the right to not agree to calling the question. If he feels that most of the people or people that really want to speak and haven't had the opportunity to speak, he can call that out of order, until he feels that everybody that wants to speak, can speak. When we go to discussion, one person can't just say, I call the question right away and stop everybody from speaking. We've been kind of sloppy over the years and we need to get back into trying to follow the Robert's rules of order on how we do some of this stuff. Thank you Commander.

Don Weber:

We'll call for the District reports and we're most interested in who your replacement will be for next year. District one.

Susan Hughes:

Susan Hughes, Vice Commander District One. Lou's report is in the book of reports. He is in rehab right now because he had his hip replaced. Next year's District one commander will be me.

Don Weber:

Congratulations.
