Resolved that \$7,434 excess of The Department of Oregon budget for 2021-2022, \$3000 Transferred to the Past National Commander Guest Fund budget line. \$1000 be transferred to the Oregon Legion College Training Budget Line. \$250 be transferred to Training and Development budget line. \$1000 be transferred to the Alternate NEC budget line. \$500 be transferred to the passenger van budget line. The remainder of \$1,684 be transferred to the Permanent Finance Reserve Fund budget line excess for the Department budget year 2021, and it be further resolved that this resolution be approved upon the Pre-Convention DEC in Hillsboro, Oregon, on June 22, 2022. Take effect and so implemented. I so move as Chair of the Permanent Finance Commission.
