I had the opportunity to join with NVC Uhrig and the Membership team on a District 1 revitalization. At that time we were successful in reactivating Tillamook Post 47, a century Post started in 1919.

We continue to experience membership declines that are, negatively, impactful to our budget. This decline has forced travel budgets for department officers and commission/committee chairs to be held, on balance, in reserve, as membership-income is below what was previously budgeted. Early projections on next year's budget may result in a similar reality, significantly decreased or no available travel funds for department officers and commission/committee chairs.

This in no way diminishes the importance of the work before us. What it does do is challenge us to seek innovative means as we continue to fulfill our mission. The questions raised should not be "what are we going to cut?" Rather, "how are we going to get it done?"

Membership impacts all levels of our organization and will become successful once more members choose to, proactively, support organized efforts to end the decline.

Outreach and engagement opportunities continue to be identified and explored, then acted on as appropriate, to continue increasing visibility of our American Legion. Our accomplishments and the programs and services we offer remain vitally important to elevate in the consciousness of the public, in its entirety (i.e., veteran and non-veteran communities). We have encountered some success in growing relationships but must continue to expand our efforts.

It's early still, but Tillamook #47 is being reinvigorated by patriots with a heart for their community and our American Legion. While the demographic, presently, appears to be similar to the national organization - "68% are age 68 or older" - they are re-energized in wanting to maintain a post. They are in need of support and nurturing and district leadership will be vital to their foundation becoming re-established.

ACTIVITIES and engagements include:

- Participated in 'Winning the Battle | A Veteran Mental Health Summit, held at Clackamas County Community College, Oregon City. "Be the One" initiative discussions were held with mental health providers in attendance.
- The national "Be the One" initiative continues to leverage our department's efforts and
  positive energy in supporting other engagements around the nation. Numerous media
  releases have showcased TOALF-funded and Legion Family supported Buddy Check
  and "Be the One" bracelet packs and "how to" activities. This includes national news
  distributions with Legion.org, American Legion Online Update, Digital Dispatch, and
  social media postings on national American Legion Facebook and Twitter accounts.
- "Be the One" and/or Buddy Check bracelet packs were requested by and provided for outreach/engagement events for Crook County Post/Unit #29; John Kalmbach #90; Aloha #104; Korea Defense Veterans Association (KDVA); Hillsboro #6; and, Blue Star Mothers/Liberation Veteran Services, in VA, requested two dozen for an event being supported.

- *TALMA Training Tuesday* I provided a 35 min session on Dept of Oregon "Be the One" activities focusing on how smaller communities can increase engagement.
- Participated in NVC Doug Uhrig (WY) visit to Department of Oregon in support of the D1/Tillamook #47 membership event. The revitalization efforts included face-to-face walk-up contacts as well as telephone contacts of existing members and Post 114 members.
- National Veterans Wheelchair Games (NVWG) Grassroots work is underway on planning some level of outreach and engagement with disabled veteran athletes that will participate at the 2023 NVWG in the greater-Portland area, July 4-9, 2023. Considerations include hosting a booth; a department 'welcome packet'; a mixer/meetand-greet at a post; and, leveraging NHQ involvement to improve future relationships between NVWG and our organization.
- Legislative I have been appointed to the National Legislative Council and assigned as national congressional liaison to Senator Ron Wyden. A phone contact was made with Senator Wyden's Portland office, via voice message, with a near-future visit to the office planned.

Congressional contacts made through Legislative Action Center (LAC) include legislation support for passing Senate Bill 316 which calls for repeal of the 1991 and 2002 Authorizations for Use of Military Force (AUMFs), to Senator Merkley and Senator Wyden.

- Continuing support and contributions to Permanent Finance Commission (PFC) and The Oregon American Legion Foundation (TOALF).
- Attended the virtual component of the Roseburg VAMC "Women Veterans Town Hall," which focused on holistic care for female veterans and efforts to attract and maintain female health providers. Other topics included Serve Act, PACT Act, mental health, weight management and nutrition, and more. 12 veterans/10 employees onsite and 11 virtual. POC Jessica Burnett, LCSW, Women Veterans Program Manager, Roseburg VAMC (jessia.burnett2@va.gov).

The Post Delegates will cast their vote for adoption. This is required by our Department Constitution and By-Laws. Our Department Budget Year is October 1 through September 30. This is also our Department Tax Year which is being submitted now. Lower membership does affect our Department Budget and what we are able to do to complete our mission and our commitments to our Members and Veterans Community. Our plan for our 2021-2022 Department Budget was for increased membership and matching funds to offset our shortfall as agreed in our Spring DEC and Department Convention. We have not accomplished that requirement in our plan. We had to revisit our budget, which we do monthly throughout the Budget year which is part of that plan, we cannot

have a negative budget. As we put this Proposed 2022-2023 Department Budget together, we were required to reduce our Membership income to support our actuals and make further reductions in expenses. We need to work on our membership, there are plenty of opportunities in our Department for growth. We are holding several events this year in which we have the opportunity to develop new members and new opportunities for growth. Several Posts are active again and are doing programs, doing a good job for their members and their communities, and holding events. The Post also held a Saint Patrick's Day party for members and family. The menu included the customary corn beef & cabbage dinner and a green beverage. Members are very appreciative of the tremendous amount of planning and work our Adjutant, Mark Cole, did to make these festivities so enjoyable by all.

Post 70 Glen Morrison (Cave Junction) 70: The Post is in the process of adding two new members and currently stands at 26 members. Mr. Roger Brant, a city official for Parks & Recreation, has asked Post members to assist in moving the WWI memorial and flagpole off of private property to a city owned location, Jubilee Park. He also plans to include a memorial site recognizing our American Legion Post 70 at this site. The Commander, Bob Soria, is working with Mr. Grant on writing grant requests to cover expenses.

This will include a memorial ceremony at the park and at the City Hall the following Monday.

Members of the Post attended the memorial service and funeral for Post 14 40+ year member, Ron Fuller, at Eagle Point National Cemetery.

Members continue doing buddy checks. Three members have been moved to memory care in Brookings.

Coming out of the Covid-19 disaster, officers are meeting to plan events to increase interest and to motivate members to become active again in our rural area. The Covid-19 disaster and the wildfires that occurred in our area have devastated our membership resources.

The Post is hosted the Welcome Home Vietnam Veterans Event at the VA SORCC in White City on Wednesday, March 29<sup>th</sup>, at the Community Center.

1. Department membership continues to remain stagnant. Minimal membership growth continues to be a significant factor effecting our Department's financial stability; impacting incoming revenue, Legion programs, and revenue enhancement programs. Some voluntary monetary donations have been received to counter the loss of revenue that would normally be generated by membership growth. However, the enthusiasm and purpose for donations and membership growth seems to have wilted. Our Department has only one way to go, and that is **UP**!! We have the potential. "*There are only two options: Make progress or make excuses.*" Anonymous

2. The Department Headquarters office budget is a sizeable part of the Department budget even with the continuance of a declining membership. However, reality has arrived! Our will to grow membership has lessened and so has our operating capitol. Department officers and program chairpersons have been or may be asked to employ their personal creativity and generosity to perform their duties and responsibilities. While open to suggestions, A/A Commission members are exploring where possible administrative costs could be trimmed in the headquarters budget and still be able to maintain a feasible Department Headquarters operation. It is only prudent that A/A re-look at Department's administrative costs that could be a potential savings. "If you don't sacrifice for what you want, what you want will be the sacrifice."

3. Every member across our Department must realize we cannot continue to function with a declining ration of dollars to membership. Every day our Department nears the certainty that if we don't change the way we do business in Department of Oregon, we are not going to overcome our financial challenges. Turning our backs on our fellow veterans, our youth, and our America would be out-of-character for The American Legion Department of Oregon.

4. Minutes of proceedings are official record of actions taken during Department of Oregon's Annual Convention. Minutes, DEC or commission/committee meetings, summarizes topics of discussions, decisions, votes on specific motions, activities, administrative information, date/time of meetings and names all attendees. Meeting minutes serves a historical purpose, a legal purpose while documenting a group's adherence to the proper procedures and organizational Constitution and By-Laws, Code of Procedures, Policies, State and Federal guidelines. Minutes and recordings made during a meeting are discoverable in litigation. The Department Commander and Adjutant have been working on previous minutes of Department Executive Committee (DEC) meetings and Department Convention proceedings (2022 Pre- and Post-Convention DEC meetings, 2022 Department Convention proceedings, September 22, 2022,

virtual DEC meeting, October 30, 2022 DEC meeting, and 2023 Mid-Year Virtual DEC meeting) that will be presented for DEC approval at the Spring DEC meeting, April 15-16, 2023 in Redmond Post 44. The A/A Commission will be putting forth resolutions to amend the Department Constitution and By-Laws regarding Department Executive Committee meetings and Department Convention proceedings.

1. There have been three Boys State Committee meetings since the Winter DEC; February 13,

March 13, and April 10.

2. The following High School Counselors have been contacted by Committee members and Post members in recruiting efforts; McNary High School in Keizer, St. Helens High School in St. Helens, Central Catholic High School in Portland, McMinnville High School in McMinnville, Newberg High School in Newberg, Sheridan High School in Sheridan, Reynolds Learning Academy in Troutdale, and Centennial High School in Gresham. In most all cases the American Legion was welcomed and generated 5 Boys State applications.

3. To date there are 8 applications on file @ Department Headquarters from Oregon & 2 from Washington. We are expected to receive an additional 15 applications this month for a total of 25, representing a growth of 47% in 2022. It is further hoped that our citizen population will be around 40-50 citizens for the Class of 2023 (a growth of almost 300%).

4. We have secured commitments from 3 State Legislative Officials, 2 Attorneys, and 1 Mayor plus a City Manager to attend as Guest Lecturers and participants, with a retired Multnomah Circuit Court Judge being used to swear in the 2023 Boys State elected officials at their Graduation exercise.

5. At the request of the USMA (West Point) 1 Post facilitated the attendance @ California Boys/Girls State for a young lady from Oregon.

6. Theme days have been established for the Week; Monday is Press/Publishers Day, Tuesday is Educators Day (High School Principals & Counselors/Instructors are invited), Wednesday is Alumni Day (any previous Boys Stater is invited), Thursday is Post/Sponsors Day (any Legion member or Business Sponsor is invited).

7. The largest obstacle facing Boys State continues to be Post involvement. At this point, we have only maybe, maybe, 10 Posts throughout Oregon involved, which represents about 8% of all Posts in the State.

Attached is a MicroSoft WORD document file containing my report on the outcomes of the Preliminary Round / State Championship of the 2023 American Legion National Junior Three-Position Air Rifle Tournament, with a focus on participation by Oregon youth, to date.

In 2022 there were 18 individual sporter air rifle competitors from Oregon, and in 2023 there were 17 individual sporter air rifle competitors from Oregon.

Nationally, there were 485 sporter air rifle competitors in 2022, and there were 545 sporter air rifle competitors in 2023.

In 2022 the highest-scoring competitor from Oregon was ranked second in the nation, and in 2023 the highest-scoring competitor from Oregon was ranked ninth in the nation.

In 2022 the highest-scoring team from Oregon was ranked sixth (out of 101 teams) in the nation, and in 2023 the highest-scoring team in Oregon was ranked sixth (out of 77 teams) in the nation.

In both 2022 and 2023 there were one individual sporter air rifle competitor and one fourperson team from Oregon invited to the second round.

1.1. The audit of the available records through March 2023 for the 2022-2023 membership year, thus far, has noted that Department, District, and Post reports on file at Department are mixed results for completion of required reports. Many, many reports are missing completely, or incomplete. Examples include: Not all entries entered on the forms, no signatures, only some officers listed, only one committee identified, etc.

As of being three-quarters-way through the membership year, there still have only eleven (11) Post Analysis Reports been documented of the 112 posts in the Department.

1.2. District Meetings. District meeting minutes on file at Department reflect situations, where in some districts an insufficient number of posts attending are resulting in that business

For those Districts that have produced minutes, it appears at least two-thirds of the posts in those Districts are reporting activity, but what of the posts not attending District meetings, and of the Posts for which Districts have yet to send District minutes to Department.

This combined with the use of virtual formats in conjunction with self-study, and meeting-style classes may be the future in the immediate term.

These proposals are still in the ideas stage, and the Training and Development Committee looks forward to any input that Department members offer for suggestions in types of training and content.

On the local level the 2023 session began on January 17, 2023. Both the House and Senate committees for veterans have added additional duties from previous sessions. The House has added General Government and the Senate has added Federal and World Affairs. The chairs for both committees did not change from last year. This year's committee members are a good mixture of past members, new members with legislative experience, and new legislative members. This year all meetings at the Capital are in person. I have been attending many of the meetings. This has given The American Legion a recognizable presence.

Currently there are 33 bills in the House and 17 bills in the Senate for veteran and military. The bills cover a variety issues, but the majority of the bills are around Taxes (veteran pensions, National Guard pay, property), and education. One of the high priority bills in the House is HB2147 which directs counties to designate person to ensure interment of unclaimed human remains of veteran. This bill is currently stalled in committee to gather information and verify numbers.

One of the educational bills was submitted by Nick Juarez of Post 104. HB2615 Allows veterans to participate in Oregon Promise program if first enrolled in classes within 12 months after discharge from military. Nick testified in person before the House committee. This bill became the first veteran's bill to pass the house and is now in the Joint Ways and Means committee.

I have been visiting as many post as possible to give information on the state bills and passing out fliers to sign up for alerts. The more individuals sign up and use the alerts the better our grassroots movement will be affective.

On the national front, the sessions are just getting started. 6 members of The American Legion and 2 members of the American Legion Auxiliary were at the Washington Conference the last week of February. Visits were made to all Oregon legislators or their staff to discuss the American Legion Legislative Agenda. Once again I want to remind everyone to sign up for alerts. It is quick and easy to sign up. You can sign up at <u>https://www.votervoice.net/AmericanLegion/home</u>. Both the Senate and House have now started to hold meeting and have passed a few veteran bills.

#### BILLS PASSED IN HOUSE

HR 502, by Rep. Banks (R-IN), concerning VA reimbursement of educational expenses;
HR 815, by Rep. McMorris Rodgers (R-WA), the RELIEVE Act, removing the requirement that a veteran must receive care from the VA in the previous 24 months to have emergency care covered if the veteran is within the first 60 days of enrolling in the VA health care system;
HR 753, by Rep. Bost (R-IL), the VA COST SAVINGS Enhancement Act, requiring each medical facility to have an on-site medical waste treatment system; and

• **HR 1226**, by Rep. Aguilar (D-CA), the Wounded Warrior Access Act, related to online ways to submit claims-related records requests.

All of the bills passed either by unanimous roll call votes or by a voice vote.

• On Tuesday, February 28, the House Appropriations Subcommittee on Defense held a hearing titled "Ukraine Oversight."

**Report** – The Technology Committee has met periodically at Department Headquarters and via telephone to review the status and security of our network and data. Larry Edwards and Flynn Phillips were in attendance.

We feel that our network and data are secure in accordance with current business practices. As our Network Server approaches the end of life in 2024 as state-of-the-art hardware we recommend replacing the current server with cloud support. This will require entering into a contract for cloud implementation, transfer of any stored data, and ongoing support and maintenance of software to achieve that goal. We feel this approach will be in keeping with the direction of industry standards and will result in a reduced overall cost of support going forward. This move will be compatible with the National strategy of The American Legion. If approved, the budget will need to be submitted for the coming fiscal year for hardware, software, and support.

Membership continues to struggle, I believe I have started each report and article this year with that same line. We continue lead the pack from behind moving into 49<sup>th</sup> place. Regardless of attempts we have been unsuccessful in getting any substantial momentum. Seeking advice from those who have gone before me as last year utilizing upbeat and motivational attempts left us even further behind. Switching to a more direct and stern approach was the only method that kept us moving forward. This year starting with uplifting, motivational even inspirational comments led us to the worst start we have had in a long time and swapping to the direct and stern approach has delivered slightly better results however not enough to get us back on track. We are 1 of a handful of Departments that has yet to hit a target date this year. M&PA held a meeting on March 15<sup>th</sup> regarding a Per Capita increase resolution. It was determined by a majority vote of the M&PA present that we should forward the resolution on to Convention due to the lack of membership and the lack of faith in increasing membership enough within a required timeframe.

M&PA held virtual meetings with National Executive Committeeman Kevin Owens, Department Officers, Department M&PA Commission Members as well as District 1 Commander and 1<sup>st</sup> Vice Commander. Purpose of the meeting was to establish a revitalization in District 1 starting at the District 1 meeting and securing assistance from District 1 membership. A couple of substantial hurdles jumped out but the team was able to pull it together and navigate fairly easily.

On March 10<sup>th</sup> M&PA embarked on a journey starting with picking up our National Membership Engagement Coordinator Michele Steinmetz from the Portland Airport and heading towards Aloha Post 104. March 11<sup>th</sup> we attended the District 1 meeting where the Commander then announced for the 1<sup>st</sup> time to her membership about the revitalization. This posed an issue as we had originally planned for a very small revitalization with a couple focal points, but as the District Commander told us she had secured 30 volunteers, plans changed and we brought a much larger work order. Unfortunately after the meeting was concluded, only the 1<sup>st</sup> Vice Commander Tom Miller attended from District 1 as well as 3 members from District 2, Renee Ohler, Mike Speer, and Ian Gerstel stayed to assist and be trained on how a revitalization was accomplished. Unfortunately this wasn't fully accomplished as we were prepared for a different work load. NMEC Steinmetz and myself then went to Tillamook where we were joined the following day by NEC Kevin Owens. We were able to knock on doors from our expired DMS list and get several to renew their membership. Later that evening were met by our Department Commander Larry Wittmayer who escorted our National Vice Commander Doug Uhrig to our location. Shortly after Department 1<sup>st</sup> Vice Commander Cory Brockmann and Auxiliary Department Vice President Catherine Brockmann arrived as well. The next morning we all met at Tillamook Elks Lodge which was our Headquarters for the rest of our stay where we were met by Department Membership Commission member Renee Ohler and Department Assistant Service Officer Jody Marsh. This team came together with 1 objective, rejuvenate Tillamook Post 47. Over the course of the next 3 days we ran a revitalization for District 1, Tom Miller District 1 1<sup>st</sup> Vice Commander assisted remotely and even District 2 jumped in and did some as well. During this time utilizing our NVC as a spokesperson, we were able to set up and meet with Tillamook School District Superintendent as well as Director of Scholarships, and then the NVC held an interview with the local Tillamook Newspaper. Next the NVC, NEC and Department 1<sup>st</sup> Vice spoke to the Rotary club, and presented Department of Oregon Challenge Coins to nearly all of the Tillamook Police Department. A meeting with the City manager led to an appointment and discussion held between the NVC and a City Councilman who is the city chair for Veteran Affairs and a vet himself. A meeting with the Veteran Service Office led to 2 of the 4 CVSO's in Tillamook to come to the Elks Lodge and inquire more from us and speaking with Jody Marsh for potential future collaboration. A guided tour of Pioneer Museum gained us some insight into the town and even produced archived articles about The American Legion in Tillamook. That evening NVC and NEC attended the Elks meeting, asking for and securing a meeting place for the new Tillamook Post 47 members to host meetings. Next we secured a meeting with Care Inc who has a Director that specifically handles veterans in need and homeless veterans and was attended by NVC, Dep 2<sup>nd</sup> Vice and Dep ASO. A lot about different programs available was discussed as well as our mission. We wrapped up this stay in Tillamook with hosting the 1<sup>st</sup> meeting Post 47 has had in over a decade with 16 members attending including a Past Post Commander. Conclusion of this meeting was NVC Doug Uhrig swore in a new Post Commander, New 1<sup>st</sup> Vice Commander and a new Adjutant. While this is a great accomplishment, recruiting, transferring or renewing 22 members for the Post, the work is far

from over. Tillamook will need support from every angle to ensure they thrive with all the excited members. Department and District 1 need to stay on top of this Post and offer any assistance we can and fuel their flame to make sure they don't die out again. I believe this method of revitalization can be duplicated throughout the Department and should be soon to help rejuvenate inactive Posts across the Department in lieu of closing so many.

# ATF Begins Publicly Posting Results of Federal Firearm Licensee Compliance Inspections Involving Violations of DOJ's Enhanced Regulatory Enforcement

The Department of Justice's Enhanced Regulatory Enforcement policy focuses on the GCA violations that pose inherent public safety risk.

#### Homeland Security Today

For the first time ever, the Bureau of Alcohol, Tobacco, Firearms and Explosives began publicly posting information, <u>available on the ATF website</u>, regarding the results of certain compliance inspections of federal firearms licensees (FFL) completed between July 2021 and December 2022. The data posted today involves ATF inspections resulting in the citation of an FFL for violation of a regulation identified in the Enhanced Regulatory Enforcement policy announced by Attorney General Merrick B. Garland on June 23, 2021. That policy, which is part of the Department of Justice's overall <u>Violent</u> <u>Crime Reduction Initiative</u>, identifies regulatory violations of the Gun Control Act that pose inherent public safety risks.

"ATF is committed to transparency," said ATF Director Steven Dettelbach. "Congress, by law, gives ATF the responsibility to inspect firearms licensees. The information released today will assist the public in understanding how ATF handles inspections where significant violations are uncovered on the part of firearms licensees."

ATF's core mission is to protect the public from violent crime, particularly crimes involving the use of firearms. An essential part of this mission is ensuring that FFLs comply with applicable federal laws and regulations, particularly the implementing regulations of the GCA.

FFLs are often our first line of defense against gun crime and are often a source of critical enforcement information that helps law enforcement identify straw purchasers and disrupt firearms trafficking schemes. FFLs that willfully violate the law, however, must be held accountable. ATF conducts inspections to ensure compliance with applicable local, state, and federal laws and regulations and to educate licensees on the specific requirements of those laws and regulations.

The Department of Justice's Enhanced Regulatory Enforcement policy focuses on the GCA violations that pose inherent public safety risk. These violations are:

- Refusing to allow ATF to conduct a lawful inspection
- Transferring a firearm to a prohibited person
- Failing to conduct a required background check
- Falsifying records
- Failing to respond to a trace request

When willfully committed, a violation of these GCA regulations will result in ATF taking action to revoke the license of the offending FFL, unless extraordinary circumstances apply. The data and information posted today identifies the number of FFL inspections that resulted in ATF issuing a citation for one or more of these violations between July 2021 and December 2022, and includes the Final Notices of Revocation for the 93 FFLs whose licenses ATF revoked for willfully violating these provisions.

The law allows ATF to revoke a license when the record shows that an FFL willfully committed at least one violation of the GCA or its implementing regulations. FFLs are provided due process throughout the inspection and revocation process, including the right to a hearing and to appeal a final license revocation in federal court.

Anyone who observes suspected violations of the GCA or ATF's implementing regulations may report them to ATF's tip line at <u>https://www.atf.gov/atf-tips</u>. ATF regulates the firearm industry and is the lead federal law enforcement agency with jurisdiction involving firearms and violent crimes. More information about ATF and its programs is available at <u>www.atf.gov</u>.
