The Future of VA Healthcare

The future of Department of Veterans Affairs (VA) healthcare is a hybrid system consisting of inpatient and outpatient care, telehealth, and community care. Ensuring VA is equipped to meet the unique needs of an increasingly diverse veteran population requires VA fully leverage all healthcare modalities and a seamless transition between them. Modernizing electronic health records, veteran-centric access standards, a transparent online scheduling system for VA-provided care and community care alike are essential to ensuring that veterans receive the benefits they deserve. The means by which VA delivers care may change, but one thing cannot – VA should continue to deliver the best care anywhere to our nation's veterans.

A critical component of modernizing VA healthcare is investing in its infrastructure. The average age of a VA medical facility is approaching 60 years old while the median age of a private-sector medical facility is approximately 11 years old. The changing nature of healthcare over the last 60 years, combined with shifting veteran demographics, has outpaced VA's ability to realign its infrastructure in accordance with patient demands. While the authorization of 31 major medical leases in Section 702 of the PACT Act was a critical first step in addressing VA's infrastructure demands, more must be done.

The Electronic Health Record Modernization (EHRM) program, another cornerstone of VA healthcare modernization, is expected to take about 10 years to implement across all VA facilities, with projected completion in Fiscal Year 2028. The recent acquisition of the Cerner system has been far from seamless and has come with a wide variety of challenges. For example, VA staff reported difficulties adjusting to the new system, due to a lack of proper training. In addition, it was discovered that the new system created an "unknown queue," a problematic feature that has caused referral orders to effectively go missing at VA. Moreover, according to the Office of Inspector General's (OIG) audit team. VA lacked a reliable integrated master schedule consistent with scheduling standards, which increases the risk of missing milestones and delaying the delivery of a system to support timely, quality care to veterans. Schedule delays that extend the program are also likely to result in about \$1.95 billion in annual cost overruns and may undermine VA's other modernization efforts on supply chain and financial management systems. A lot more must be done to rectify these issues.

Freedom of expression, enshrined in article 19 of the Universal Declaration of Human Rights, is essential for empowering individuals and building free and democratic societies. A fundamental right on its own, freedom of expression also provides the conditions for protecting and promoting all other human rights. But its exercise does not happen automatically; it requires a safe environment for dialogue, where all can speak freely and openly, without fear of reprisal.

Today, the twentieth anniversary of World Press Freedom Day is an opportunity to renew our commitment in challenging times. Every day, freedom of expression faces new threats. Because they help ensure transparency and accountability in public affairs, journalists are frequent targets of violence. More than 600 journalists have been killed in the last 10 years, many while reporting in non-conflict situations. A climate of impunity persists — 9 out of 10 cases of killings of journalists go unpunished. Too many media workers also suffer from intimidation, threats and violence. Too many experience arbitrary detention and torture, often without legal recourse.

We must show resolve in the face of such insecurity and injustice. The theme of this year's World Press Freedom Day, "Safe to Speak: Securing Freedom of Expression in All Media", aims to rally international action to protect the safety of every journalist in every country and to break the vicious circle of impunity.

These goals underpin the United Nations Plan of Action on the Safety of Journalists and the Issue of Impunity. The United Nations system is strongly committed to coordinating action, raising awareness and supporting countries in upholding international principles and developing legislation for freedom of expression and information.

Action must encompass both traditional media and the digital world, where news is increasingly produced and consumed. Bloggers, citizen reporters and social media producers, as well as their sources, face increasing threats to their safety. In addition to physical dangers, they are being targeted with psychological and emotional violence through cyberattacks, data breaches, intimidation, undue surveillance and invasions of privacy.

Such assaults not only limit the right to freedom of expression and threaten the safety of online journalists and their sources — they undermine the ability of all people to benefit from a free and open Internet





WHERE CAN YOU FIND THE BEST MEDICAL MANUAL?

The Articles of Confederation

The Articles of Confederation served as the written document that established the functions of the national government of the United States after it declared independence from Great Britain. It established a weak central government that mostly, but not entirely, prevented the individual states from conducting their own foreign diplomacy.

The Albany Plan an earlier, preindependence attempt at joining the colonies into a larger union, had failed in part because the individual colonies were concerned about losing power to another central institution. As the American Revolution gained momentum, however, many political leaders saw the advantages of a centralized government that could coordinate the Revolutionary War. In June of 1775, the New York provincial Congress sent a plan of union to the Continental Congress, which, like the Albany Plan, continued to recognize the authority of the British Crown.

Some Continental Congress delegates had also informally discussed plans for a more permanent union than the Continental Congress, whose status was temporary. Benjamin Franklin had drawn up a plan for "Articles of Confederation and Perpetual Union." While some delegates, such as Thomas Jefferson, supported Franklin's proposal, many others were strongly opposed. Franklin introduced his plan before Congress on July 21, but stated that it should be viewed as a draft for when Congress was interested in reaching a more formal proposal. Congress tabled the plan.

Following the Declaration of Independence, the members of the Continental Congress realized it would be necessary to set up a national government. Congress began to discuss the form this government would take on July 22, disagreeing on a number of issues, including whether representation and voting would be proportional or state-by-state. The disagreements delayed final discussions of confederation until October of 1777. By then, the British capture of Philadelphia had made the issue more urgent. Delegates finally formulated the Articles of Confederation, in which they agreed to state-bystate voting and proportional state tax burdens based on land values, though they left the issue of state claims to western lands unresolved. Congress sent the Articles to the states for ratification at the end of November. Most delegates realized that the Articles were a flawed compromise, but believed that it was better than an absence of formal national government.

On December 16, 1777, Virginia was the first state to ratify. Other states ratified during the early months of 1778. When Congress reconvened in June of 1778, the delegates learned that Maryland, Delaware and New Jersey refused to ratify the Articles. The Articles required unanimous approval from the states. These smaller states wanted other states to relinquish their western land claims before they would ratify the Articles. New Jersey and Delaware eventually agreed to the conditions of the Articles, with New Jersey ratifying on Nov 20, 1778, and Delaware on Feb 1, 1779. This left Maryland as the last remaining

Irked by Maryland's recalcitrance, several other state governments passed resolutions endorsing the formation of a national government without the state of Maryland, but other politicians such as Congressman Thomas Burke of North Carolina persuaded their governments to refrain from doing so, arguing that without unanimous approval of the new Confederation, the new country would remain weak, divided, and open to future foreign intervention and manipulation.

Meanwhile, in 1780, British forces began to conduct raids on Maryland communities in the Chesapeake Bay. Alarmed, the state government wrote to the French minister Anne-César De la Luzerne asking for French naval assistance. Luzerne wrote back, urging the government of Maryland to ratify the Articles of Confederation. Marylanders were given further incentive to ratify when Virginia agreed to relinquish its western land claims, and so the Maryland legislature ratified the Articles of Confederation on March 1, 1781.

The Continental Congress voted on Jan 10, 1781, to establish a Department of Foreign Affairs; on Aug 10 of that year, it elected Robert R. Livingston as Secretary of Foreign Affairs. The Secretary's duties involved corresponding with U.S. representatives abroad and with ministers of foreign powers. The Secretary was also charged with transmitting Congress' instructions to U.S. agents abroad and was authorized to attend sessions of Congress. A further Act of Feb 22, 1782, allowed the Secretary to ask and respond to questions during sessions of the Continental Congress.

The Articles created a sovereign, national government, and, as such, limited the rights of the states to conduct their own diplomacy and foreign policy.

However, this proved difficult to enforce, as the national government could not prevent the state of Georgia from pursuing its own independent policy regarding Spanish Florida, attempting to occupy disputed territories and threatening war if Spanish officials did not work to curb Indian attacks or refrain from harboring escaped slaves. Nor could the Confederation government prevent the landing of convicts that the British Government continued to export to its former colonies. In addition, the Articles did not allow Congress sufficient authority to enforce provisions of the 1783 Treaty of Paris that allowed British creditors to sue debtors for pre-Revolutionary debts, an unpopular clause that many state governments chose to ignore. Consequently, British forces continued to occupy forts in the Great Lakes region. These problems, combined with the Confederation government's ineffectual response to Shays' Rebellion in Massachusetts, convinced national leaders that a more powerful central government was necessary. This led to the Constitutional Convention that formulated the current Constitution of the United States.

Convalescing at home:

But OK, on to the topic at hand. Recently I was reviewing the Code of Procedures for Children and Youth. Being so new to this Committee the majority of it was acceptable but some things pertaining to Temporary Financial Assistance (TFA's) will be changing. Requests for TFA;s have

drastically reduced in the past 2 years. I am just starting to appreciate the reason for this.

I would like to encourage everyone to offer TFA's to Veterans who meet the criteria which is primarily having dependent Children in the home. For questions call me and I can walk you through the process.





The Marine Corps was founded Nov. 10, 1775 when the Continental Congress ordered two battalions of marines to be created to serve during the Revolutionary War.

They further resolved that this force be acquainted with maritime operations in order to serve aboard naval vessels. Thus, the United States Marine Corps has always been an expeditionary naval force ready to defend the nation's interests overseas.

Official Marine statements include: "We are warriors, one and all. Born to defend, built to conquer. The steel we wear is the steel within ourselves, forged by the hot fires of of discipline and training. We are fierce in a way no others can be. We are marines." "In the Marines, everyone, sergeant, mechanic, cannoneer, supply-man, clerk, aviator, and cook, they are all a rifleman first. All speak the language of the rifle and bayonet, of muddy boots and long hot marches. It's never us and them, only us. That is the secret of the Corps."

Death ground: today's American infantry in battle the saying goes, "Every Marine is a rifleman first." This quickly demonstrates the marines' intense focus on warfare. Their well-known slogan, "The Few, The Proud, The Marines," expresses the marine Corps' intense focus on values as well. Warriors with values – this defines the U.S. Marine Corps.

To be a Marine is to always move forward with tenacity towards the next battle standing in the way of our Nation's progress, but Marines also have a long lineage of defining moments to look back on, serving as a source of immeasurable inspiration. One such unit was the Navajo Code Talkers; crucial in securing victory over Japan in WWII. It was our Marine Navajo Code Talkers who provided the unbreakable code necessary to communicate on the battlefield effectively. Another fighting force of the Marine Corps; was the Montford Point Marines, they paved the way for generations to come, more than

20,000 Montford Point Marines made history winning crucial battles for our nation in the Pacific, Korea and Vietnam battlefields.

A cadence steeped in history, it is 10 November of every year that our Nation, our Corps, and our Marines pay tribute to all the Marine Corps Symbolizes. Listen to the marine Corps Birthday Cadence on November 10, and feel the heartbeat of the legacy nearly two and a half centuries long.



Our new 2023-2024 Department Budget started on October 1, 2023. We changed our annual budget from October 1 to September 30 the following year four years ago, from August 1 to July 30, to support our Programs. With the July 30 ending of our budget year, we still had outstanding payments due from our Baseball, Boys State, and Jim Willis Law Enforcement Academy in the following budget year from our Programs being conducted. Officers, District Commanders, and Commission/ Committee Chairs, I have emailed our end-of-budget year actuals and approved 2023-2024 Department Budget numbers to each of you. Please review your assigned budgets before submitting expense reports or changes for your programs or functions. I have started auditing all our accounts and have started our annual Tax reporting for this past Budget Year. All voting Department Executive Committee Members will receive copies of our Department 990 Form and schedules and supporting data before being submitted to the IRS. I will keep repeating this as it appeared in the September and October issue of the Legionnaire and requires reinforcement: Let's talk about our budget requests, specifically income versus expense, and discuss budgets in general. There seems to be some confusion with some of our members who use the Department budget for their Legion activities. The approved Department Budget is adopted at each Department Convention for the new Membership Year by our Convention delegates. Considerable work goes into the Department Budget, initial budget requests by the officers, programs, and activities of the Department, which is a


business. An initial Budget meeting with preparation, reviewing budget requests, and understanding income that will be available to support the new budget, which includes membership, which is our market, like any other business. The "market does dictate in any business." Uniquely, in our business, we do have pass-through self -supporting programs, and some of those programs also have grants and other revenue streams. Those programs are co-mingled in our Department Budget as they are programs/parts of our Department. Income versus expense: our expenses cannot exceed our income. As we do each year, the Finance Commission will be asking all officers, chairs of commissions and committees, and administration to submit their budget requirements, which will occur in the next few months. Keep in mind as you meet with your team, plan your activity for our next membership year, and complete your budget request that if you have income, your expenses do not exceed your income. We have many years of actuals, income, and expenses, so we can provide you with this information. Far too many times, a program will list that their income is going to be \$50, \$70,000, and their actual income is \$9 10,000, and their expenses are \$15, \$20,000. Remember, this is a business, and this is our business. One issue that we experienced this year was that a commission thought that the income number they submitted, which was adopted at the Convention, could be spent even though they did not receive their projected income. NO. There is nothing wrong with planning for a larger program/event that is acceptable, encouraged, and supported. If it



does not materialize, we must stay within our "actual" income line. We have a lot of excellent programs; we are the only VSO that has all these excellent programs. I would encourage officers, chairs of the Commission, and committee members to attend District and post meetings throughout our Department, provide information on their programs, and become cheerleaders in all the great programs and activities that we do. And while out there, get commitments and, I am sure, a lot of interest in our

programs and activities. There are a lot of grants in Oregon, and each chair should be applying for them for their program; we have a 501c3 that the grants can be held for your program. And remember, we are a member organization. Membership is our market, and the market dictates. Remember, we are here to help and answer questions. There are no dumb questions.

Looking Beyond

I would like to stay positive about our department and find the indicators that we are getting our act together and starting to move forward making progress for each successive year. However, after reviewing the records at Department Headquarters, it appears we are still in a malaise and treading water. I speak of the diminishing efforts to make progress in working the programs of The American Legion in our Department.

The Department Constitution and By-Laws describes in a framework how we are structurally supposed to operate. It details in the Constitution By-Laws, Article II, Section 3 and Section 6 that all the officers are to be installed and committees appointed no later than September 20th of each year. Yet, as of October 3rd the records on file indicate the following:

As you will note, last year was anything but a stellar year with only about two-thirds of the posts having submitted their Confidential and Installation records, and only 40% of the Posts submitting Committee records.

WELL, this year it is even worse with only 50% filing. Confidential and Installation records, and only 23% filing Committees records. And it would be nice if our Districts were on top of the process, but you can see that their record (pardon the pun) is dismal also; with only 4 of 10 Districts having confidential records on file, and only 2 listing their Committees.

Why is this important? In accordance with our Constitution By-Laws Article I, Section 4, each District shall have a District Chairman for each Commission and/or Committee having a program at the Post level with the duty of promoting and coordinating their respective programs among the Post in the District. So, if we are approximately one-quarter of the way into the membership year, and we still do not have officers installed and committees appointed, we may presumably be behind in accomplishing the goals and objectives of accomplishing our programs.

This is by no means an enviable situation to be in! If we are to conduct our programs and do the work of The American Legion in our communities in an organized and productive manner, we must be organized. That means finding people to lead, setting a vision and goals to accomplish that vision and leading and administrating that process to produce a quality product throughout our Department, Districts, and Posts. All is not lost. We still have three-quarters of our year ahead of us, so Looking Beyond we must get our act together and work out programs in an orderly manner. Each of our Department Commissions and Committees should have met by now, and they should be sharing their vision and insights throughout our department to make steady progress on promoting and administrating our programs. IF they have the names of the people in leadership positions as reflected on the Confidential Reports and the Committee Reports they can then connect with those people to help Department, Districts, and Posts to move forward in making our programs progressively more effective throughout this year and beyond. By working to make incremental improvement each year we can make our department a standout in accomplishing the programs throughout our state.

"A Different View of Veterans Day"

As Veterans Day approaches, I wish to share an experience I had a little over a year ago. Ken Buckles and I had been invited to attend a meeting of the local Rotary Club to share about upcoming the two events. "Remembering America's Heroes" that was going to be held in the Hermiston High School gym and the "Wall of Honor" that was going to be on display at the Hermiston Community Center.

After the meeting, Ken chatted with the Rotary members while I was off to one side, giving my best "beef raffle" sales pitch to other members, hoping to score a few sales that were needed to support our non-profit organization.

A young man patiently waited until I had a free moment, then approached me, followed by him introducing himself. I noticed an accent in his speech, and I couldn't quite figure out where he might've come from, so I asked. He responded, "South Africa." I immediately had common ground on which to pursue this conversation because my wife and I have been to South Africa numerous times while on our way to either Botswana or Namibia, where we worked assisting missionaries in their endeavor. Jo'burg is the southernmost airport hub on the continent of Africa. More than likely, I offered him the opportunity to purchase a raffle ticket, and there is the possibility that he purchased one, but at the moment, my

memory fails me. Following a brief introductory conversation, he moved on with his intentions. My new friend quickly informed me that his father had served in the South African Army. I must admit that I interrupted his delivery because I had visited the largest sand dune in the world, which is near Walvis Bay along the Atlantic coast in Namibia, where South African troops completed their training by carrying a full load of battle gear while slogging through bottomless sand. That took place in days gone by. He pressed on with his message. The following conversation is paraphrased. "In America, the people honor their veterans with special holidays. In South Africa, nothing is mentioned about them. In fact, there is nothing to honor veterans because of the politics associated with the history of apartheid." Whether you know it or not, at one time, South Africa had a well-trained military complete with modern weaponry. South Africa supported the U.S. during the Korean War.

As our conversation progressed, I soon learned that veterans really didn't communicate with each other except for the ones who knew each other. He went on to explain that the structure here in America is very different from highways and buildings named after a veteran or war, and there are other memorials dedicated to those who served with distinction. It is so easy here for veterans to

communicate and come together despite the inter-service rivalries. When our visit came to a close, I invited him to visit our monthly meeting to share these insights with my fellow Legionnaires. He did, and we thoroughly enjoyed his presentation.






"The American Legion Riders will assist in that effort....stick with us and help us make this transition a successful one."

Military Times | <u>Lawmakers demand accountability</u> <u>after VA loses track of vets' claims</u>

House Republicans on Tuesday called for employee discipline and potential firings after the discovery that tens of thousands of veterans' disability cases were lost for months or years in the Department of Veterans Affairs claims systems due to software glitches.

"VA.gov has gaps, and veterans are falling into them," said Rep. Matt Rosendale, R-Mont., who chairs the House Veterans' Affairs subcommittee on technology, during a hearing Tuesday. "This is a situation where the VA is badly in need of independent oversight."

In August, VA leaders announced they had found roughly 32,000 veterans' disability claims delayed — some dating back years — due to technical flaws in the department's VA.gov filing systems. Two weeks later, officials acknowledged 57,000 more similarly delayed cases involving veterans trying to add dependents to their accounts.

In all of the cases, VA officials pledged to backdate veterans' pay as soon as possible. But the mistakes may have delayed potentially thousands of dollars in monthly payouts to individuals suffering from military-related illnesses or injuries.

Veterans Affairs Chief Information Officer Kurt DelBene noted that the errors represent a small fraction of the more than seven million cases filed since early 2018, but he also acknowledged that any mistake that causes financial harm to veterans is unacceptable.

"VA will resolve these issues, prevent them from happening again, and address them more quickly when needed," he told lawmakers. "And most importantly, we'll make sure that all impacted veterans get the benefits and services that they deserve as quickly as possible."

But several lawmakers said those promises aren't enough.

"I think we have a problem with addressing the major issues in leadership and officials not being held accountable for things that they do or do not do in upholding their responsibilities to veterans," said Rep. Morgan Luttrell, R-Texas. "My concern is that no one is holding [anyone] responsible for this."

DelBene said leadership is pressing for fixes and improvements to the system, but not with the threat of mass firings. Officials from the department said that work will include better oversight systems to ensure that similar problems in the future are quickly caught, preventing problems from compounding over months or years.

Earlier this month, in a letter to VA leadership, committee Chairman Mike Bost, R-Ill., lamented the problems as "just the latest in a string of electronic filing issues that continue to plague the department."


Such problems include ongoing issues with the department's 10-year, \$16-billion effort to overhaul its electronic health records system, which has been delayed by technical issues for months.

VA officials at Tuesday's hearings promised regular updates to the committee on their proposed fixes in the coming weeks. Rosendale said he expects to hold more hearings on the issue in the months ahead.



SCOUTING

So, when I was thinking about what to

write about this month, I got to thinking that a lot of you, even those in scouting, don't have a statewide picture of scouting in Oregon. So, I'm starting a series on the "Big Picture" of Oregon Scouting.

This month, I'll start with an overview. Below is a map of Oregon and the five councils, in the red lines, that make up Oregon, some of Washington, some of California, and a lot of Idaho. I don't know who drew the council boundaries, but I'm convinced they slept through geography class. But, like they say, "it is what it is". As I mentioned, like the Legion, which is broken up into ten districts, scouting in Oregon is broken up into five councils. Each Council has an office with officers and staff who run the activities within their Council. On the scout uniform is a shoulder patch identifying which Council a scout is from. So, if you can't read the fine print, in the NW corner is Cascade Pacific Council, headquartered in Portland. Down the coast is the Oregon Trail Council, headquartered in Eugene. Along the southern border is Crater Lake Council, headquartered in Central Point, near Medford. Traveling east is the Mountain West Council, headquartered in Boise, Idaho. Lastly, the Blue Mountain Council is in the middle of the map, headquartered in Kennewick, Washington.

Because I have spent most of my scouting life in the Cascade Pacific Council (upper left), we'll discuss that Council first next month.
