Convention Registration Form Instructions

<u>Delegates</u>: Posts must pay according to your Post membership numbers. Please refer to page 4 for the correct number of Delegates. If your Post is not attending, you are still required to pay \$20 for each delegate. For Example, if your Post has: 151-250 members. The Post delegate strength is 4 Delegates. (\$20 x 4= \$80 in total is owed to the Department.)

<u>Alternates</u>: If you have more members who wish to attend than Delegates allowed, you may choose as many Alternates as you are allowed Delegates at \$20 each.

For Example, if your Post has: 151-250 paid members- your Post's delegate strength is 4 Delegates and 4 Alternates. Total amount due to Department for 4 Delegates and 4 Alternates is \$160 (\$20 x8 = \$160)

<u>Delegates-At-Large</u>: If you have Delegates-At-Large in your Post, they are listed for you on page 4. **You DO** have to pay for these members delegate fee whether they do/ do not attend the Convention. Delegate-at-large fee is \$20 ea.

<u>Guests</u>: The Post may have as many guests as wanted. Guest registration fee is \$7.50 each in addition to all other Delegate, Alternate and/ or Delegate-at-large fees.

When filling out your Certification and Registration Form, please leave the name field blank if you **DO NOT** have Delegates attending the Convention from your Post. **You are still required to send in your Certification** and Registration Form along with your check fee for each Delegate to Department no later than <u>May 1</u>, <u>2024</u>. Please <u>DO NOT</u> list names if not attending.

No Certification and Registration Form and fees will not be accepted at the Convention. Forms and fees must be provided to the Department no later than May 1, 2024.

Your Delegates will pick up their name badges and packets at the Convention registration table.
